## **Introduction**

1. Saint Vincent and the Grenadines is pleased to present its responses to the 156 recommendations received on the occasion of its Third cycle Universal Periodic Review, following the interactive dialogue at the 39<sup>th</sup> Session of the Working Group for the UPR on November 3, 2021. The Government of Saint Vincent and the Grenadines consulted various stakeholders, including members of civil society and public institutions, on the recommendations and has considered their views in determining the State's positions.
2. Saint Vincent and the Grenadines is further pleased to advise that of the 156 recommendations received, eighty-one (81) receive the support of the Government of Saint Vincent and the Grenadines, while seventy-five (75) are noted.
