Addendum

Views on conclusions and/or recommendations, voluntary commitments and replies presented by the State under review



1. The Republic of the Sudan is honoured to present its position on the recommendations issued by States during the universal periodic review, following examination of its report during the third cycle in 2022, in accordance with the general principles of the Human Rights Council and the guiding principles of the universal periodic review. The Sudan has consistently upheld all its commitments under international law and has made progress in strengthening and protecting those commitments. It cooperates with international mechanisms and strives to continue protecting and enhancing human rights at national and international level.

2. The Sudan has given serious consideration to the recommendations presented via the universal periodic review mechanism following the examination of its report. The Sudan has developed its response to those recommendations through a consultative and participatory approach, in line with United Nations guidance on ensuring the participation of all relevant stakeholders from the executive, legislative and judicial authorities, relevant agencies, civil society organizations and national human rights institutes so that a decision can be taken on the basis of their views.

3. The Sudan notes that several recommendations have been made that it has already accepted and implemented effectively, or is in the process of implementing, including – but not limited to – the recommendation to ratify the Convention against Torture and the International Convention for the Protection of All Persons from Enforced Disappearance (both of which the Sudan ratified in 2021), the recommendation to strengthen cooperation with the International Criminal Court and the recommendation to establish a commission for legal reform.
