## Curricula vitae\*

### Ahmed Al Kabir (Bangladesh)

Dr. Ahmed Al Kabir has over thirty-five years of work as a Program Development, Evaluation, and Management Specialist with specialization in health, nutrition, education and environmental development working with government, private and non-government agencies. At present, he is the Chairperson of the International Medical College and Hospital located in Tongi, Bangladesh.

From 2009 to 2014, Dr. Kabir served as the Chairperson of the Governing Board of the state owned Rupali Bank Ltd. During his tenure as the Chairperson, he has made significant improvements in all aspects of one of the largest state-owned Bank of Bangladesh, its management and functioning, which is now considered as a success story in Bangladesh.

Dr. Kabir led and worked as consultant in various projects and programmes implemented in Bangladesh by JHU Bloomberg School of Public Health, USA; University of Aberdeen; JHPIEGO (ACCESS-FP); Delegation of European Commission; GIZ, Germany; IPPF, India; RDP Medi Vision International, Netherlands and Asian Development Bank (ADB); and Swisscontact – Katalyst during October 2005 till end of 2008. Dr. Kabir has also worked as the Asia Regional Program Advisor of Averting Maternal Deaths and Disabilities (AMDD) Program of the Columbia University, USA from 2002 to 2005. From April 2000 to August 2002, he served as the Chief of Party (COP) of the largest Urban Health program of the world and led a large team of professionals involved in providing reproductive health, child health, communicable diseases (including TB, HIV/AIDS and Malaria), and limited curative care.

From July 1997 to March 2000, he was the Deputy Chief of Party with USAID/John Snow Inc. (JSI) Urban Family Health Partnership (UFHP) Program in Bangladesh. From 1983 to June 1997, he was the Programme Advisor with AVSC International (currently Engender Health, USA) Programme in Asia. During this period, he participated in health sector related programs including on TB and HIV/AIDS.

Dr. Kabir, started his career as a Research Officer in 1976 to 1978, when he served in the Planning Cell of the Ministry of Health and Family Welfare of Bangladesh. From 1979 to 1980, Dr Kabir worked with UNFPA as a Programme Officer in Bangladesh.

Dr. Kabir has participated extensively in international business development, capacity building, policy advocacy, NGO and private sector program management and several assessment/review teams in the evaluation of different components of development activities of various organization in South and South East Asian region including Bangladesh, Afghanistan, Nepal, Bhutan, Vietnam, Pakistan, Sri-Lanka, India, Philippines, Thailand, and Indonesia.

Dr. Kabir has served in many committees and working groups of national and international organizations. He has served for three consecutive terms as a member of the Advocacy Advisory Committee (AAC) of Stop TB partnership of WHO. He has also served in the UNION (of WHO) as a working group member of Capacity Building and Training.

In September 2002, Dr. Kabir established a regional (Asia) technical resource centre in Dhaka namely *Research, Training and Management (RTM) International* to provide technical assistance and support to the development of health, education and environment sectors. The organization is now one of the leading technical resource organizations of Bangladesh. Since the establishment of the RTM International, Dr. Kabir and his team has worked as a consultant to UNFPA, UNICEF, UNHCR, IOM, European Commission, GIZ, DFID, Columbia University (USA), JHPIGO, Swisscontact Katalyst and USAID. While working with these organizations, he developed project documents and managed execution and implementation of project activities relating to training, service delivery, communication and marketing.

Dr. Kabir has rich and diverse knowledge and expertise in working with the regional, international and United Nations organization.

Dr. Kabir also has extensive experience in working with community-based organization. In 1979, Dr. Kabir founded an NGO (SHIMANTIK) in Bangladesh to serve the poor and under-privileged people of Bangladesh, which is a nationally known leading development organization in Bangladesh.

Dr. Kabir holds a PhD in Economics (Population and Development), an MSc in Medical Demography (from the London School of Hygiene and Tropical Medicine, UK), and a Post-Graduate Diploma in Population Growth Studies (from the University of Wales, UK) and a Master's degrees in Economics (from the Chittagong University of Bangladesh).

### Philip Richard Okanda Owade (Kenya)

#### Summary profile

Ambassador Owade is a highly motivated individual with impeccable analytical, diplomatic and leadership skills. He served in the public service with distinction, brilliance and integrity rising from Legal Officer to Ambassador to the United Nations office in Geneva before returning home to serve as Secretary, Local Government Administration 2010–2013 and as Secretary, Devolution in the Ministry of Devolution and Planning 2013–2016. He was instrumental in drafting the five pieces of legislation that operationalized chapter 11 of the Constitution on Devolved System of Government including the Urban Areas and cities Act, The Intergovernmental Relations Act, The County Government Act and the Transition to Devolved Government Act, 2012. He was instrumental in developing and rolling out capacity building and civic education programmes for County Governments.

As a member of the Transition Authority from its inception in 2011 to its winding up in 2016, he played a key role in setting up structures and mechanisms for rolling out the devolved system of government.

He has amassed considerable expertise in the areas of public policy, international law governance, local authorities' administration and devolution.

From August 2018 to date, as County Attorney of Siaya, he has successfully established the Office of County Attorney with capacity to provide legal advisory services to both arms of Government, draft and develop several pieces of legislation and policy and to represent the government in courts of law.

From October 2010 to June 2016 he served as a member of the Kenya Rural Roads Authority responsible for overseeing the opening up of rural Kenya. As a Board Member he was instrumental in launching and overseeing the Roads 2000 project. Was a key player in drafting KERRA's strategic plans, detailing the Country's road programmes and projects.

Upon retirement from public service in June 2016, Amb. Owade established a legal consultancy firm as a lead consultant and sole practitioner in the law firm, P.R.O Owade & Co Advocates and Commissioners for Oaths.

Apart from legal practice, Ambassador Owade is a consultant on issues pertaining to governance, devolution, capacity building and public policy formulation and implementation.

Ambassador Owade is a member of the United Nations Joint Staff Pension Board since January, 1996 and is currently its Chairman. This is a fully funded pension system with diverse investments in equity, stocks, bonds and real estate around the world to the tune of 65 billion dollars. In the capacity as member of the Board and its current chairman he travels to New York, Geneva and other United Nations centers around the world from time to time.

In recognition of his distinguished and exemplary service H.E. the President bestowed on him the Head of State commendation of the Elder of the Order of the Burning Spear (E.B.S.), in December 2016, just after separation from service.
