Procedural report of the second session of the Working Group on the Strengthening of the Convention¹


I. Opening of the second session of the Working Group

- 1. In accordance with the decisions of the Ninth Review Conference, the second session of the Working Group was convened at the Palais des Nations in Geneva from 7 to 18 August 2023. The Working Group held 20 meetings during that period under the Chairpersonship of Ambassador Flavio Soares Damico, Special Representative of Brazil to the Conference on Disarmament. Ambassador Camille Petit, Permanent Representative of France to the Conference on Disarmament, and Mr. Irakli Jgenti, Deputy Permanent Representative of Georgia to the United Nations Office in Geneva, served as its Vice-Chairpersons.
- 2. The Under Secretary-General and High Representative for Disarmament Affairs, Ms. Izumi Nakamitsu, addressed the Working Group via a video message.
- 3. Mr. Daniel Feakes, Chief, Implementation Support Unit, Office for Disarmament Affairs, Geneva, served as Secretary of the Meeting. Mr. Hermann Lampalzer, Political Affairs Officer, Implementation Support Unit, served as Deputy Secretary.

II. Participation at the second session of the Working Group

4. - 5. In addition, two States that had signed the Convention but had not yet ratified it participated in the second session of the Working Group without taking part in the making of decisions, as provided for in rule 44, paragraph 1 of the rules of procedure: Arab Republic of Egypt; Syrian Arab Republic.
- 6. Two States, Djibouti and Israel, neither parties nor signatories to the Convention, participated in the second session of the Working Group as observers, in accordance with rule 44, paragraph 2.
- 7. The United Nations Conference on Trade and Development, the United Nations Institute for Disarmament Research, the United Nations Office for Disarmament Affairs and the Group of Experts supporting the Committee established pursuant to Security Council resolution 1540 attended the second session of the Working Group in accordance with rule 44, paragraph 3.
- 8. The Arms Trade Treaty Secretariat, the European Union, the International Atomic Energy Agency, the International Centre for Genetic Engineering and Biotechnology, the International Criminal Police Organization, the Organization for the Prohibition of Chemical Weapons, The World Academy of Sciences, the World Health Organization and the World Organization for Animal Health were granted observer status to participate in the second session of the Working Group in accordance with rule 44, paragraph 4.
- 9. In addition, at the invitation of the Chairperson, in recognition of the special nature of the issues under consideration at this session and without creating a precedent, experts from international organizations and non-governmental organizations participated as guests in panel sessions organized by the Chairperson as reflected in paragraphs, 14, 16 and 18.
- 10. Twenty-one non-governmental organizations and research institutes attended the second session of the Working Group under rule 44, paragraph 5.
- 11. A list of all participants in the second session of the Working Group is contained in documents BWC/WG/2/INF.1 and Rev.1.

III. Identifying, examining and developing specific and effective measures, including possible legally-binding measures, and making recommendations to strengthen and institutionalize the Convention in all its aspects within the mandate of the Working Group

- 12. In accordance with the indicative schedule of activities as adopted at its first session (see Annex II of BWC/WG/1/2), the Working Group commenced its consideration of agenda item 6 on "Identifying, examining and developing specific and effective measures, including possible legally-binding measures, and making recommendations to strengthen and institutionalize the Convention in all its aspects within the mandate of the Working Group".
- 13. At its first meeting, on 7 August 2023, the Chairperson announced that he had decided to appoint Friends of the Chair to assist him in his consultations and negotiations on particular issues as follows:

The Working Group held two meetings on 16 August 2023 devoted to the issue of "a mechanism to review and assess scientific and technological developments relevant to the Convention and to provide States Parties with relevant advice". The following States Parties introduced working papers on this issue: United Kingdom of Great Britain and Northern Ireland (BWC/WG/2/WP.9), Russian Federation (BWC/WG/2/WP.16), Iran (Islamic Republic of) (BWC/WG/2/WP.19) and Panama (BWC/WG/2/WP.23). There then followed an interactive discussion in which the following States Parties participated: Australia, Austria, Belgium, France, Iran (Islamic Republic of), Kazakhstan, Panama, Portugal, Russian Federation, United Kingdom of Great Britain and Northern Ireland, United States of America, Venezuela (Bolivarian Republic of).
- The Working Group held four meetings from 17 to 18 August 2023 devoted to the issue of "Measures on national implementation of the Convention". The following States Parties introduced working papers on this issue: United Kingdom of Great Britain and Northern Ireland (BWC/WG/2/WP.10), Russian Federation (BWC/WG/2/WP.17 and BWC/WG/2/WP.25), United States of America (BWC/WG/2/WP.20) and Kenya and Panama (BWC/WG/2/WP.24) and Ukraine (BWC/WG/2/WP.26). In a panel session on this issue moderated by the Chairperson, statements on national implementation efforts in their countries were made by Mr. Song Yajun (China), Ms. Somsanouk Keobounsan (Lao People's Democratic Republic), Ms. Melanie Reddiar (South Africa) and Mr. Peter Ahabwe Babigumira (Uganda). In a panel session on this issue organized by the Chairperson, technical briefings were provided by Ms. Irina Albrecht representing the Group of Experts in support of the Committee established pursuant to Security Council resolution 1540 and Dr. Jun Xing representing the World Health Organization. There was also a brief overview of its activities presented by the Implementation Support Unit. There then followed an interactive discussion in which the following States Parties participated: Algeria, Argentina, Austria, Azerbaijan (on behalf of the Group of the Non-Aligned Movement and other States Parties to the BWC), China, Colombia, France, Georgia, Germany, India, Iran (Islamic Republic of), Japan, Kenya, Malaysia, Maldives, Mexico, Netherlands (Kingdom of the), Norway, Pakistan, Panama, Peru, Philippines, Russian Federation, Samoa, Saudi Arabia, Singapore, South Africa, Sri Lanka, Switzerland, Ukraine, United States, Uruguay. The European Union also made a statement.
- 19. Following a preliminary exchange of views and to facilitate further discussions, the respective Friends of the Chair circulated the informal papers listed in Annex I (BWC/WG/2/CRP.2 and BWC/WG/2/CRP.5). The preparation and submission of those papers

is without prejudice to the positions of delegations on the issues under consideration in the Working Group and does not imply agreement on the scope or content of the papers.
