Extensions of country programmes Note of the Administrator

Summary

The present note contains information on the extensions of the country programmes for Malawi, Libya, Somalia and Sudan. Requests for first one-year extensions of country programmes are approved by the Administrator and presented to the Executive Board for information. Requests for second one-year extensions, two-year extensions and exceptional third year extensions of country programmes are submitted to the Executive Board for approval.

Elements of a decision

The Executive Board may wish to take note of the first one-year extension of the country programme for Sudan from 1 January to 31 December 2017.

The Executive Board may wish to approve the second one-year extension of the country programme for Somalia from 1 January to 31 December 2017, the two-year extension of the country programme for Malawi from 1 January 2017 to 31 December 2018, and the exceptional third year extension of the country programme for Libya from 1 January to 31 December 2017.
