Extensions of country programmes Note of the Administrator

Summary

The present note contains information on the extensions of the country programmes for Bahrain, Burkina Faso, Cameroon, El Salvador, Guinea-Bissau, Libya, Mauritius and Seychelles. Requests for first one-year extensions of country programmes are approved by the Administrator and presented to the Executive Board for information. Requests for second one-year extensions, two-year, three-year and exceptional extensions of country programmes are submitted to the Board for approval.

Elements of a decision

The Executive Board may wish to: (a) take note of the first one-year extensions of the country programmes for Bahrain, Cameroon, El Salvador, Guinea-Bissau and Libya from 1 January to 31 December 2021; (b) approve the two-year extension of the country programme for Burkina Faso from 1 January 2021 to 31 December 2022 and the three-year extensions of the country programmes for Mauritius and Seychelles from 1 January 2021 to 31 December 2023.
