When several resolutions were adopted under the same number, each of them was identified by a capital letter (for example: resolution 1926 B (LVIII), resolutions 1954 A to D (LIX)). The last resolution so numbered is resolution 2130 (LXIII), of 14 December 1977.

Since 1978, as part of the new system adopted for symbols of Council documents, the resolutions are numbered on a yearly basis and are identified by two arabic numerals separated by an oblique stroke, the first numeral indicating the year, the second the number of the resolution in the annual series (for example: resolution 1978/36).

Decisions

Until 1973 (up to and including the resumed fiftyfifth session), the decisions of the Council were not numbered. From 1974 to 1977 (up to and including the resumed sixty-third session), the decisions were numbered consecutively and were identified by an arabic numeral followed by an indication of the session in parentheses (for example: decision 64 (ORG-75), decision 78 (LVIII), adopted at the organizational session for 1975 and the fifty-eighth session, respectively). The last decision so numbered is decision 293 (LXIII), of 2 December 1977.

Since 1978, as part of the new system adopted for symbols of Council documents, the decisions are numbered on a yearly basis and are identified by two arabic numerals separated by an oblique stroke, the first numeral indicating the year, the second the number of the decision in the annual series (for example: decision 1978/41).

In 1982, the resolutions and decisions adopted by the Council are published in three supplements to the Official Records of the Economic and Social Council, 1982, as follows:

RESOLUTIONS

FIRST REGULAR SESSION OF 1982

1982/1. Situation of refugees in the Sudan

The Economic and Social Council,

Recalling its resolution 1981/5 of 4 May 1981 on the situation of refugees in the Sudan,

Recalling further General Assembly resolutions 35/181 of 15 December 1980 and 36/158 of 16 December 1981

Having considered the report of the Secretary-General, to which was annexed the report of the United Nations interagency mission on education and social development/welfare services for refugees in the Sudan,

Having heard the statement delivered by the United Nations Deputy High Commissioner for Refugees before the Council on 22 April 1982,²

Recognizing the heavy burden placed on the Government of the Sudan in caring for the refugees and the need for adequate international assistance to continue its efforts to render services to the refugees,

Appreciating the measures which the Government of the Sudan, a least developed country, is taking in order to provide shelter, food and other services to the growing number of refugees in the Sudan,

- 1. Endorses the report of the United Nations interagency technical follow-up mission to the Sudan³ and the recommendations contained therein;
- 2. Expresses its appreciation to the Secretary-General, the United Nations High Commissioner for Refugees, donor countries and voluntary agencies for their efforts to assist the refugees in the Sudan;
- 3. Requests the Secretary-General, in close cooperation with the United Nations High Commissioner for Refugees and the relevant specialized agencies, to make available the necessary human, technical and financial resources to the Government of the Sudan so that the recommendations of various interagency missions can be implemented immediately;
- 4. Appeals urgently to Member States, the United Nations High Commissioner for Refugees, the United Nations organizations concerned and voluntary agencies to provide the Government of the Sudan with the resources necessary for the prompt implementation of the development assistance projects envisaged in the annex to the report of the Secretary-General;
- 5. Requests the Secretary-General, in co-operation with the United Nations High Commissioner for Refugees, to submit a comprehensive report to the General Assembly at its thirty-seventh session on the progress made in the implementation of the recommendations

of the interagency technical follow-up mission as well as on the implementation of the present resolution.

17th plenary meeting 27 April 1982

1982/2. Assistance to displaced persons in Ethiopia

The Economic and Social Council,

Recalling its resolution 1980/54 of 24 July 1980 and General Assembly resolution 36/161 of 16 December 1981.

Having heard the statements of the representative of the Secretary-General and of the United Nations Deputy High Commissioner for Refugees,⁴

Taking into account the report of the Secretary-General on assistance to displaced persons in Ethiopia, prepared pursuant to Council resolution 1980/8 of 28 April 1980,5

Recalling the appeal of the Secretary-General in his note verbale of 11 November 1980,

Recognizing the growing number of voluntary returnees in Ethiopia,

Deeply concerned that the appeals of the Secretary-General, the General Assembly and the Council have yet to give rise to an adequate response,

- 1. Endorses once again the appeals of the Secretary-General and the General Assembly;
- 2. Appeals once again to the Governments of Member States and to intergovernmental and non-governmental organizations and all voluntary agencies to contribute generously to the Government of Ethiopia in its effort to provide relief and rehabilitation to the displaced persons and voluntary returnees;
- 3. Commends the effort made by various organs and specialized agencies of the United Nations in mobilizing assistance to displaced persons and voluntary returnees in Ethiopia;
- 4. Requests the United Nations High Commissioner for Refugees to intensify his efforts in mobilizing humanitarian assistance for the relief, rehabilitation and resettlement of voluntary returnees, in view of their increasing number;
 - 5. Decides to keep the matter under review.

17th plenary meeting 27 April 1982

1982/3. Humanitarian assistance to refugees in Djibouti

The Economic and Social Council,

Recalling its resolutions 1980/11 of 28 April 1980, 1980/44 of 23 July 1980 and 1981/4 of 4 May 1981,

Recalling also General Assembly resolutions 35/182 of 15 December 1980 and 36/156 of 16 December 1981,

Having heard the oral report of the representative of the Secretary-General on the refugee situation in Djibouti.⁶

Having heard also the statement of the delegation of Djibouti on the refugee situation in that country,⁷

Appreciating the determined efforts of the Government of Djibouti to cope with the refugee situation, despite its limited economic resources,

Aware of the social and economic burden placed on the Government and people of Djibouti as a result of the influx of refugees and of its impact on the development and infrastructure of the country,

Deeply concerned about the persistence of the food shortage in the country, which has been aggravated by the devastating effects of the prolonged drought,

Noting with satisfaction the concern and continued efforts of the United Nations High Commissioner for Refugees, the United Nations Development Programme, the United Nations Children's Fund, the World Health Organization, the World Food Programme, the Food and Agriculture Organization of the United Nations, other intergovernmental organizations, as well as the non-governmental and voluntary agencies which have worked closely with the Government of Djibouti in the implementation of the relief and rehabilitation programme for the refugees in Djibouti,

- 1. Takes note with appreciation of the oral report of the representative of the Secretary-General on the refugee situation in Djibouti;
- 2. Appreciates the efforts made by the United Nations High Commissioner for Refugees to keep the refugee situation in Djibouti under constant review;
- 3. Requests the United Nations High Commissioner for Refugees to intensify his programme of humanitarian assistance to the refugees in Djibouti;
- 4. Requests all Member States, the specialized agencies and other organizations of the United Nations system, and other intergovernmental and non-governmental organizations, to continue to support the efforts made by the Government of Djibouti to meet the needs of the refugees and the other victims of the drought;
- 5. Requests the United Nations High Commissioner for Refugees to continue to ensure that adequate assistance programmes are organized for the refugees in Djibouti and to maintain close contact with Member States and intergovernmental and nongovernmental organizations and voluntary agencies concerned to mobilize the necessary assistance to the Government of Djibouti so as to enable it to cope effectively with the refugee situation, which has been further aggravated by the debilitating effects of the drought;
- 6. Requests the Secretary-General, in co-operation with the United Nations High Commissioner for Refugees, to evaluate the needs and the scope of the assistance necessary to finance the relief and rehabilitation programmes for the refugees and to report to the

General Assembly, at its thirty-seventh session, on the progress achieved in the implementation of the present resolution:

7. Decides to keep the question under review.

1982/4. Assistance to refugees in Somalia

The Economic and Social Council,

Recalling its resolution 1981/31 of 6 May 1981 and General Assembly resolution 36/153 of 16 December 1981, on the question of assistance to refugees in Somalia,

Taking into account the report of the Secretary-General, to which was annexed the report of the review mission to Somalia on the situation of the refugees in Somalia, containing an assessment of their over-all needs as well as the amount and type of assistance required to strengthen support services and facilities.

Aware of the consequences of the social and economic burden placed on the Government and people of Somalia as a result of the influx of refugees and the subsequent impact on the national development and the infrastructure of the country,

- 1. *Takes note* of the report of the Secretary-General;
- 2. Expresses its appreciation to the Secretary-General and to the United Nations High Commissioner for Refugees for their continued efforts to mobilize international assistance on behalf of the refugees in Somalia;
- 3. Notes with satisfaction the assistance rendered to the refugees in Somalia by various Member States, the United Nations High Commissioner for Refugees, the World Food Programme, the United Nations Children's Fund and other intergovernmental organizations concerned:
- 4. Also notes with satisfaction the valuable services and assistance being contributed to the refugee programme in Somalia by various voluntary agencies and non-governmental organizations;
- 5. Appeals to Member States, international organizations and voluntary agencies to render all possible material, financial and technical assistance to the Government of Somalia to enable it to meet the needs of the refugees, including those aspects relating to their education, self-help activities and community development and to the strengthening of support services and facilities;
- 6. Requests the Secretary-General, in co-operation with the United Nations High Commissioner for Refugees, to report to the Economic and Social Council, at its second regular session of 1982, on the refugee situation in Somalia and on the progress made in implementing the recommendations contained in the report of the review mission;
- 7. Further requests the Secretary-General, in cooperation with the United Nations High Commissioner for Refugees, to submit a report to the General As-

1982/5. Measures to be taken following the cyclones and floods in Madagascar

The Economic and Social Council,

Considering that Madagascar has recently suffered the effects of several tropical cyclones and floods which have caused loss of life and considerable damage to the economy of the country,

Having heard the statement of the delegation of Madagascar on the cyclones which affect the countries situated in the south-western part of the Indian Ocean, and the statement of the representative of the Office of the United Nations Disaster Relief Coordinator,

Recognizing that climatic hazards create in countries subject to seasonal disasters emergency situations having medium-term and long-term economic, social and structural consequences which affect development,

Recalling the resolutions of the General Assembly and its own resolutions on assistance in cases of natural disasters, in which appeals have been made to the international community to give special attention to these phenomena,

Taking into account the fact that the provision of assistance to countries stricken by natural disasters is an expression of the international solidarity proclaimed in the Charter of the United Nations.

Noting with satisfaction the emergency assistance provided by a number of States, specialized agencies and other international and regional organizations, and by voluntary agencies,

Noting also the efforts made by the Government of Madagascar to relieve the suffering of the victims of the cyclones and floods,

- 1. Expresses its profound sympathy with the people and Government of Madagascar for the loss of life and the serious damage which the recent cyclones and floods have caused to the economy of the country;
- 2. Urges all States to participate or to continue to participate in relief operations and in the implementation of programmes for the rehabilitation and reconstruction of the areas affected by the cyclones and floods;
- 3. Requests the specialized agencies and other international and regional organizations, as well as voluntary agencies, particularly those most directly concerned, to lend their support, within the framework of their respective programmes, to the efforts of the Secretary-General and the United Nations Disaster Relief Co-ordinator to mobilize relief and assistance, and also to consider urgently the requests for assistance made by the Government of Madagascar during the phase of rehabilitation and reconstruction;
- 4. Expresses the hope that the United Nations Development Programme, the World Bank and all other

international financial institutions concerned will give sympathetic and urgent consideration to requests for assistance which the Government of Madagascar may submit under its rehabilitation, reconstruction and development programmes and with a view to improving the existing disaster warning and protection systems;

5. Requests the Secretary-General to report to the Economic and Social Council at its second regular session of 1982 and to the General Assembly at its thirty-seventh session on the implementation of the present resolution.

1982/6. Measures to be taken following the heavy floods which have affected Democratic Yemen

The Economic and Social Council,

Considering that Democratic Yemen has recently suffered the effects of heavy floods which have caused loss of life and considerable damage to the economy of the country.

Having heard the statement of the delegation of Democratic Yemen on the extent of the damage caused by the unprecedented heavy floods, 10

Recalling the resolutions of the General Assembly and its own resolutions on assistance in cases of natural disasters, in which appeals have been made to the international community to give special attention to the phenomenon of natural disasters,

Taking into account the fact that the provision of assistance to countries stricken by natural disasters is an expression of the international solidarity proclaimed in the Charter of the United Nations,

Noting with satisfaction the assistance provided by several countries, international and regional organizations and voluntary agencies,

Noting also the efforts made by the Government of Democratic Yemen to relieve the suffering of the victims of the heavy floods,

- 1. Expresses its profound sympathy with the people and Government of Democratic Yemen for the loss of life and the serious damage which the recent floods have caused to the economy of the country;
- 2. Urges all States to participate or to continue to participate in relief operations and in the implementation of programmes for the rehabilitation and reconstruction of the areas affected by the floods:
- 3. Requests international and regional organizations, including specialized agencies, and voluntary agencies, particularly those most directly concerned, to lend their support and assistance, within the framework of their respective programmes, to the efforts of the Secretary-General and the United Nations Disaster Relief Co-ordinator to mobilize relief and assistance, and also to consider urgently the requests for assistance made by the Government of Democratic Yemen during the phase of rehabilitation and reconstruction;
- 4. Expresses the hope that the United Nations Development Programme, the World Bank and all other international financial institutions concerned will give sympathetic and urgent consideration to requests for

assistance which the Government of Democratic Yemen may submit under its rehabilitation, reconstruction and development programmes and with a view to improving the existing disaster warning and protection systems:

5. Requests the Secretary-General to report to the Economic and Social Council, at its second regular session of 1982 on the implementation of the present resolution.

1982/7. Convening of an International Conference on Population in 1984

The Economic and Social Council,

Recalling its resolution 1981/87 of 25 November 1981, in which it decided to convene an International Conference on Population in 1984,

Noting with appreciation the report of the Secretary-General of the Conference¹¹ and the significant progress made towards obtaining the necessary extrabudgetary resources for the Conference, as requested in paragraph 9 of Council resolution 1981/87,

Noting with satisfaction the current status of preparations for the Conference,

- 1. Welcomes the offer of the Government of Mexico to act as host to the International Conference on Population in 1984;
- 2. Decides to include in the agenda of its second regular session of 1982 an item on the convening of an International Conference on Population in 1984 in order:
- (a) Further to review the financial estimates for the Conference contained in the report of the Secretary-General¹² in the light of the contributions pledged;
- (b) To consider the status of the preparatory activities being undertaken;
- 3. Urges Member States to provide the necessary assistance and financial support in order to ensure the success of the preparatory activities and of the Conference.

19th plenary meeting 30 April 1982

1982/8. Measures to improve international cooperation in the interdiction of illicit drug traffic

The Economic and Social Council,

Recalling the need for close co-operation among law enforcement authorities in investigating the illicit traffic in narcotics and psychotropic substances,

Bearing in mind resolutions 2 (S-V) of 22 February 1978,13 5 (XXVIII) of 21 February 1979,14 4 (S-VI) of 20 February 1980¹⁵ and 3 (XXXIX) of 10 February

198116 of the Commission on Narcotic Drugs, as well as the relevant provisions of the international Conventions.

Firmly believing that, to be effective in combating and interdicting the illicit traffic, measures employed by customs and drug control administrations must be given wide international support,

- 1. Urges all Governments, whenever necessary, to strengthen their customs and drug control bodies with a view to promoting the interdiction of substances diverted to illicit channels, by means which include the provision of timely, relevant information and cooperation to the fullest extent possible with national and international organizations working in this area:
- 2. Appeals to all States to develop means of monitoring more effectively shipments of controlled drugs within and across their borders, particularly within free trading zones:
- 3. Calls upon States, subject to their constitutional limitations, their legal systems and domestic law, to pass and enforce laws that make the deliberate misrepresentation or mislabelling of controlled narcotic drugs or psychotropic substances punishable offences, or to take other suitable measures for their control;
- 4. *Invites* all Governments to respond positively to the suggestion of the International Narcotics Control Board that a list should be made of the precursors and reagents most widely used in the illicit manufacture of narcotic drugs and psychotropic substances¹⁷ by submitting this information to the Secretary-General at his request and bringing the list to the attention of their police, customs and other control authorities;
- 5. Requests the Secretary-General to transmit the text of the present resolution to all Governments and to invite them to bring it to the attention of their competent authorities in order to ensure the implementation of its provisions.

19th plenary meeting 30 April 1982

1982/9. Concerted action against the illicit drug traffic in Central and South America and the Caribbean region

The Economic and Social Council,

Recalling General Assembly resolution 36/132 of 14 December 1981,

Recognizing that, to be more effective, measures against the illicit drug traffic must be so co-ordinated that all affected States, including those not producers or significant consumers of illicit drugs, will be able to strengthen their countermeasures against such traffic nationally, regionally and internationally,

Aware of the urgent need to strengthen co-ordinated efforts in parts of Central and South America and the Caribbean region, having due regard to the special problems of this area in so far as drug law enforcement is concerned.

1. Requests the United Nations Fund for Drug Abuse Control to give favourable consideration,

within the limits of the financial resources available, to reasonable requests for assistance in strengthening effective action against the illicit drug traffic which may be received from countries in Central and South America and the Caribbean region;

2. Requests the Division of Narcotic Drugs, in cooperation with INTERPOL and the Customs Cooperation Council, to attach high priority to organizing drug law enforcement training seminars in Central and South America and the Caribbean region, making full use of the training facilities and expertise that may be available within the area or from countries in other regions affected by the traffic in drugs emanating from, or passing through, Central and South America and the Caribbean region, and requests the United Nations Fund for Drug Abuse Control to consider financing such seminars.

19th plenary meeting 30 April 1982

1982/10. International Year against Drug Abuse

The Economic and Social Council,

Having considered the report of the International Narcotics Control Board for 1981, 18

Noting with deep concern the Board's conclusion that, despite the international community's efforts to date, drug abuse throughout most of the world has not decreased—on the contrary, the situation has continued to deteriorate, afflicting more and more countries, both developing and developed, victimizing adolescents and even children, and leading to the availability of drugs of ever greater potency capable of being consumed in more hazardous ways,

Noting also the Board's call for the stimulation of action at all levels, from international to local, involving families, communities, neighbourhoods, schools, religious institutions, and public, private and voluntary associations and organizations,

Convinced that the holding within the near future of an International Year against Drug Abuse could serve as a catalyst for renewed world-wide awareness of the serious drug situation in many parts of the world and for stimulating the wide range of national and international activities required in the battle against drug abuse and illicit traffic,

Bearing in mind its resolution 1980/67 of 25 July 1980, by which it established guidelines for future international years,

- 1. Invites all Governments to submit, through the Secretary-General, their comments on the proposed proclamation of an International Year against Drug Abuse to the Commission on Narcotic Drugs for consideration at its thirtieth session;
- 2. Invites the Commission on Narcotic Drugs to transmit to the Council at its first regular session of 1983 an analysis of those comments, together with a recommendation thereon, in order that an appropriate recommendation may be submitted to the General Assembly at its thirty-eighth session;

3. Requests the Secretary-General to transmit the text of the present resolution to all Governments for consideration and action as appropriate.

19th plenary meeting 30 April 1982

1982/11. Co-operation with the International Narcotics Control Board concerning Schedule II of the 1971 Convention on Psychotropic Substances

The Economic and Social Council,

Noting with deep concern the increasing diversion from international commerce of psychotropic substances controlled under Schedule II of the 1971 Convention on Psychotropic Substances, 19 notably amphetamine, methamphetamine and methaqualone,

Commending the International Narcotics Control Board for the manner in which it is actively carrying out its mandate under the 1971 Convention with a view to promoting effective international control,

Bearing in mind the observations made by the Board in its report for 1981²⁰ concerning the international situation and the need for action by Governments,

Recalling the need for Governments to apply strictly to Schedule II substances the export and import authorization system provided for in article 12, paragraph 1, of the 1971 Convention,

- 1. Invites the International Narcotics Control Board to continue to monitor international trade substances listed in Schedule II of the 1971 Convention on Psychotropic Substances, to maintain dialogues with Governments and to exercise its good offices with a view to facilitating the earliest possible identification of instances of significant diversion and the prompt adoption of measures to curtail such diversion;
- 2. Invites Governments to co-operate with the Board and provide it promptly with the information it requests in order to enable it effectively to monitor international trade and identify diversion of Schedule II substances:
- 3. Also invites Governments of importing countries to send to Governments of exporting countries copies of import certificates, as suggested by the Board in its report for 1981;²¹
- 4. Appeals to manufacturing/exporting countries to refrain from exporting Schedule II substances in the event of the Board advising them that a suspicious pattern exists until further inquiries establish the legitimacy of the purposes for which the shipment is intended;
- 5. Reminds Governments of the need, in pursuance of article 12, paragraph 3, subparagraph (a), of the 1971 Convention, to exercise in free ports and zones the same supervision and control of Schedule II substances as is applied in other parts of their territories;
- 6. Calls attention to the possibility of Governments availing themselves of the protection against the import of unwanted substances afforded by article 13 of the 1971 Convention and to the need to imple-

ment the necessary measures to ensure that no exports of such substances to the prohibiting countries take place:

7. Requests the Secretary-General to transmit the present resolution to all Governments for urgent consideration and action as appropriate.

19th plenary meeting 30 April 1982

1982/12. Demand and supply of opiates for medical and scientific needs

The Economic and Social Council,

Recalling its resolutions 1979/8 of 9 May 1979, 1980/20 of 30 April 1980, 1981/8 of 6 May 1981, and resolution 1 (XXIX) of 11 February 1981 of the Commission on Narcotic Drugs, entitled "Strategy and policies for drug control", 22

Taking note of the supplement to the report of the International Narcotics Control Board for 1980, entitled Demand and Supply of Opiates for Medical and Scientific Needs, 23 and of the recommendations contained therein,

Reaffirming that a world-wide balance is essential between the supply of opiate raw materials and the demand for opiates for medical and scientific purposes,

Noting with satisfaction that a number of major importing, manufacturing and consuming countries have responded positively to the above-mentioned resolutions,

Concerned that large stocks of opiate raw materials held by the traditional supplier countries constitute a heavy financial and other burden for them,

- 1. Urges the Governments of those countries that have not already done so to take effective steps to implement the above-mentioned resolutions, and also to consider taking other steps, including those recommended by the International Narcotics Control Board, to achieve a world-wide balance between demand and supply of opiates for medical and scientific purposes;
- 2. Appeals to Governments which have not cultivated papaver bracteatum to consider possibilities for refraining from embarking on the commercial cultivation of papaver bracteatum;
- 3. Requests the Secretary-General to transmit the present resolution to all Governments, inviting them to bring it to the attention of their competent authorities.

1982/13. Strategy and policies for drug control

The Economic and Social Council,

Taking note of resolution 1 (S-VII) of 8 February 1982 of the Commission on Narcotic Drugs,²⁴

Recommends to the General Assembly the adoption of the following draft resolution:

"The General Assembly,

"Recalling its resolution 36/168 of 16 December 1981, by which it adopted the International Drug Abuse Control Strategy and the basic five-year programme of action²⁵ dealt with in resolution 1 (XXIX) of 11 February 1981 of the Commission on Narcotic Drugs, transmitted to the General Assembly by the Economic and Social Council in accordance with its decision 1981/113 of 6 May 1981,

"Recalling also that in paragraph 3 of resolution 36/168 the Commission on Narcotic Drugs was requested to establish, within available resources, a task force to review, monitor and co-ordinate the implementation of the International Drug Abuse Control Strategy and the programme of action.

"Recalling further its resolutions 32/124 of 16 December 1977, 33/168 of 20 December 1978, 34/117 of 17 December 1979 and 35/195 of 15 December 1980,

"Noting with satisfaction the establishment on a provisional basis by the Commission on Narcotic Drugs of the task force requested,

"Taking note of Economic and Social Council resolution 1982/13 of 3 May 1982 and resolution 1 (S-VII) of 8 February 1982 of the Commission on Narcotic Drugs,

- "1. Approves the projects recommended by the Commission on Narcotic Drugs in its resolution 1 (S-VII), as set out in the report of the Commission on its seventh special session, 26 for implementation in 1983;
- "2. Requests the Commission on Narcotic Drugs to review the reports of its task force and to report thereon, through the Economic and Social Council, to the General Assembly at its thirty-eighth session:
- "3. Urges all Member States, non-member States parties to the international drug control treaties, specialized agencies and other international organizations and private institutions concerned with the drug abuse problem to strengthen their participation in and support for activities related to the International Drug Abuse Control Strategy and the programme of action;
- "4. Also urges Member States to contribute or increase their contributions to the United Nations Fund for Drug Abuse Control in order to ensure success of the International Drug Abuse Control Strategy and to give firm impetus to the world community's battle against international drug traffickers and against drug abuse;
- "5. Requests the Secretary-General to transmit the text of the present resolution and related documents to all Member States, non-member States parties to the international drug control treaties, and all relevant international, intergovernmental and non-governmental organizations."

1982/14. Establishment of a regional office at Lima for co-ordinating narcotics control

The Economic and Social Council,

Recalling the resolutions on the problem of drug abuse control adopted in recent years by the General Assembly, the Economic and Social Council, the Commission on Narcotic Drugs, the World Health Organization and other competent bodies,

Recalling, in particular, General Assembly resolution 36/168 of 16 December 1981, by which the Assembly adopted the International Drug Abuse Control Strategy and the basic five-year programme of action²⁷ dealt with in resolution 1 (XXIX) of 11 February 1981 of the Commission on Narcotic Drugs, transmitted to the Assembly by the Economic and Social Council in accordance with its decision 1981/113 of 6 May 1981,

Convinced that greater control of the production and distribution of narcotics and a reduction of the demand for illicit narcotics are necessary prerequisites for reducing the illicit traffic in narcotic drugs and psychotropic substances,

Conscious of the links between drug trafficking and serious problems of a socio-economic nature, which are reflected in an intensification of organized crime, the illegal acquisition of firearms, exchange-control violations, customs offences and various other forms of criminality,

Acknowledging that constraints of an economic and technical nature are obstacles for many developing countries in their fight against drug trafficking,

Drawing attention to the need for developing country producers of narcotic drugs to receive more assistance from Governments and international organizations concerned, so that they will be able to facilitate drug abuse control by implementing policies of crop substitution and programmes of industrial and rural development,

Taking into account United Nations programmes related to combating the problem of drug trafficking, in particular the International Drug Abuse Control Strategy, which recognize the need to encourage activities at the regional level, inter alia, by grouping together geographical areas with similar social, economic and cultural characteristics and by preparing one or more strategies for those areas which should be effective in the short term,

Considering that the increase in coca production in the Andean subregion is assuming alarming proportions, owing to the growing illicit demand for cocaine throughout the world, and that it is therefore necessary to deal globally with the problem in all its manifestations,

1. Calls upon the Commission on Narcotic Drugs to give higher priority to the problems of illicit production of narcotic drugs and the trafficking in and abuse of narcotic drugs in the Andean subregion, including in particular coca, and to formulate, with the participation of the United Nations narcotics agencies, a more specific strategy and programmes for the subregion within its regular budget and through voluntary contributions;

- 2. Requests the Secretary-General, through the United Nations Fund for Drug Abuse Control, to assist in co-ordinating international narcotics control efforts in the Andean subregion, and to consider the establishment of a regional office at Lima, taking into account the recommendations concerning regional activities outlined in the International Drug Abuse Control Strategy, as agreed to in General Assembly resolution 36/168:
- 3. Requests the specialized agencies, Member States and non-governmental organizations to assist in the implementation of the present resolution and to collaborate in any projects and activities which may become part of the programme;
- 4. *Urges* Governments to support United Nations efforts in the Andean subregion by contributing to the United Nations Fund for Drug Abuse Control.

20th plenary meeting 3 May 1982

1982/15. International Year of Peace and International Day of Peace

The Economic and Social Council,

Recalling that in the Preamble to the Charter of the United Nations the peoples of the United Nations proclaim their determination to save succeeding generations from the scourge of war and, for that end, to practise tolerance and live together in peace with one another as good neighbours and to unite their strength to maintain international peace and security,

Recognizing that, in spite of resolute efforts of the United Nations, peace continues to be a goal the attainment of which is only precarious and is not a living and permanent awareness of all human beings and peoples,

In pursuance of General Assembly resolution 36/67 of 30 November 1981, in which the Assembly invited the Economic and Social Council to consider the possibility of declaring an International Year of Peace at the first practicable opportunity, taking into account the urgency and special nature of such an observance as well as the guidelines for international years and anniversaries adopted by the General Assembly in its decision 35/424 of 5 December 1980,

Conscious of the validity of the guidelines for international years and anniversaries adopted by the General Assembly in that decision and taking into account that the special urgency and importance which the Assembly attached to this Year seems exceptionally, in this instance, to justify some derogation from the guidelines,

Considering that, since the promotion of peace in accordance with the principles of the Charter is a fundamental purpose of the United Nations, the proclamation and subsequent observance of the International Year of Peace could be linked to the fortieth anniversary of the Organization, on 24 October 1985,

- 1. Recommends to the General Assembly that, at its thirty-seventh session, it should:
- (a) Establish 1986 as the International Year of Peace;
- (b) Solemnly proclaim the International Year of Peace on 24 October 1985, the date of the observance

of the fortieth anniversary of the United Nations, on the understanding that the activities of the Year will begin on 1 January 1986;

- (c) Invite Member States and observers, relevant organs and organizations of the United Nations system and non-governmental organizations concerned to submit to the Secretary-General suggestions for the observance of the International Year of Peace;
- 2. Further recommends to the General Assembly that, at its thirty-seventh session, it should request the Secretary-General, taking into account the suggestions referred to in paragraph 1 (c) above, to propose at the thirty-eighth session a draft programme and budget for the observance of the International Year of Peace, on the understanding that its financing will conform to the guidelines laid down by Assembly decision 35/424.

22nd plenary meeting 4 May 1982

1982/16. Activities of non-governmental organizations

The Economic and Social Council,

Taking note of the letter dated 19 April 1982 from the Chairman of the Committee on Non-Governmental Organizations to the President of the Economic and Social Council regarding the question of the activities of non-governmental organizations in relation to South Africa,²⁸

Taking note with appreciation of the work done by some non-governmental organizations with a view to the eradication of the policy of apartheid, as practised by the Government of South Africa,

- 1. Expresses its expectation that non-governmental organizations in consultative status with the Economic and Social Council will take due account in their activities of relevant resolutions of the Council and the General Assembly condemning the policy of apartheid as practised by the Government of South Africa, in accordance with Council resolution 1296 (XLIV) of 23 May 1968;
- 2. Requests the Committee on Non-Governmental Organizations to include an examination of this question in the review of current practice related to the implementation of Council resolution 1296 (XLIV) which it is to undertake at its next session, in 1983.

22nd plenary meeting 4 May 1982

1982/17. Convention on the Elimination of All Forms of Discrimination against Women

The Economic and Social Council,

Recalling General Assembly resolution 34/180 of 18 December 1979, in which the Assembly adopted the Convention on the Elimination of All Forms of Discrimination against Women contained in the annex thereto.

Recalling also General Assembly resolution 35/140 of 11 December 1980,

Recalling further General Assembly resolution 36/131 of 14 December 1981,

Stressing the central role of the Commission on the Status of Women in considering within the United Nations matters relating to the achievement of the objectives of the United Nations Decade for Women: Equality, Development and Peace,

Reaffirming its conviction that the ratification of, or accession to, the Convention on the Elimination of All Forms of Discrimination against Women and the implementation of its provisions are important for the attainment of the three objectives of the United Nations Decade for Women: Equality, Development and Peace.

- 1. Welcomes with great satisfaction the entry into force on 3 September 1981 of the Convention on the Elimination of All Forms of Discrimination against Women:
- 2. Urges States that have not yet become parties to the Convention to ratify it or to accede to it;
- 3. Expresses its interest in the earliest possible commencement of the work of the Committee on the Elimination of Discrimination against Women provided for in part V of the Convention, in particular with a view to considering national reports on the implementation of the Convention in accordance with article 18 thereof;
- 4. Requests the Secretary-General to transmit the reports of the Committee to the Commission on the Status of Women for its information:
- 5. Recommends that the Commission on the Status of Women should include the question of the status of the Convention in the agenda of its thirtieth session;
- 6. Recommends to the Secretary-General that he should consider a concerted information effort to spread knowledge regarding the Convention.

22nd plenary meeting 4 May 1982

1982/18. Situation of women and children in the occupied Arab territories

The Economic and Social Council,

Deeply concerned about the prevailing conditions of the Palestinian people, particularly the women and children.

Noting the great sacrifices of the Palestinian women and children in pursuit of their inalienable right to have their own homeland,

Considering that international co-operation and peace are threatened by colonialism, neo-colonialism, fascism, zionism, apartheid and foreign occupation, alien domination and racial discrimination in all its forms,

Affirming its full solidarity with the Palestinian women in their struggle for independence under the leadership of the Palestine Liberation Organization,

Expressing its grave concern that the Palestinian women and people continue to be denied their inalienable rights, in particular their right to return to their homes and property from which they have been displaced and uprooted, the right to self-determination

and the right to national independence and sovereignty,

Recognizing that the mass uprooting from their homeland obstructs the participation and integration of women in efforts to achieve progress,

- 1. Appeals to all women of the world to proclaim their solidarity with and support for the Palestinian women and people in their drive to put an end to the flagrant violation by Israel of fundamental human rights in the occupied territories;
- 2. Also appeals to all States and international organizations to extend all moral and material assistance to the Palestinian and Arab women and people in their struggle for the restoration of their inalienable right to return to their homes and property from which they have been displaced and uprooted;
- 3. Further appeals to all women of the world to take the necessary measures to secure the release of thousands of persons, including women and children, fighters for the cause of self-determination, liberation and independence, held arbitrarily in the prisons of the occupying forces;
- 4. Requests the United Nations and its organs and specialized agencies, as well as all national, regional and international women's organizations, to extend their help, both moral and material, to the Palestinian women and their organizations and institutes.

1982/19. Role of women in economic development

The Economic and Social Council,

Recalling General Assembly resolution 35/136 of 11 December 1980, in which the Assembly endorsed the Programme of Action for the Second Half of the United Nations Decade for Women,²⁹

Bearing in mind General Assembly resolutions 3201 (S-VI) and 3202 (S-VI) of 1 May 1974, containing the Declaration and the Programme of Action on the Establishment of a New International Economic Order, 3281 (XXIX) of 12 December 1974, containing the Charter of Economic Rights and Duties of States, and 3362 (S-VII) of 16 September 1975 on development and international economic co-operation,

Emphasizing the importance of women's full participation in the development process as agents and beneficiaries of development,

Aware that improvement in the economic condition and role of women is a necessary prerequisite for an improvement in the status of women,

Aware that at present women are not equal beneficiaries of the fruits of economic and social development,

1. Recommends that the General Assembly should request all specialized agencies and other relevant organizations, in particular the United Nations Development Programme, to consider including special fi-

nancial components, within existing budgetary resources, in their technical co-operation programmes for the development of women in the economic field, enhancing the entrepreneurial and technological capacity of women, particularly in the co-operative and non-traditional sectors and in developing countries;

2. Requests the Secretary-General to report to the Commission on the Status of Women at its thirtieth session on the implementation of the present resolution

23rd plenary meeting 4 May 1982

1982/20. Suppression of the traffic in persons and of the exploitation of the prostitution of others

The Economic and Social Council,

Considering the terms of General Assembly resolution 317 (IV) of 2 December 1949,

Referring to resolution 1 (XXVII) of 4 April 1978 of the Commission on the Status of Women,³⁰

Recalling its resolutions 1980/4 of 16 April 1980 and 1981/40 of 8 May 1981,

Taking into account the work of the Sub-Commission on Prevention of Discrimination and Protection of Minorities and the report on its thirty-fourth session,³¹

Having taken note of the report presented orally to the Commission on the Status of Women at its twenty-ninth session,

Aware of the contribution that the Centre for Social Development and Humanitarian Affairs can make by reason of its interdisciplinary competence,

Convinced that the scope of the problem raised by the traffic in persons, in particular women and children, requires consultation and co-ordination by all the competent agencies in the United Nations system or outside the system—the regional commissions, the Office of the United Nations High Commissioner for Refugees, the World Health Organization, the International Labour Organisation, the United Nations Children's Fund, the United Nations Educational, Scientific and Cultural Organization, the World Tourism Organization, INTERPOL and non-governmental organizations interested in this problem,

Requests the Secretary-General to appoint a special rapporteur who, within existing budgetary resources, will make a synthesis of the surveys and studies on the traffic in persons and the exploitation of the prostitution of others that have been or are being carried out within the agencies in the United Nations system or outside the system, and will present that synthesis and propose appropriate measures to prevent and suppress those practices that are contrary to the fundamental rights of human beings at the first regular session of 1983 of the Council.

1982/21. Action to be taken to ensure the recovery abroad of maintenance

The Economic and Social Council,

Noting that in many countries the number of divorces and separations has continually increased during recent years,

Taking note of the fact that judicial or administrative decisions taken on the occasion of divorces and separations often include the payment of maintenance intended to meet, at least partly, the needs of the spouse and the children, as issue of the union, for whom the spouse is responsible, taking into consideration existing legislation in the countries of the two spouses,

Considering that the recovery of such maintenance, which is already difficult within the national territory, becomes practically impossible when the debtor spouse resides abroad,

Emphasizing the extreme prejudicial situation of creditors in respect of maintenance due who are injured in this way,

Emphasizing also the important progress constituted, for the States that have ratified it, by the Convention on the Recovery Abroad of Maintenance, done at New York on 20 June 1956,³²

- 1. Requests the Secretary-General to provide full information on the Convention on the Recovery Abroad of Maintenance, done at New York on 20 June 1956; in addition, States parties could study possible improvements in the light of their experience with regard to that Convention;
- 2. Expresses the wish that States which have not yet done so should ratify the Convention as soon as possible, in view of its undeniable humanitarian scope;
- 3. *Invites* the States parties to that Convention, in conformity with article 10 thereof, to accord the highest priority to the transfer of funds payable as maintenance or to cover expenses in respect of proceedings under that Convention.

23rd plenary meeting 4 May 1982

1982/22. Abuses against women and children

The Economic and Social Council,

Taking note of the continued and consistent concern expressed by the international community at the blatant and inhuman abuses of women and children,

Recognizing the evils of such abuses as kidnapping, abduction, forced child labour, battered women and children, violence in the family, rape, prostitution, and the inevitable serious problems of mental and physical health.

Appalled by the resultant exploitation, oppression and violence to human dignity,

Believing that the abuse of women and children is an intolerable offence to the dignity of the human being and is a harsh indictment of any claim to be civilized,

1. Calls upon Member States to take immediate and energetic steps to combat these social evils and to inform the Secretary-General of the action taken;

2. Requests the Secretary-General to compile a study on the action taken by Member States for submission as a report to the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women to be held in 1985, if the Preparatory Committee for the Conference so decides.

23rd plenary meeting 4 May 1982

1982/23. Elderly women and the World Assembly on Aging

The Economic and Social Council,

Recalling General Assembly resolutions 32/131 of 16 December 1977, 33/52 of 14 December 1978, 34/153 of 17 December 1979 and 35/129 of 11 December 1980,

Recalling also resolution 13, entitled "Social security and family security for women, including the elderly and the handicapped", adopted by the World Conference of the International Women's Year,³³ and resolution 4, entitled "Elderly women and economic security", adopted by the World Conference of the United Nations Decade for Women: Equality, Development and Peace,³⁴

Emphasizing the fact that, because the increasing life expectancy of women exceeds that of men in many developing and more developed societies, elderly women are a rapidly increasing segment of the national population,

Aware that elderly women have suffered from past discrimination and lack of opportunity and that in many countries the economic plight of elderly women is becoming more serious,

Concerned that this situation is further complicated by increased migration of family members and other cultural phenomena resulting in socio-economic hardships for the aging,

Bearing in mind the Convention on the Elimination of All Forms of Discrimination against Women,³⁵

- 1. Urges that the special problems faced by elderly women, such as income security, education, employment, housing, health and community support services, should be given explicit and full attention by the World Assembly on Aging to be held at Vienna from 26 July to 6 August 1982, and should be dealt with in the plan of action to be adopted by the World Assembly;
- 2. Requests Member States to ensure that women are included in the preparations for the World Assembly on Aging and are appointed as members of their delegations to that Assembly;
- 3. Requests Member States and the relevant United Nations bodies to continue to collect data on the situation of elderly women to serve as a basis for formulating and implementing policies and programmes to define their special economic and social planning needs;

4. Urges all Governments, national and international organizations, both governmental and non-governmental, the mass media, educational bodies and all individuals concerned to strengthen their efforts to adopt or change national laws to ensure that elderly women have equal opportunities to live in health, dignity, self-reliance and self-fulfilment.

23rd plenary meeting 4 May 1982

1982/24. Women and children under apartheid

The Economic and Social Council,

Recalling General Assembly resolution 35/206 N of 16 December 1980 on women and children under apartheid,

Recalling also resolution 45 adopted by the World Conference of the United Nations Decade for Women,³⁶

Reaffirming that apartheid is a crime against humanity,

Noting with admiration the great sacrifices of the women and children in South Africa and Namibia in the struggle for their inalienable rights and their national liberation,

Recognizing that the so-called constitutional and other reforms by the racist minority régimes are no more than mere adjustments within the framework of apartheid.

Affirming its full solidarity with the women of South Africa and Namibia in the struggle for liberation under the leadership of their national liberation movements,

Considering that international efforts should be greatly intensified to publicize the plight of women and children in South Africa and Namibia and to promote greater solidarity with and assistance to them in the context of their heroic struggle for the liberation of South Africa and Namibia,

Appreciating the valuable contribution made by the various United Nations voluntary funds for southern Africa, including the United Nations Educational and Training Programme for Southern Africa,

Gravely concerned about the inhuman oppression of millions of women and children under apartheid, which manifests itself in the killing, detention and torture of school children protesting against discrimination, the enforced separation of women from their husbands and mass starvation in the reserves,

Commending the Special Committee against Apartheid and its Task Force on Women and Children for giving special attention to the plight of women and children under apartheid,

Noting with appreciation the establishment of the International Committee of Solidarity with the Struggle of Women in South Africa and Namibia,

1. Reaffirms the commitment of the United Nations to the total eradication of apartheid and the promotion of the establishment of a democratic society in which all the people of South Africa as a whole, irre-

spective of race, colour, sex or creed, will enjoy equal and full human rights and fundamental freedoms and will participate freely in the determination of their destiny:

- 2. Invites all Governments and organizations to observe 9 August annually as the International Day of Solidarity with the Struggle of Women in South Africa and Namibia;
- 3. Appeals to all Governments and organizations to provide generous contributions to the projects of the national liberation movements and front-line States for assistance to refugee women and children from South Africa and Namibia;
- 4. Further appeals to all Governments to make generous contributions to the various trust funds for southern Africa, including the United Nations Educational and Training Programme for Southern Africa;
- 5. Welcomes the decision of the Special Committee against Apartheid to organize, in co-operation with the International Committee of Solidarity with the Struggle of Women in South Africa and Namibia, an international conference on women and apartheid, to be held at Brussels from 17 to 19 May 1982;
- 6. Invites women's organizations all over the world to intensify their action in solidarity with the struggle for liberation in South Africa and Namibia and to consider a greater co-ordination of their efforts in cooperation with the Special Committee against Apartheid.

23rd plenary meeting 4 May 1982

1982/25. Women and children refugees

The Economic and Social Council,

Considering the agony and suffering of the Kampuchean refugees in South-East Asia,

Considering the special problems of women refugees, particularly with regard to physical safety,

- 1. Expresses grave concern at the plight of Kampuchean women and children, including the many thousands who have been forced to flee to other countries as refugees;
- 2. Calls upon the international community to continue to share the burden of assisting refugees and displaced persons from Kampuchea.

23rd plenary meeting 4 May 1982

1982/26. Preparations for the 1985 World Conference to Review and Appraise the Achievements of the United Nations Decade for Women

The Economic and Social Council,

Considering that the General Assembly, in its resolution 35/136 of 11 December 1980, decided to convene in 1985, at the conclusion of the United Nations Decade for Women: Equality, Development and Peace, a world conference to review and appraise the achievements of the Decade,

Recalling General Assembly resolution 36/126 of 14 December 1981, in which the Commission on the

Status of Women was requested to give priority at its twenty-ninth session to the question of the preparations for the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women, with a view to submitting to the Assembly at its thirty-seventh session, through the Economic and Social Council, specific proposals on that question.

Recalling also General Assembly resolution 35/10 C of 3 November 1980, by which the Assembly decided that preparatory committees should be established for special conferences only if that function could not be appropriately performed by an existing intergovernmental organ,

Emphasizing the importance of undertaking at the conclusion of the Decade a critical review and appraisal of progress at international, regional and national levels in the achievement of the goals of the Decade—equality, development and peace—and the subthemes of education, health and employment, and the obstacles encountered in the implementation of the World Plan of Action for the Implementation of the Objectives of the International Women's Year³⁷ and the Programme of Action for the Second Half of the United Nations Decade for Women,³⁸ and also of developing a forward-looking perspective on the status of women.

Emphasizing also the need to identify the most effective strategies and methods of work at the international level and to establish priorities for the United Nations system,

Bearing in mind the positive response of many Governments to the World Plan of Action, in the form of national mechanisms or legislation,

Also bearing in mind the need in the coming years to realize the full potential of those mechanisms or legislation to enable women to maintain and consolidate gains made during the Decade,

Taking note of the report of the Secretary-General on the preparations for the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women,³⁹ to be held in 1985,

- 1. Decides that the Commission on the Status of Women shall be the preparatory body for the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women and shall operate on the basis of consensus, and invites the widest possible participation by Member States in the deliberations of the preparatory body;
- 2. Recommends that the Commission on the Status of Women, acting as the preparatory body for the Conference, should meet at Vienna in extraordinary session in 1983 and again in 1985 with conference preparations as the sole item of the agenda, and that its thirtieth regular session, in 1984, should be extended to allow additional time for conference preparations;
- 3. Decides also to recommend to the General Assembly that the Advancement of Women Branch of the

Centre for Social Development and Humanitarian Affairs of the Secretariat should serve as the secretariat of the preparatory body, as well as of the Conference;

- 4. Recommends also that the General Assembly should make the necessary budgetary allocations, in the light of the proposals made by the preparatory body at its first session, to enable the Advancement of Women Branch to perform those duties;
- 5. Recommends further that, with a view to the achievement of the goals of the Decade, a forward-looking draft perspective on the status of women to the year 2000 should be prepared by the preparatory body for consideration by the Conference based on the experience gained in the implementation of the World Plan of Action for the Implementation of the Objectives of the International Women's Year and the Programme of Action for the Second Half of the United Nations Decade for Women;
- 6. Encourages Member States to consider establishing national committees to assist, for example, in national-level preparations for the Conference, consultations on issues and themes and the preparation of national reports;
- 7. Invites the regional commissions to conduct consultations, within existing resources, on issues and themes for the Conference and on organizational arrangements at the regional level to prepare for the Conference, and to submit the results of those consultations to the preparatory body;
- 8. Invites Member States to submit in writing, by 1 July 1982, their views on the proposed goals and specific themes of the Conference so that the Centre for Social Development and Humanitarian Affairs can prepare a report based on those views by 31 January 1983, for consideration by the Commission, in its capacity as preparatory body, at its extraordinary session in 1983;
- 9. Also invites non-governmental organizations having consultative status with the Economic and Social Council and intergovernmental organizations to submit their views, in writing, on their contributions to the Conference and on possible issues and themes for the Conference to the Centre for Social Development and Humanitarian Affairs, for consolidated presentation to the preparatory body;
- 10. Requests the Secretary-General to undertake interagency consultations on issues and themes for the Conference with a view to presenting an interagency report on the question to the preparatory body at its first session;
- 11. Decides to consider at its first regular session of 1983, in connexion with the question of the United Nations Decade for Women: Equality, Development and Peace, the report of the Commission on the Status of Women on its first session as preparatory body for the World Conference.

1982/27. International Research and Training Institute for the Advancement of Women

The Economic and Social Council,

Recalling its resolutions 1998 (LX) of 12 May 1976 and 1981/13 of 6 May 1981 on the International Re-

Having considered the report of the Secretary-General on developments relating to the organizational aspects of the Institute,⁴⁰

Taking note with satisfaction of the report of the Board of Trustees of the International Research and Training Institute for the Advancement of Women on its second session,⁴¹

Expressing its satisfaction with the approved programme and activities of the Institute for 1982–1983,

Taking note with appreciation of the host country's effort to ensure the completion of the Institute's premises at Santo Domingo by June 1982,

- 1. Requests the Secretary-General to take all necessary measures to ensure the transition of the functioning of the International Research and Training Institute for the Advancement of Women to its head-quarters in the Dominican Republic;
- 2. Emphasizes that the research and training activities of the Institute should aim at strengthening the links between issues affecting women and mainstream development activities at all levels;
- 3. Endorses the network concept to be developed in stages with the organizations of the United Nations system and regional and national institutions as a mode of operation for the execution of the programmes of the Institute;
- 4. Reiterates the need for close and continued cooperation between the United Nations system and other organizations and the Institute, particularly in research and training, which would lead to increased technical co-operation for development;
- 5. Requests the regional commissions, the specialized agencies and other organizations and bodies in the United Nations system to co-operate fully and to give support to the Institute, particularly in the programming and implementation of joint activities;
- 6. Calls upon all Member States to contribute to the United Nations Trust Fund for the International Research and Training Institute for the Advancement of Women or to co-operate in other ways with the Institute so as to ensure regular and effective financing for its programme development;
- 7. Requests the Secretary-General to inform the General Assembly at its thirty-seventh session of the activities and programme of the Institute.

23rd plenary meeting 4 May 1982

1982/28. Co-ordination and information in the field of youth

The Economic and Social Council,

Recalling its resolutions 1979/27 of 9 May 1979, 1980/25 of 2 May 1980 and 1981/25 of 6 May 1981 on co-ordination and information in the field of youth,

Recalling also resolution 34/151 of 17 December 1979, by which the General Assembly decided to designate 1985 as International Youth Year: Participation,

Development, Peace, and resolution 36/28 of 13 November 1981, by which the Assembly endorsed the specific Programme of Measures and Activities to be undertaken prior to and during the International Youth Year.

Noting that the Advisory Committee for the International Youth Year will hold its second session at Vienna from 14 to 23 June 1982,

Considering that the implementation of the specific Programme of Measures and Activities to be undertaken prior to and during the International Youth Year will contribute to intensifying and improving the coordination of the activities of the United Nations and specialized agencies relating to youth,

Convinced of the importance of giving widespread publicity to the activities of the United Nations in the field of youth and of increasing the dissemination of information about youth, especially in the context of the preparations for the International Youth Year,

Recalling the conclusions contained in the report of the Committee for Programme and Co-ordination on the work of its twenty-first session regarding the cross-organizational programme analysis of the youth activities of the United Nations system,⁴²

Taking note of the report of the Secretary-General on co-ordination and information in the field of youth, 43

- 1. Endorses the conclusions contained in the report of the Secretary-General on co-ordination and information in the field of youth;
- 2. Requests the Secretary-General to take into account the ideas expressed in the Economic and Social Council on ways and means for improving the activities of co-ordination and information in the field of youth in the preparation of the documentation to be submitted to the Advisory Committee for the International Youth Year at its second session;
- 3. Invites all United Nations bodies, specialized agencies, regional commissions and other international intergovernmental organizations, as well as nongovernmental organizations concerned, to pay particular attention to the improvement of co-ordination and information in the field of youth in the context of the implementation of the specific Programme of Measures and Activities to be undertaken prior to and during the International Youth Year;
- 4. Decides to consider at its first regular session of 1983, on the basis of a report of the Secretary-General, the progress achieved in co-ordination and information in the field of youth.

1982/29. Preparations for the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders, with special reference to its agenda

The Economic and Social Council,

Considering that, in pursuance of General Assembly resolution 415 (V) of 1 December 1950, the Seventh

United Nations Congress on the Prevention of Crime and the Treatment of Offenders is to be convened in 1985

Bearing in mind General Assembly resolutions 32/59 and 32/60 of 8 December 1977 and 35/171 of 15 December 1980, in which the Assembly noted the importance of the United Nations congresses in the field of crime prevention and criminal justice,

Recognizing the significant contributions of the congresses in the promotion and strengthening of international co-operation in this field,

Recalling its decision 1981/122 of 6 May 1981, in which the Secretary-General was requested, without prejudice to the established reporting procedures, to submit a comprehensive statement on the preparatory work for the Seventh Congress to the Economic and Social Council at its first regular session of 1982,

Recalling also General Assembly resolution 36/21 of 9 November 1981, in which the Secretary-General was requested to take into account the relevant recommendations made by the Committee on Crime Prevention and Control at its seventh session regarding the preparations for the Congress,

Emphasizing the importance of undertaking all the preparatory activities in a timely and concerted manner,

Acknowledging the need to create governmental, professional and public awareness of the issues related to crime prevention and criminal justice in the context of development, particularly in the preparatory phase of the Congress,

Conscious of the positive response of many countries to the Caracas Declaration and the recommendations of the Sixth Congress,⁴⁴ and of the need to keep national authorities involved in the preparations for the Seventh Congress,

Having considered the relevant recommendations made by the Committee on Crime Prevention and Control at its seventh session, 45 bearing in mind that, in accordance with paragraph 2 of General Assembly resolution 32/60, the Committee is entrusted with the function of preparing the quinquennial United Nations congresses on the prevention of crime and the treatment of offenders,

Taking note of the comprehensive statement of the Secretary-General⁴⁶ and of the note on the continuation of preparations for the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders,⁴⁷

- 1. Approves the provisional agenda for the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders, as recommended by the Committee on Crime Prevention and Control at its seventh session, set out below:
 - "1. Opening of the Congress
 - "2. Organizational matters
 - "3. New dimensions of criminality and crime prevention in the context of development: challenges for the future

- "7. Formulation and application of United Nations standards and norms in criminal justice
- "8. Adoption of the report of the Congress";
- 2. Endorses the recommendations of the Committee, particularly the recommendation that item 3 should be discussed in plenary meetings, the remaining items being dealt with by two main committees;
- 3. Encourages Governments to make preparations for the Congress by all appropriate means, with a view to formulating national position papers;
- 4. Invites Member States to submit, for consideration by the Seventh Congress, information to the Secretary-General on the implementation of the recommendations of the Sixth Congress, in order to ensure continuity between the two Congresses in accordance with resolution 17 of the Sixth Congress;⁴⁴
- 5. Also invites the regional commissions, the regional and international institutes in the field of crime prevention and the treatment of offenders, the specialized agencies and other entities within the United Nations system, other intergovernmental organizations concerned and non-governmental organizations having consultative status with the Economic and Social Council to become actively involved in the preparations for the Seventh Congress;
- 6. Urges the Secretary-General to undertake the necessary interagency consultations within the machinery of the Administrative Committee on Coordination as a means of facilitating the work of the Committee on Crime Prevention and Control in its function of assisting the Council in co-ordinating activities in the field of crime prevention and control;
- 7. Requests the Secretary-General to take all necessary measures to ensure the successful undertaking of the preparatory activities for the Seventh Congress as well as the success of the Congress itself, including the convening of the regional preparatory meetings and interregional meetings of experts in 1983 and 1984, and the commissioning of experts and consultants, selected with due regard to equitable geographical representation, to assist in the preparation of the necessary documentation and in the professional conduct of the proceedings of the Congress, in accordance with past practice and with rule 58 of the provisional rules of procedure of the congresses;⁴⁸
- 8. Also requests the Secretary-General to provide the necessary additional resources, including temporary assistance, to the Centre for Social Development and Humanitarian Affairs of the Secretariat in order to enable its Crime Prevention and Criminal Justice Branch to undertake, in an effective and timely manner, all the preparatory activities for the Seventh Congress;
- 9. Recommends that adequate provision should be made for the attendance of the regional commissions at the next session of the Committee on Crime Prevention and Control and at the Congress;

1982/30. Enhancement of the functioning of the Committee on Crime Prevention and Control in relation to the preparation of United Nations congresses on the prevention of crime and the treatment of offenders

The Economic and Social Council,

Having considered the report of the Secretary-General on preparations for the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders,⁴⁹

Convinced of the need to make more effective the methods of work of the Committee on Crime Prevention and Control, especially in connexion with its function of preparing the United Nations congresses on the prevention of crime and the treatment of offenders.

Desiring to enable the Committee to undertake its functions between sessions, in accordance with paragraph 1 (a) of Economic and Social Council resolution 1979/19 of 9 May 1979 and General Assembly resolution 32/60 of 8 December 1977, particularly in relation to its functions as a preparatory committee,

- 1. Decides that the Chairman of the Committee on Crime Prevention and Control may appoint persons from among the members of the Committee who may give advice in respect of the regional and interregional preparatory meetings for the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders:
- 2. Requests the Secretary-General to implement fully the decisions and recommendations made by the Committee on Crime Prevention and Control at its seventh session, in accordance with paragraph 2 of Economic and Social Council resolution 1979/19.

23rd plenary meeting 4 May 1982

1982/31. Implementation of the Programme for the Decade for Action to Combat Racism and Racial Discrimination

The Economic and Social Council,

Recalling General Assembly resolution 3057 (XXVIII) of 2 November 1973, in which the Assembly proclaimed the Decade for Action to Combat Racism and Racial Discrimination and approved the Programme for the Decade,

Recalling also the other relevant General Assembly resolutions, particularly resolution 34/24 of 15 November 1979, in which the Assembly adopted the four-year programme of activities designed to accelerate progress in the implementation of the Programme for the Decade.

Bearing in mind General Assembly resolution 35/33 of 14 November 1980, in which the Assembly decided to hold in 1983, as an important event of the Decade, a second world conference to combat racism and racial discrimination, and invited the Economic and Social Council to begin the preparatory work for the conference at its first regular session of 1981,

Convinced that effective implementation of the Programme for the Decade will help to promote and encourage respect for human rights and fundamental freedoms for all, without distinction as to race, colour, descent or national or ethnic origin,

Recalling its resolutions 1980/7 of 24 April 1980 and 1981/30 of 6 May 1981,

- 1. Takes note with satisfaction of the report of the Secretary-General submitted in accordance with General Assembly resolution 3057 (XXVIII);⁵⁰
- 2. Recommends to the General Assembly the adoption of the following draft resolution:

"The General Assembly,

"Reaffirming its resolve to bring about the total and unconditional eradication of racism, racial discrimination and apartheid, which still represent serious obstacles to further progress and to the strengthening of international peace and security,

"Recalling that, in its resolution 3057 (XXVIII) of 2 November 1973 and in the Programme for the Decade for Action to Combat Racism and Racial Discrimination annexed thereto, and in other relevant resolutions, it called upon all peoples, Governments and institutions to continue their efforts to eradicate racism, racial discrimination and apartheid and thus to promote respect for human rights and fundamental freedoms for all, without distinction as to race, colour, descent or national or ethnic origin,

"Taking into account the Declaration and the Programme of Action adopted by the World Conference to Combat Racism and Racial Discrimination,⁵¹

"Recalling that, in the programme of activities to be undertaken during the second half of the Decade for Action to Combat Racism and Racial Discrimination contained in the annex to its resolution 34/24 of 15 November 1979, it called upon all States, United Nations organs and intergovernmental and non-governmental organizations to intensify their efforts to achieve the speediest attainment of the objectives of the Decade, aimed at the complete and final elimination of all forms of racism and racial discrimination,

"Expressing its serious concern at the situation prevailing in South Africa and throughout southern Africa as a result of the policies and actions of the apartheid régime, particularly its efforts to per-

petuate and strengthen racist domination of the country, its policy of 'bantustanization', its brutal repression of opponents of apartheid and its renewed acts of aggression against neighbouring States,

"Reaffirming that apartheid is a crime against humanity,

"Particularly concerned at the persistence of the illegal occupation of Namibia by the racist minority régime of South Africa,

"Disappointed that the talks between the United Nations and the South African racist and illegal occupation régime aimed at reaching a negotiated settlement of the question of Namibia have thus far failed because of the bad faith of that régime,

"Reaffirming that any collaboration with the racist régime of South Africa constitutes a hostile act against the oppressed people of South Africa and a contemptuous defiance of the United Nations and the international community,

"Considering that such collaboration strengthens the racist régime, encourages it to persist in its repressive and aggressive policy and seriously aggravates the situation in southern Africa, thus constituting a threat to international peace and security,

"Seriously concerned at the fact that the principal Western and other trading partners of South Africa are continuing to collaborate with the racist régime and that their collaboration constitutes the main obstacle to the abolition of that régime and the elimination of the inhuman and criminal system of apartheid.

"Alarmed by the persistent collaboration by certain Western States and Israel with the racist régime of South Africa in the nuclear field,

"Aware of the constant need to mobilize public opinion against any political, military, economic and other assistance granted to the racist régime of South Africa.

"Aware of the need to promote solutions to the problems of discrimination facing migrant workers and their families,

"Recalling its resolution 35/33 of 14 November 1980, in which it decided to hold in 1983 a second world conference to combat racism and racial discrimination, which, while reviewing and assessing the activities undertaken during the Decade, should have as its main purpose the formulation of ways and means and of specific measures aimed at ensuring the full and universal implementation of United Nations resolutions and decisions on racism, racial discrimination and apartheid,

"Stressing the importance of attaining the objectives of the Decade,

"Convinced that the Second World Conference to Combat Racism and Racial Discrimination will make a useful and constructive contribution to the attainment of those objectives,

"1. Proclaims that the elimination of all forms of racism and of discrimination based on race and the attainment of the objectives of the Programme for the Decade for Action to Combat Racism and Racial Discrimination and of the programme of activities to be undertaken during the second half of the Decade

are matters of high priority for the international community and, therefore, for the United Nations;

- "2. Strongly condemns the policies of apartheid, racism and racial discrimination pursued in southern Africa, all occupied Arab territories and elsewhere, in particular the denial of the right of peoples to self-determination and independence;
- "3. Reaffirms its strong support for the national liberation struggle against racism, racial discrimination, apartheid, colonialism and foreign domination and for self-determination by all available means, including armed struggle;
- "4. Reaffirms the inalienable rights of the Namibian people to self-determination and independence;
- "5. Vigorously condemns the repeated acts of aggression committed by South Africa against the States of the region, particularly Angola, Botswana, Mozambique, Seychelles and Zambia;
- "6. Expresses its profound solidarity with the front-line States which are victims of the racist aggression and destabilization attempts of the Pretoria régime;
- "7. Once again invites all Member States, United Nations organs, specialized agencies and other intergovernmental organizations, national liberation movements, anti-apartheid and anti-racist organizations and other solidarity groups to strengthen and enlarge the scope of their activities in support of the objectives of the Programme for the Decade;
- "8. Again requests the Security Council to consider, as a matter of urgency, the imposition of full mandatory sanctions under Chapter VII of the Charter of the United Nations against the racist régime of South Africa and the strengthening of the embargo on arms, with a view to putting an end to all military and nuclear collaboration with South Africa:
- "9. Reaffirms the decision approving the Declaration of the International Seminar on the Implementation and Reinforcement of the Arms Embargo against South Africa, 52 which was held in London from 1 to 3 April 1981 under the auspices of the Special Committee against Apartheid;
- "10. Vigorously condemns the collaboration of certain Western countries, Israel and other States and of transnational corporations and other organizations, which are maintaining or continuing to increase their collaboration with the racist régime of South Africa, particularly in the political, economic, military and nuclear fields, thereby encouraging that régime to persist in its inhuman and criminal policy of brutal oppression of the peoples of southern Africa and its denial of human rights;
- "11. Calls once again upon all Governments which have not yet done so to take legislative, administrative and other measures in respect of their nationals and the bodies corporate under their jurisdiction that own enterprises in southern Africa in order to put an end to such enterprises;
- "12. Calls upon all States to adopt, as a matter of high priority, measures declaring punishable by law any dissemination of ideas based on racial

superiority or hatred and outlawing organizations based on racial hatred and prejudice, including neo-Nazi and Fascist organizations and private clubs and institutions established on the basis of racial criteria or propagating ideas of racial discrimination and apartheid;

- "13. Invites Member States, the organs and bodies of the United Nations system and the specialized agencies to continue their efforts with a view to the protection of the rights of all migrant workers and their families;
- "14. Takes note with appreciation of the report of the Preparatory Sub-Committee for the Second World Conference to Combat Racism and Racial Discrimination on its first session;⁵³
- "15. Requests the Secretary-General to provide the Preparatory Sub-Committee with all necessary assistance:
- "16. Further requests the Secretary-General to appoint, after consultation with the regional groups, in 1982, a Secretary-General for the Second World Conference to Combat Racism and Racial Discrimination, who shall have the rank of Assistant Secretary-General and shall be responsible for the organization of the Conference and co-ordination with Member States, organs and bodies of the United Nations, specialized agencies and other intergovernmental organizations, as well as with non-governmental organizations;
- "17. Invites Member States to continue to cooperate with the Secretary-General as part of the Programme for the Decade and the preparations for the Conference;
- "18. *Invites* the appropriate organs and bodies of the United Nations system to contribute to the preparations for the Conference;
- "19. Expresses its satisfaction to the Committee on the Elimination of Racial Discrimination, the Special Committee against Apartheid, the United Nations Council for Namibia, the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples, the Committee on the Exercise of the Inalienable Rights of the Palestinian People and the Commission on Human Rights, through its Ad Hoc Working Group of Experts on Southern Africa, for their contribution to the implementation of the Programme for the Decade and invites them to include in their activities the preparations for the Conference;
- "20. Decides to consider at its thirty-eighth session, as a matter of high priority, the item entitled 'Implementation of the Programme for the Decade to Combat Racism and Racial Discrimination'."

24th plenary meeting 5 May 1982

1982/32. Second World Conference to Combat Racism and Racial Discrimination

The Economic and Social Council,

Recalling General Assembly resolutions 3057 (XXVIII) of 2 November 1973, 33/99 and 33/100 of 16

December 1978, 34/24 of 15 November 1979, 35/33 of 14 November 1980 and 36/8 of 28 October 1981, and its resolution 1990 (LX) of 11 May 1976,

Recalling also its decision 206 (ORG-77) of 14 January 1977, its resolution 2046 (S-III) of 23 February 1977 and its decision 1981/130 of 6 May 1981,

Having considered the report of the Preparatory Sub-Committee for the Second World Conference to Combat Racism and Racial Discrimination on its first session,⁵⁴

Noting with appreciation the offer of the Government of the Philippines to act as host to the Second World Conference to Combat Racism and Racial Discrimination.

Recognizing that the Philippines is one of the countries affected by the current world economic crisis and that, despite this, the Government of the Philippines is willing to make a substantial financial contribution towards the Conference.

- 1. Approves the draft provisional agenda and the draft provisional rules of procedure of the Second World Conference to Combat Racism and Racial Discrimination;⁵⁵
- 2. Recommends to the General Assembly that invitations to participate in the Conference should be extended to:
 - (a) All States;
- (b) The United Nations Council for Namibia, in accordance with General Assembly resolution 31/149 of 20 December 1976;
- 3. Recommends to the General Assembly that the following should be invited to participate in the Conference as observers:
- (a) Representatives of national liberation movements recognized in its region by the Organization of African Unity, in accordance with General Assembly resolution 3280 (XXIX) of 10 December 1974;
- (b) Representatives of organizations that have received a standing invitation from the General Assembly to participate in the sessions and the work of all international conferences convened under its auspices, in accordance with Assembly resolutions 3237 (XXIX) of 22 November 1974 and 31/152 of 20 December 1976;
- (c) The specialized agencies concerned, as well as interested organs and bodies of the United Nations;
 - (d) Interested intergovernmental organizations;
 - (e) The Special Committee against Apartheid;
- (f) The Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples;
- (g) The Committee on the Elimination of Racial Discrimination;
 - (h) The Commission on Human Rights;
- (i) The Committee on the Exercise of the Inalienable Rights of the Palestinian People and the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Population of the Occupied Territories;
- (j) Other interested committees of the United Nations;

- (k) Non-governmental organizations in consultative status with the Economic and Social Council which have contributed to the achievement of the goals and objectives of the Decade for Action to Combat Racism and Racial Discrimination and to the implementation of the Programme of Action adopted by the first World Conference to Combat Racism and Racial Discrimination, 56 taking into account also their record in the struggle against racism and racial discrimination;
- 4. Decides that the languages of the Conference shall be Arabic, Chinese, English, French, Russian and Spanish;
- 5. Decides that the documentation for the Conference shall include pre-session and in-session documents as indicated in paragraphs 63 to 78 of the report of the Preparatory Sub-Committee;⁵⁷
- 6. Decides to authorize the Preparatory Sub-Committee to hold a second session of one week in March 1983 and to submit its report to the Economic and Social Council at its first regular session of 1983;
- 7. Requests the Secretary-General to take appropriate steps as soon as possible to start the timely preparation of all the necessary documentation and to ensure that the documentation is available at least six weeks before the beginning of the Conference;
- 8. Requests the Secretary-General to submit to the Preparatory Sub-Committee for the Second World Conference to Combat Racism and Racial Discrimination a draft programme of action containing proposals for activities to be undertaken after the Conference as a follow-up to the programme of activities adopted for the second half of the Decade⁵⁸ and the Programme of Action adopted by the first World Conference, taking into account the above-mentioned documents and the relevant resolutions and decisions of the United Nations regarding racism, racial discrimination and apartheid, and invites the Preparatory Committee, on the basis of the Secretary-General's draft, to submit to the Conference, through the Economic and Social Council, a draft programme of action:
- 9. Also requests the Secretary-General to report to the Preparatory Sub-Committee at its second session on the status of the documentation;
- 10. Recommends that the offer of the Government of the Philippines to act as host to the Conference should be accepted and that the formula decided upon by the General Assembly in its resolution 31/78 of 13 December 1976 regarding the cost involved in holding the first World Conference should apply to that offer;
- 11. Requests the Secretary-General to consult with the Government of the Philippines concerning arrangements for holding the Conference at Manila;
- 12. Recommends that the duration of the Conference should be two weeks, from 1 to 12 August 1983, these dates being subject to adjustment contingent upon the consultations with the Secretary-General;
- 13. Recommends to the General Assembly the adoption of the following draft resolution:

"Recalling its resolution 3057 (XXVIII) of 2 November 1973, by which it proclaimed the Decade for Action to Combat Racism and Racial Discrimination.

"Bearing in mind its resolution 35/33 of 14 November 1980, by which it decided to hold in 1983, as an important event of the Decade, a second World Conference to Combat Racism and Racial Discrimination, which, while reviewing and assessing the activities undertaken during the Decade, should have as its main purpose the formulation of ways and means and of specific measures aimed at ensuring the full and universal implementation of United Nations resolutions and decisions on racism, racial discrimination and apartheid,

"Bearing in mind also the provisions of its resolution 36/8 of 28 October 1981 regarding the preparations for the Second World Conference to Combat Racism and Racial Discrimination,

"Taking note of Economic and Social Council resolution 1982/32 of 5 May 1982, containing recommendations regarding the organization of the Second World Conference to Combat Racism and Racial Discrimination,

- "1. Endorses Economic and Social Council resolution 1982/32;
- "2. Accepts the offer of the Government of the Philippines to act as host to the Second World Conference to Combat Racism and Racial Discrimination;
- "3. Decides to convene the Conference at Manila from 1 to 12 August 1983;
- "4. Decides to make an exception to its resolution 2609 (XXIV) of 16 December 1969 on the pattern of conferences and agrees that half of the additional cost involved in holding the Conference in the Philippines shall be defrayed from the regular budget of the United Nations;
- "5. Requests the Secretary-General to invite as participants in the Conference:

- "(i) The Committee on the Exercise of the Inalienable Rights of the Palestinian People and the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Population of the Occupied Territories;
- "(j) Other interested committees of the United Nations;
- "(k) Non-governmental organizations in consultative status with the Economic and Social Council which have contributed to the achievement of the goals and objectives of the Decade for Action to Combat Racism and Racial Discrimination and to the implementation of the Programme of Action adopted by the first World Conference, taking into account also their record in the struggle against racism and racial discrimination;
- "7. Requests the Secretary-General, as part of the preparatory process, to take adequate steps to ensure that maximum publicity is given to the Conference and, to that end, to allocate the necessary resources from the regular budget;
- "8. Calls upon all States to contribute to the success of the Decade for Action to Combat Racism and Racial Discrimination, in particular by their active participation in the Conference;
- "9. Urges all States to co-operate with the Secretary-General of the Conference in the preparatory work and to consider the establishment of national committees for publicizing the aims and, eventually, the main results of the Conference;
- '10. Requests the Secretary-General to report to the General Assembly at its thirty-eighth session on the work of the Conference;
- "11. Decides to consider at its thirty-eighth session, as a matter of high priority, an item entitled 'Second World Conference to Combat Racism and Racial Discrimination'.'

25th plenary meeting 5 May 1982 1982/33. Review of the composition, organization and administrative arrangements of the Sessional Working Group (of Governmental Experts) on the Implementation of the International Covenant on Economic, Social and Cultural Rights*

The Economic and Social Council,

Recalling its resolution 1988 (LX) of 11 May 1976, by which it noted the important responsibilities placed upon the Economic and Social Council by the International Covenant on Economic, Social and Cultural Rights, in particular those resulting from articles 21 and 22 of the Covenant, and expressed its readiness to fulfil those responsibilities,

Recalling its decision 1978/10 of 3 May 1978, by which it decided to establish a Sessional Working Group on the Implementation of the International Covenant on Economic, Social and Cultural Rights, for the purpose of assisting the Council in the consideration of reports submitted by States parties to the Covenant in accordance with Council resolution 1988 (LX), and determined the composition of the Working Group,

Recalling also its resolution 1979/43 of 11 May 1979, by which it approved the methods of work of the Sessional Working Group, and its decision 1981/158 of 8 May 1981, by which it incorporated certain changes in, and modified the methods of work of, the Sessional Working Group,

Recalling further its resolution 1980/24 of 2 May 1980, by which it noted that the Sessional Working Group, established in accordance with Council decision 1978/10, had encountered certain difficulties in discharging its responsibilities under the arrangements and requested the Secretary-General to solicit the views of members of the Council and all States parties to the Covenant on the future composition, organization and administrative arrangements of the Sessional Working Group and to submit a report thereon, together with any comments he might wish to make, to the Council at its organizational session for 1981, in order to assist the Council in reviewing its decision 1978/10.

Recalling its decision 1981/162 of 8 May 1981, by which it decided to review the composition, organization and administrative arrangements of the Sessional Working Group at its first regular session of 1982,

Having considered the report of the Sessional Working Group (of Governmental Experts) on the Implementation of the International Covenant on Economic, Social and Cultural Rights,59

Decides that:

- The Working Group established by Economic and Social Council decision 1978/10 and modified by Council decision 1981/158 shall be renamed "Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights" (hereinafter referred to as "the Group of Experts");
- The fifteen members of the Group of Experts shall be elected by the Economic and Social Council

from among the States parties to the International Covenant on Economic, Social and Cultural Rights, in accordance with the geographical distribution established by the Council in paragraph (a) of its decision 1978/10, under the following conditions:

- The members of the Group of Experts shall be elected for a term of three years and shall be eligible for re-election at the end of their terms;
- One third of the membership of the Group of Experts, comprising one member from each regional group, shall be renewed each year;
- The first elections shall take place during the (iii) resumed second regular session of 1982 of the Economic and Social Council and the confirmation of the experts designated by Member States to represent them in the Group of Experts shall take place at the organizational session for 1983 of the Council; immediately after the first elections, the President of the Council shall choose by lot the name of one member from each regional group whose term shall expire at the end of one year and the name of another member from each regional group whose term shall expire at the end of two years;
- The terms of office of members elected to the Group of Experts shall begin on 1 January following their election and shall expire on 31 December following the election of members that are to succeed them as members of the Group of Experts;
- (v) Subsequent elections shall take place each year during the first regular session of the Council:
- Each Member State elected to the Group of Experts shall designate, in consultation with the Secretary-General and subject to confirmation by the Council, a qualified person to represent that Member State in the Group of Experts:
- (vii) The person so designated by his or her Government shall be an expert with recognized competence in the field of human rights;
- The Group of Experts shall meet annually for a period of three weeks, beginning two weeks before the first regular session of the Council; the duration of each session may be extended by the Council at its organizational session, if required, taking into account the number of reports to be examined by the Group of Experts in the course of its following session;
- At the end of each of its sessions, the Group of Experts shall submit to the Economic and Social Council a report on its activities and shall make suggestions and recommendations of a general nature based on its consideration of reports submitted by States parties to the Covenant and by the specialized agencies, in order to assist the Council to fulfil, in particular, its responsibilities under articles 21 and 22 of the Covenant;
- The Secretary-General shall provide the Group of Experts with summary records of its proceedings; those summary records shall be made available to the Council at the same time as the report of the Group of Experts; the Secretary-General shall also

provide the Group of Experts with appropriate conference facilities:

- (f) The Economic and Social Council shall review the composition, organization and administrative arrangements of the Group of Experts at its first regular session of 1985, and subsequently every three years, taking into account the principle of equitable geographical distribution and the increase in the number of States parties to the Covenant;
- (g) The procedures and methods of work established by the resolutions and decisions referred to in the preamble to the present resolution shall remain in force in so far as they are not modified by the present resolution.

27th plenary meeting 6 May 1982

1982/34. Study of the problem of discrimination against indigenous populations

The Economic and Social Council,

Recalling its resolution 1589 (L) of 21 May 1971, resolutions 22 (XXXVII) of 10 March 198160 and 1982/19 of 10 March 198261 of the Commission on Human Rights and resolutions 8 (XXIV) of 18 August 1971,62 5 (XXXIII) of 10 September 198063 and 2 (XXXIV) of 8 September 198164 of the Sub-Commission on Prevention of Discrimination and Protection of Minorities,

Recognizing the urgent need to promote and to protect the human rights and fundamental freedoms of indigenous populations,

Bearing in mind the concerns expressed in this regard at the World Conference to Combat Racism and Racial Discrimination in 1978,65

Believing that special attention should be given to appropriate avenues of recourse at the national, regional and international levels in order to advance the promotion and protection of the human rights and fundamental freedoms of indigenous populations,

Mindful of the conclusions of the Sub-Commission on Prevention of Discrimination and Protection of Minorities and of the Commission on Human Rights that the plight of indigenous peoples is of a serious and pressing nature and that special measures are urgently needed to promote and protect the human rights and fundamental freedoms of indigenous populations,

Authorizes the Sub-Commission on Prevention of Discrimination and Protection of Minorities to establish annually a working group on indigenous populations which shall meet for up to five working days before the annual sessions of the Sub-Commission in order to review developments pertaining to the promotion and protection of the human rights and funda-

mental freedoms of indigenous populations, including information requested by the Secretary-General annually from Governments, specialized agencies, regional intergovernmental organizations and nongovernmental organizations in consultative status, particularly those of indigenous peoples, to analyse such materials, and to submit its conclusions to the Sub-Commission bearing in mind the report of the Special Rapporteur of the Sub-Commission;66

- 2. Decides that the Working Group shall give special attention to the evolution of standards concerning the rights of indigenous populations, taking account of both the similarities and the differences in the situations and aspirations of indigenous populations throughout the world;
- 3. Requests the Secretary-General to assist the working group on indigenous populations and make all necessary arrangements to enable it to carry out its functions.

28th plenary meeting 7 May 1982

1982/35. Summary or arbitrary executions

The Economic and Social Council,

Recalling the Universal Declaration of Human Rights, 67 which guarantees the right to life, liberty and security of person,

Having regard to the provisions of the International Covenant on Civil and Political Rights, 68 in which it is stated that every human being has the inherent right to life, that this right shall be protected by law and that no one shall be arbitrarily deprived of his life,

Recalling General Assembly resolution 34/175 of 17 December 1979, in which the Assembly reaffirmed that mass and flagrant violations of human rights are of special concern to the United Nations and urged the Commission on Human Rights to take timely and effective action in existing and future cases of mass and flagrant violations of human rights,

Further recalling resolution 8 (XXIII) of 16 March 1967 of the Commission on Human Rights⁶⁹ concerning the question of violations of human rights and fundamental freedoms in any part of the world,

Mindful of General Assembly resolution 36/22 of 9 November 1981, in which the Assembly condemned the practice of summary executions and arbitrary executions,

Bearing in mind resolution 5, on extra-legal executions, of the Sixth United Nations Congress on the Prevention of Crime and the Treatment of Offenders, 70

Deeply alarmed about the occurrence of summary or arbitrary executions, including extra-legal executions, that are widely regarded as being politically motivated,

Convinced of the need to deal urgently with the question of summary or arbitrary executions,

- 1. Strongly deplores the increasing number of summary or arbitrary executions taking place in various parts of the world;
- 2. Decides, therefore, to appoint for one year a special rapporteur to examine the questions related to summary or arbitrary executions;
- 3. Requests the Chairman of the Commission on Human Rights, after consultations within the Bureau, to appoint an individual of recognized international standing as special rapporteur;
- 4. Considers that the special rapporteur in carrying out his mandate may seek and receive information from Governments, specialized agencies and other intergovernmental organizations, as well as non-governmental organizations in consultative status with the Economic and Social Council;
- 5. Requests the special rapporteur to submit a comprehensive report to the Commission on Human Rights at its thirty-ninth session on the occurrence and extent of the practice of such executions, together with his conclusions and recommendations;
- 6. Urges all Governments to co-operate with and assist the special rapporteur in the preparation of his report;
- 7. Requests the Secretary-General to provide all necessary assistance to the special rapporteur;
- 8. Requests the Commission on Human Rights to consider the question of summary or arbitrary executions as a matter of high priority at its thirty-ninth session under the agenda item entitled "Question of the violation of human rights and fundamental freedoms in any part of the world, with particular reference to colonial and other dependent countries and territories".

28th plenary meeting 7 May 1982

1982/36. Situation of human rights in Equatorial Guinea

The Economic and Social Council,

Recalling its resolution 1981/38 of 8 May 1981 and its decision 1981/167 of 16 July 1981,

Bearing in mind resolution 1982/34 of 11 March 1982 of the Commission on Human rights,⁷¹

Mindful of the role that the United Nations could play in the promotion, the protection and the restoration of human rights and fundamental freedoms in the world,

Conscious of the request of the Government of Equatorial Guinea for assistance in the restoration of human rights and fundamental freedoms in that country with a view to ensuring, in particular, the right of the population to participate in the management of public affairs in the country,

1. Takes note of the plan of action proposed by the Secretary-General⁷² on the basis of recom-

- 3. Requests the Secretary-General, with expert assistance if necessary, to discuss the Government of Equatorial Guinea the role that the United Nations could play in the implementation of the plan of action;
- 4. *Invites* the Government of Equatorial Guinea to co-operate with the Secretary-General in this respect;

- 1. Authorizes a meeting of an open-ended working group for a period of one week prior to the thirty-ninth session of the Commission on Human Rights to facilitate the completion of the work on a draft convention on the rights of the child;
- 2. Requests the Secretary-General to transmit to the Commission on Human Rights at its thirty-ninth session all relevant material relating to the draft convention on the rights of the child.

28th plenary meeting 7 May 1982 1982/38. Question of the human rights of all persons subjected to any form of detention or imprisonment, in particular torture and other cruel, inhuman or degrading treatment or punishment

The Economic and Social Council,

Recalling General Assembly resolution 36/60 of 25 November 1981, by which the Commission on Human Rights was requested to complete as a matter of highest priority, at its thirty-eighth session, the drafting of a convention against torture and other cruel, inhuman or degrading treatment or punishment, and Economic and Social Council resolution 1981/37 of 8 May 1981 by which the Council authorized a meeting of an openended working group for a period of one week prior to the thirty-eighth session of the Commission on Human Rights to complete the work on a draft convention against torture and other cruel, inhuman or degrading treatment or punishment,

Considering that it was not found possible to complete the work on the draft convention during the thirty-eighth session of the Commission on Human Rights,

Taking note of resolution 1982/44 of 11 March 1982 of the Commission on Human Rights, 76

- 1. Authorizes a meeting of an open-ended working group for a period of one week prior to the thirty-ninth session of the Commission on Human Rights to complete the work on a draft convention against torture and other cruel, inhuman or degrading treatment or punishment;
- 2. Requests the Secretary-General to transmit to the Commission on Human Rights at its thirty-ninth session all relevant material relating to the draft convention.

28th plenary meeting 7 May 1982

1982/39. Protection of the rights of children and parents in cases of removal or retention of children

The Economic and Social Council,

Bearing in mind the Declaration of the Rights of the Child proclaimed by the General Assembly in its resolution 1386 (XIV) of 20 November 1959,

Recalling that, under the terms of principle 2 of that Declaration, the child shall enjoy special protection, and shall be given opportunities and facilities, by law and by other means, to enable him to develop physically, mentally, morally, spirtually and socially in a healthy and normal manner and in conditions of freedom and dignity,

Concerned about the proliferation of conflicts between couples of different nationalities and at the consequences which result therefrom for children, concerned particularly by their removal from the country of one spouse to the country of the other without the consent of one of the two spouses, and without or in violation of a judicial or administrative decision, and, lastly, concerned about the cases of child retention in which such situations sometimes end,

Noting the existence of a common interest in the elaboration of a full and detailed international convention on the rights of the child, as already evinced by the representatives of many countries and international organizations,

Recalling that the universally acknowledged standards and principles in the field of human rights impose on States the obligation to protect all individuals under their jurisdiction from infringements of their freedom and dignity by any private person,

- 1. Calls the attention of States to the proliferation of cases of removal and retention of children and invites them to co-operate actively with a view to preventing the occurrence of such cases and to solving them speedily, out of concern for the interest of the child:
- 2. Invites States to organize such co-operation through the conclusion of bilateral arrangements or through accession to regional conventions or international conventions such as the Hague Convention on the Civil Aspects of International Child Abduction of 25 October 1980, which is open to all States;
- 3. Invites the Commission on Human Rights, when drafting the convention on the rights of the child, to take into consideration the protection of the rights of the child in cases of unauthorized international removal:
- 4. Requests the Secretary-General to consult with Governments on this problem and to report to the Commission on Human Rights at its thirty-ninth session under the agenda item entitled "Question of a convention on the rights of the child".

28th plenary meeting 7 May 1982

1982/40. Report of the Ad Hoc Working Group of Experts of the Commission on Human Rights on allegations of infringements of trade union rights in the Republic of South Africa

The Economic and Social Council,

Recalling its resolution 1981/41 of 8 May 1981,

Recalling its decision 1981/155 of 8 May 1981, by which it transmitted to the Ad Hoc Working Group of Experts of the Commission on Human Rights, for consideration, the allegations regarding infringements of trade union rights in South Africa submitted by the International Confederation of Free Trade Unions,

Having examined the reports of the Ad Hoc Working Group of Experts, 77

Noting that the Government of South Africa continues to violate, by its legislation, international standards concerning trade union rights,

Noting further with grave concern that police and State interference in industrial disputes and repression against the independent black trade union movement has persisted,

- 1. Takes note of the report of the Ad Hoc Working Group of Experts prepared in accordance with Council resolution 1981/41;⁷⁸
- 2. Takes note with appreciation of the report of the Ad Hoc Working Group of Experts prepared in accordance with Council decision 1981/155,79 and of the conclusions contained therein;
- 3. Demands the immediate recognition of the unimpeded exercise of freedom of association and trade union rights by the entire population of South Africa, without discrimination of any kind;
- 4. Calls once again for the immediate release of all the imprisoned trade unionists and the lifting of all banning orders imposed on persons engaged in trade union activities:
- 5. Demands the lifting of the ban on fund-raising drives by the Federation of South African Trade Unions;
- 6. Reiterates its demand for the cessation of all government and police interference in labour disputes;
- 7. Requests the Ad Hoc Working Group of Experts to continue to study the situation and to report thereon to the Commission on Human Rights and the Council, as appropriate;
- 8. Also requests the Ad Hoc Working Group of Experts, in the discharge of its mandate, to consult with the International Labour Organisation and the Special Committee against Apartheid, as well as with international and African trade union confederations;
- 9. Decides to consider at its first regular session of 1983 the question of allegations of infringements of trade union rights in South Africa as a subitem under the item entitled "Human rights questions".

"Noting that the composition of the Executive Board was last considered by the General Assembly at its eleventh session, when the Assembly adopted resolution 1038 (XI) of 7 December 1956, replacing paragraph 6 (a) of resolution 417 (V),

- "1. Decides, without prejudice to arrangements which may be made in other bodies, to enlarge the membership of the Executive Board of the United Nations Children's Fund to forty-one members, to be elected from States Members of the United Nations or members of specialized agencies or of the International Atomic Energy Agency, subject to the following conditions:
 - "(a) Nine seats for African States;
 - "(b) Nine seats for Asian States;
 - "(c) Four seats for Eastern European States;
 - "(d) Six seats for Latin American States;
- "(e) Twelve seats for Western European and other States;
- "(f) One seat to be rotated among the five regional groups, in the following order:
 - "(i) African States;
 - "(ii) Latin American States;
 - "(iii) Asian States;
 - "(iv) Western European and other States;
 - "(v) Eastern European States;
- "(g) Without prejudice to the terms of the States already elected, elections to these forty-one seats shall be for a term of three years and retiring members shall be eligible for re-election;
- "2. Requests the Economic and Social Council to elect, at its first regular session of 1982, the additional eleven members of the Executive Board."

1982/112. Rules of procedure of the Committee for the United Nations Population Award

At its 15th plenary meeting, on 26 April 1982, the Council, pursuant to General Assembly resolution 36/201 of 17 December 1981, approved the rules of procedure of the Committee for the United Nations Population Award set out below:

Rules of procedure of the Committee for the United Nations Population Award

MEETINGS

Rule 1

- 1. The Committee shall hold a regular meeting in February of each year, to select the laureate or laureates of the year.
- 2. Special meetings may be convened with the agreement of six voting members of the Committee.
 - 3. All meetings shall take place at United Nations Headquarters.

CHAIRMAN

Rule 2

- 1. The Committee shall elect a Chairman at each regular meeting, who shall serve until a successor is elected at the following regular meeting. The Chairman shall be eligible for re-election.
- 2. In the absence of the Chairman, the Secretary-General or his representative shall act as Chairman.

SELECTION OF HONORARY MEMBERS

Rule 3

- 1. Honorary members may be selected at any meeting of the Committee, whenever there is a vacancy or in anticipation of a vacancy during the following twelve months.
- 2. Honorary members selected to fill an unexpired term shall serve for the balance of that term.

Ex officio MEMBERS

Rule 4

The exofficio members may, if necessary, act in the Committee through representatives.

OUORUM

Rule 5

Representatives of six of the ten members of the Committee elected by the Economic and Social Council shall constitute a quorum.

DECISIONS

Rule 6

- 1. Unless otherwise provided, decisions shall be made by a majority of the elected and ex officio members present and voting.
 - 2. Decisions under rule 3 or rule 7 shall be made by secret ballot.
- 3. When one or more candidates are to be selected under rule 3 or rule 7, each voting member of the Committee may vote for as many candidates as there are places to be filled, and those candidates, in a number not exceeding the number of such places, obtaining in the first ballot a majority of the votes cast and the largest number of votes shall be considered selected.
- 4. If the number of candidates selected under paragraph 3 above is less than the number of places to be filled, additional ballots shall be held on a basis similar to the first one, to fill the remaining places, provided that once one or more individual candidates have been selected pursuant to rule 7, paragraph 2, the Committee may decide not to select additional ones up to the maximum originally decided. From such additional ballots the candidate obtaining the least number of votes, or on the proposal of the Chairman several candidates having received few votes, shall be eliminated.
- 5. If any ballot results in a tie vote among all candidates, it shall be repeated; if the tie persists for two such repeated ballots, the Chairman shall select a successful candidate by drawing lots.

SELECTION OF LAUREATES

Rule 7

- 1. The Secretary of the Committee shall present to the Committee at the regular meeting all the nominations received during the previous year for laureates eligible for the United Nations Population Award.
- 2. The Committee shall decide to make the Award either to an institution or to an individual or individuals; unless it decides otherwise, no more than two individuals shall be selected.

PRIVACY OF MEETINGS AND REPORTS

Rule 8

- 1. The meetings of the Committee shall be closed.
- 2. The proceedings of the Committee shall be reflected in a report to be submitted to the Secretary-General after each regular meeting, which report shall be attached to the annual report to be submitted to the General Assembly by the Executive Director of the United Nations Fund for Population Activities.

RULES OF PROCEDURE

Rule 9

- 1. Any of these rules may be suspended by a decision of two thirds of the elected and ex officio members present and voting, provided that such decision is not inconsistent with General Assembly resolution 36/201 or any other decision of the Assembly.
- 2. Any procedural matter not covered by these rules shall be settled in accordance with the rules applicable to committees of the Economic and Social Council.

1982/127. Question of the violation of human rights in the occupied Arab territories, including Palestine

At its 28th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/1 A of 11 February 1982 of the Commission on Human Rights, ¹⁰⁶ endorsed the Commission's decision that a seminar on violations of human rights in the Palestinian and other Arab territories occupied by Israel should be held at the United Nations Office at Geneva and requested the Secretary-General to make the appropriate arrangements for the organization of the seminar and to report to the Commission on Human Rights at its thirty-ninth session.

1982/128. Adverse consequences for the enjoyment of human rights of political, military, economic and other forms of assistance given to the colonial and racist régime in South Africa

At its 28th plenary meeting, on 7 May 1982, the Council took note of resolution 1982/12 of 25 February 1982 of the Commission on Human Rights, 106 and approved the decision of the Sub-Commission on Prevention of Discrimination and Protection of Minorities to give a mandate to Mr. Ahmed Khalifa, Special Rapporteur, to continue to update the list of banks, transnational corporations and other organizations giving assistance to the racist and colonial régimes of southern Africa and to submit the revised report to the Commission through the Sub-Commission.

1982/129. Question of slavery and the slave trade in all their practices and manifestations, including the slavery-like practices of apartheid and colonialism

At its 28th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/20 of 10 March 1982 of the Commission on Human Rights, ¹⁰⁶ endorsed the Commission's decision, pursuant to an invitation by the Government of Mauritania, to authorize the Sub-Commission on Prevention of Discrimination and Protection of Minorities to send a delegation not exceeding two persons, to be appointed by the Chairman of the Sub-Commission in consultation with the Government of Mauritania, to visit Mauritania in order to study the situation and ascertain the country's needs with regard to the question of slavery and the slave trade.

1982/130. Exploitation of child labour

At its 28th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/21 of 10 March 1982 of the Commission on Human Rights, ¹⁰⁶ endorsed the Commission's recommendation that the study prepared by Mr. Abdelwahab Bouhdiba on the exploitation of child labour¹⁰⁷ should be printed and given the

widest possible distribution, including distribution in Arabic.

1982/131. Question of the human rights of all persons subjected to any form of detention or imprisonment, in particular the question of missing and disappeared persons

At its 28th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/24 of 10 March 1982 of the Commission on Human Rights, ¹⁰⁶ approved the Commission's decision to extend for one year the term of the mandate of the Working Group on Enforced or Involuntary Disappearances, as laid down in Commission resolution 20 (XXXVI) of 29 February 1980, ¹⁰⁸ and requested the Secretary-General to continue to provide the Working Group with all necessary assistance, in particular the staff and resources it required to perform its functions in an effective and expeditious manner, and if necessary to make arrangements to ensure the continuity of the Secretariat's work.

1982/132. Question of human rights in Chile

At its 28th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/25 of 10 March 1982 of the Commission on Human Rights, ¹⁰⁶ approved the Commission's decision to extend for one year the mandate of the Special Rapporteur on the situation of human rights in Chile and requested the Secretary-General to make arrangements for the provision of adequate financial resources and staff for the implementation of that resolution.

1982/133. Situation of human rights and fundamental freedoms in Poland

At its 28th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/26 of 10 March 1982 of the Commission on Human Rights, ¹⁰⁶ approved the Commission's decision to request the Secretary-General or a person designated by him to undertake a thorough study of the human rights situation in Poland.

1982/134. Situation of human rights in El Salvador

At its 29th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/28 of 11 March 1982 of the Commission on Human Rights, ¹⁰⁶ approved the Commission's decision to extend for another year the mandate of the Special Representative on the situation of human rights in El Salvador and the Commission's request to the Special Representative to submit his report on further developments in the situation of human rights in El Salvador to the General Assembly at its thirty-seventh session and to the Commission on Human Rights at its thirty-ninth session.

1982/135. Situation of human rights in Guatemala

At its 29th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/31 of 11 March 1982 of the Commission on Human Rights, 106 approved the Commission's request to its Chairman to appoint, after consultation within the Bureau, a special rapporteur of the Commission whose mandate would be to make a thorough study of the human rights situation in Guatemala, based on all information which he might deem relevant, including any comments and information which the Government of Guatemala might wish to submit, to be presented to the Commission at its thirty-ninth session. The Council requested the Secretary-General to give all necessary assistance to the special rapporteur of the Commission.

1982/136. Human rights and mass exoduses

At its 29th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/32 of 11 May 1982 of the Commission on Human Rights, 106 approved the Commission's request to the Special Rapporteur, in order to facilitate consideration by the General Assembly of his study on human rights and massive exoduses, 109 to explore further with interested Governments, the Secretary-General, United Nations bodies and the specialized agencies, and other organizations, intergovernmental and non-governmental, the study and the recommendations contained therein, to convey their observations together with his comments to the General Assembly in the course of introducing his study, and to remain available for consultations with the Group of Governmental Experts on International Co-operation to Avert New Flows of Refugees as required.

1982/137. Situation of human rights in Bolivia

At its 29th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/33 of 11 March 1982 of the Commission on Human Rights, ¹⁰⁶ approved the Commission's decision to extend for another year the mandate of the Special Envoy appointed to carry out a thorough study of the human rights situation in Bolivia and requested the Secretary-General to give all necessary assistance to the Special Envoy.

1982/138. Further promotion and encouragement of human rights and fundamental freedoms, including the question of the programme and methods of work of the Commission on Human Rights; alternative approaches and ways and means within the United Nations system for improving the effective enjoyment of human rights and fundamental freedoms

At its 29th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/41 of 11 March 1982 of the Commission on Human Rights, ¹⁰⁶ endorsed the Commission's request to the Secretary-General,

within the world-wide programme for the dissemination of basic international instruments on human rights, to disseminate widely, as a matter of priority and in as many languages as possible, the Declaration on the Elimination of All Forms of Intolerance and of Discrimination Based on Religion or Belief.¹¹⁰ The Council also endorsed the Commission's request to the Secretary-General to issue, as soon as possible, a pamphlet containing the text of the Declaration, together with relevant articles of the Universal Declaration of Human Rights¹¹¹ and the International Covenant on Civil and Political Rights,¹¹² in the six official languages of the United Nations, and to give the widest dissemination to the pamphlet.

1982/139. Advisory services in the field of human rights: assistance to Uganda

At its 29th plenary meeting, on 7 May 1982, the Council approved the decision taken by the Commission on Human Rights, in its resolution 1982/37 of 11 March 1982, 106 to request the Secretary-General, in response to the interest expressed by the Government of Uganda, to provide consultative advisory services and other forms of appropriate assistance to help the Government of Uganda to take measures to continue guaranteeing the enjoyment of human rights and fundamental freedoms, paying particular attention to the following areas: (a) the need for appropriate assistance to restore a law library for the High Court and Ministry of Justice; (b) the need for a qualified and experienced expert to serve as Commissioner for the revision of Ugandan laws in conformity with recognized norms of human rights and fundamental freedoms, and the printing of consolidated volumes of the revised laws; (c) the need for the training of prison officers with a view to securing the application of recognized norms of treatment of prisoners; and (d) the need for the training of police officials, particularly investigative and scientific experts.

1982/140. General decision concerning the establishment of a working group of the Commission on Human Rights to examine situations referred to the Commission under Economic and Social Council resolution 1503 (XLVIII) and those situations of which the Commission is seized

At its 29th plenary meeting, on 7 May 1982, the Council approved the decision taken by the Commission on Human Rights, in its decision 1982/103 of 5 March 1982, 106 to set up a working group composed of five of its members to meet for one week prior to the thirty-ninth session of the Commission to examine such particular situations as might be referred to the Commission by the Sub-Commission on Prevention of Discrimination and Protection of Minorities at its thirty-fifth session under Economic and Social Council resolution 1503 (XLVIII) of 27 May 1970 and those situations which the Commission had decided to keep under review.

1982/141. Question of the realization in all countries of the economic, social and cultural rights contained in the Universal Declaration of Human Rights and in the International Covenant on Economic, Social and Cultural Rights, and study of special problems which the developing countries face in their efforts to achieve these human rights

At its 29th plenary meeting, on 7 May 1982, the Council, noting resolution 1982/17 of 9 March 1982 of the Commission on Human Rights: 106

- (a) Approved the Commission's request to the Working Group of Governmental Experts on the Right to Development to hold two meetings of two weeks each at Geneva, the first in June/July 1982 and the second in September/October 1982;
- (b) Decided that the members of the Working Group of Governmental Experts should continue to be paid travel expenses and subsistence allowances relating to sessions of the Working Group by the United Nations, in conformity with the implementation of Council decision 1981/149 of 8 May 1981;
- (c) Further decided that that should not constitute a precedent for other similar bodies and that the present decision should be brought to the attention of the General Assembly at its thirty-seventh session.

1982/142. Report of the Commission on Human Rights

At its 29th plenary meeting, on 7 May 1982, the Council took note of the report of the Commission on Human Rights on its thirty-eighth session.¹¹³

1982/143. The right of peoples to self-determination and its application to peoples under colonial or alien domination or foreign occupation

At its 29th plenary meeting, on 7 May 1982, the Council endorsed resolution 1982/13 of 25 February 1982 of the Commission on Human Rights, 106 in which the Commission, inter alia, reaffirmed that the primary violation of human rights in Kampuchea at present was the persistence of foreign occupation, which prevented the people of Kampuchea from exercising their right to self-determination. The Council reaffirmed its decision 1981/154 of 8 May 1981, and endorsed the call for the withdrawal of all foreign forces from Kampuchea, as contained in the Declaration on Kampuchea adopted by the International Conference on Kampuchea on 17 July 1981,114 in order to allow the people of Kampuchea to exercise their fundamental freedoms and human rights, including the right to decide their own future through free and fair elections under United Nations supervision, without outside interference, subversion or coercion. The Council expressed its grave concern over the continuing activities of the foreign forces in Kampuchea, resulting in the loss of life and property of Kampucheans and forcing large

numbers of Kampuchean civilians to flee their homes. The Council welcomed the continuing efforts of the Secretary-General aimed at achieving a peaceful solution to the situation in South-East Asia and endorsed the Commission's call to all parties concerned to join in the efforts to seek a comprehensive solution to the Kampuchean problems within the framework of the Declaration on Kampuchea of 17 July 1981, which was endorsed by the General Assembly in its resolution 36/5 of 21 October 1981, and to co-operate in the work of the Ad Hoc Committee of the International Conference on Kampuchea. The Council noted with appreciation the recent visit to the area by the Special Representative of the Secretary-General.

1982/144. Report of the Panel of the Fact-Finding and Conciliation Commission on Freedom of Association appointed by the Governing Body of the International Labour Office to examine the complaints of alleged infringements of trade union rights in the United States/Puerto Rico

At its 29th plenary meeting, on 7 May 1982, the Council, recalling its resolution 277 (X) of 17 February 1950 and its decision 1978/41 of 21 July 1978, took note of the report of the Panel of the Fact-Finding and Conciliation Commission on Freedom of Association appointed by the Governing Body of the International Labour Office, 115 which concluded that the allegations of infringements of trade union rights made by the complainant were without foundation.

1982/145. Scheduling of the annual session of the Commission on Human Rights

At its 29th plenary meeting, on 7 May 1982, the Council, taking note of resolution 1982/40 of 11 March 1982 of the Commission on Human Rights, 106 in which, *inter alia*, the Commission recommended to the Economic and Social Council that it should consider the possibility of rescheduling the annual session of the Commission on Human Rights and, if necessary, of the Sub-Commission on Prevention of Discrimination and Protection of Minorities, with a view to enabling the Commission to meet later in the year, decided to consider the matter at its second regular session of 1982.

1982/146. Report of the Secretary-General on measures to be taken against Nazi, Fascist and neo-Fascist activities and all other forms of totalitarian ideologies and practices based on racial intolerance, hatred and terror

At its 29th plenary meeting, on 7 May 1982, the Council took note of the report of the Secretary-General on measures to be taken against Nazi, Fascist and neo-Fascist activities and all other forms of totalitarian ideologies and practices based on racial intolerance, hatred and terror¹¹⁶ and decided to transmit it to the General Assembly.

At its 29th plenary meeting, on 7 May 1982, the Council approved the draft provisional agenda for its second regular session of 1982¹¹⁷ and the proposed organization of work for that session.¹¹⁸
