The resolutions and decisions of the Economic and Social Council are identified as follows:

Resolutions

Until 1977 (up to and including the resumed sixty-third session), the resolutions of the Economic and Social Council were numbered consecutively and were identified by an arabic numeral followed by an indication of the session in parentheses (for example: resolution 1733 (LIV), resolution 1915 (ORG-75), resolution 2046 (S-III), adopted at the fifty-fourth session, the organizational session for 1975 and the third special session, respectively). When several resolutions were adopted under the same number, each of them was identified by a capital letter (for example: resolution 1926 B (LVIII), resolutions 1954 A to D (LIX)). The last resolution so numbered is resolution 2130 (LXIII), of 14 December 1977.

Since 1978, as part of the new system adopted for symbols of Council documents, the resolutions have been numbered on a yearly basis and identified by two arabic numerals separated by an oblique stroke, the first numeral indicating the year, the second the number of the resolution in the annual series (for example: resolution 1978/36).

Decisions

Until 1973 (up to and including the resumed fifty-fifth session), the decisions of the Council were not numbered. From 1974 to 1977 (up to and including the resumed sixty-third session), the decisions were numbered consecutively and were identified by an

arabic numeral followed by an indication of the session in parentheses (for example: decision 64 (ORG-75), decision 78 (LVIII), adopted at the organizational session for 1975 and the fifty-eighth session, respectively). The last decision so numbered is decision 293 (LXIII), of 2 December 1977.

Since 1978, as part of the new system adopted for symbols of Council documents, the decisions have been numbered on a yearly basis and identified by two arabic numerals separated by an oblique stroke, the first numeral indicating the year, the second the number of the decision in the annual series (for example: decision 1978/41).

In 1984, the resolutions and decisions adopted by the Council are being published in two supplements to the Official Records of the Economic and Social Council, 1984, as follows:

Supplement No. 1 (organizational session for 1984 and first regular session of 1984);

Supplement No. 1A (second regular session of 1984).

On 10 November 1982 (57th plenary meeting), the Council decided to discontinue the practice of holding resumed second regular sessions as from 1983 (decision 1982/189)

RESOLUTIONS

ORGANIZATIONAL SESSION FOR 1984

1984/1. Review of the functioning of the Joint Meetings of the Committee for Programme and Coordination and the Administrative Committee on Co-ordination

The Economic and Social Council,

Recalling its decision 1983/173 of 28 July 1983, by which it decided to review, at its organizational session for 1984, the functioning of the Joint Meetings of the Committee for Programme and Co-ordination and the Administrative Committee on Co-ordination,

Having considered the comments made in this regard by the Committee for Programme and Coordination and the Administrative Committee on Coordination,¹

Having considered also, in accordance with the request made by the General Assembly in its resolution 38/227 B of 20 December 1983, the question of and application of paragraph 12 of General Assembly resolution 31/93 of 14 December 1976,

1. Decides that the Joint Meetings of the Committee for Programme and Co-ordination and the

Administrative Committee on Co-ordination shall be held at Geneva on 2 and 3 July 1984;

- 2. Decides also to review at its organizational session for 1985 the functioning of the Joint Meetings;
- 3. Recommends the Committee for Programme and Co-ordination and the Administrative Committee on Co-ordination to discuss at their next Joint Meetings the topic of the implementation of the International Development Strategy for the Third United Nations Development Decade with system-wide implications, and with special emphasis on Africa, by the organs, organizations and bodies of the United Nations system;
- 4. Endorses the conclusions and recommendations of the Committee for Programme and Co-ordination,² as approved by the General Assembly in its resolution 38/227 B;
- 5. Decides to recommend to the General Assembly the continuation of the current application of paragraph 12 of Assembly resolution 31/93.

2nd plenary meeting 10 February 1984

FIRST REGULAR SESSION OF 1984

1984/2. Scheduling of the sessions of the Human Rights Committee established under the International Covenant on Civil and Political Rights

The Economic and Social Council,

Recalling paragraph 5 (g) of its decision 1984/101 of 10 February 1984,

Having heard the statement made by the President of the Economic and Social Council on 4 May 1984 regarding the outcome of his consultations with the Chairman of the Human Rights Committee on the question of the scheduling of the sessions of that Committee,³ and the views expressed by delegations on the matter,⁴

Decides to request the President of the Economic and Social Council to continue further his consultations with the Chairman of the Human Rights Committee and to report thereon to the Council at its organizational session for 1985.

9th plenary meeting 8 May 1984

1984/3. Measures to be taken following the cyclones and floods in Madagascar

The Economic and Social Council,

Having heard the statements made by the observer for Madagascar⁵ and the representative of the Office of the United Nations Disaster Relief Co-ordinator⁵ concerning the four tropical cyclones and the floods which severely affected all parts of Madagascar in December 1983 and January and April 1984,

Recognizing that these climatic phenomena have resulted in loss of life and the destruction of several towns and have inflicted serious damage on the economic and social infrastructures and on the agricultural, stock-farming and agro-industrial sectors,

Taking into account the fact that those sectors are of fundamental importance to the economy of the country,

Recalling the resolutions of the General Assembly and the Economic and Social Council on assistance

in cases of natural disaster, in which appeals have been made to the international community to give special attention to these phenomena,

Taking into account the fact that the provision of assistance to countries stricken by natural disasters is an expression of the international solidarity proclaimed in the Charter of the United Nations,

Noting the efforts made by the Government of Madagascar to relieve the suffering of the victims of the cyclones and floods,

Noting with satisfaction the emergency assistance provided by a number of States, international and regional organizations, specialized agencies and voluntary agencies,

- 1. Expresses its profound sympathy with the people and Government of Madagascar for the loss of life and the serious damage which the recent cyclones and floods have inflicted on the economy of the country;
- 2. Urges all States to participate or to continue to participate in relief operations and in the implementation of programmes for the rehabilitation and reconstruction of the areas affected by the cyclones and floods:
- 3. Requests international and regional organizations, specialized agencies and voluntary agencies, particularly those most directly concerned, to lend their support, within the framework of their respective programmes, to the efforts of the Secretary-General and the United Nations Disaster Relief Co-ordinator to mobilize relief and assistance, and also to consider urgently the requests for assistance made by the Government of Madagascar during the phase of rehabilitation and reconstruction;
- 4. Expresses the hope that the United Nations Development Programme, the World Bank and all other international and regional financial institutions concerned will give sympathetic and urgent consideration to requests for assistance which the Government of Madagascar may submit under its rehabilitation, reconstruction and development programmes and with a view to improving the existing disaster warning and protection systems;
 - 5. Requests the Secretary-General:
- (a) To send an inter-agency mission to Madagascar with a view to evaluating the damage, the priority needs of the country following the cyclones and floods and the medium-term and long-term impact of those disasters on the national economy, and to compiling the data relevant to the promotion of concerted international assistance:
- (b) To transmit the report of the mission to the international community;
- (c) To take the necessary action to help the Government prepare a reconstruction and recovery programme for the regions and sectors affected;
- 6. Further requests the Secretary-General to apprise the Economic and Social Council at its second regular session of 1984 and to report to the General Assembly at its thirty-ninth session on the implementation of the present resolution.

11th plenary meeting 11 May 1984

1984/4. Work programme in the field of population

The Economic and Social Council,

Recalling General Assembly resolution 3344 (XXIX) of 17 December 1974, in which the Assembly affirmed that the World Population Plan of Action⁶ was an instrument of the international community for the promotion of economic development, quality of life, human rights and fundamental freedoms within the broader context of the internationally adopted strategies for national and international progress,

Recalling also Council resolution 1981/28 of 6 May 1981 on the strengthening of actions concerned with the fulfilment of the World Population Plan of Action,

Reaffirming the role of the Population Commission in advising the Council on population questions, and noting with satisfaction the holding of the twenty-third session of the Population Commission in February and March 1985,

Taking note of the report of the Population Commission on its twenty-second session⁷ and the discussion contained therein on the progress of work and the work programme in the field of population,

Bearing in mind recommendations that may emanate from the International Conference on Population, 1984, for the further implementation of the World Population Plan of Action,

- 1. Takes note with satisfaction of the progress of work towards the implementation of the work programme for the biennium 1984-1985 and the medium-term plan for the period 1984-1989;
 - 2. Requests the Secretary-General:
- (a) To continue vigorously the work on the monitoring of world population trends and policies and the work necessary for the review and appraisal of the World Population Plan of Action;
- (b) To continue the work on world population trends and structure, paying attention to studies of fertility, mortality, internal and international migration, and particularly:
 - (i) To pursue vigorously the expansion of the data base for the measurement of the levels, trends, characteristics and demographic consequences of international migration;
 - (ii) To continue the work on patterns and factors of urbanization in relation to development, with special attention to internal migration;
 - (iii) To continue the work on the measurement and analysis of trends in mortality levels and differentials, the factors which affect them and their consequences; although special emphasis should be given to situations in developing countries, research related to developed countries should receive due recognition;
 - (iv) To complete a global assessment of nuptiality patterns and trends, making full use of the 1980 round of censuses;

- (v) To undertake in the medium term a major global assessment of age patterns of fertility, including a special study of adolescent fertility;
- (c) To continue the work on world demographic estimates and projections;
- (d) To continue work on the interrelations of population and development, paying due attention both to the implications of population trends for development and to the impact of social and economic change on demographic trends, with a view to promoting the integration of demographic factors in national and international development strategies and plans, and to expedite the preparation of manuals for the use of national planners on methods of incorporating demographic factors in development planning;
- (e) To continue the work undertaken by the United Nations Working Group on Comparative Analysis of World Fertility Survey Data, using all available data from the World Fertility Survey;
- (f) To continue the work on the population policy data bank in order to broaden the scope and analytic capacity of research on population policy formulation, implementation and evaluation;
- (g) To pursue research on the formulation, implementation and evaluation of all aspects of population policies, including mortality, fertility and the family, population distribution and international migration;
- (h) To continue work on the interrelationships between population, resources, environment and development;
- (i) To pursue and intensify the efforts of the international Population Information Network (POPIN) towards identifying and establishing better ways to improve the flow of population information;
- (j) To continue the United Nations programme of technical co-operation in the field of population for countries requesting such assistance, in close co-ordination with funding agencies, in particular the United Nations Fund for Population Activities, taking full account of experience gained through technical co-operation projects on population, and making necessary programme modifications in the light of the recommendations of the International Conference on Population, 1984;
- (k) To pursue the United Nations programme of training in population, giving appropriate support to the United Nations-sponsored regional and interregional demographic training and research centres, and assisting the further development of national training institutions, in order to provide interdisciplinary training in population, emphasizing specific policy-oriented training in and studies of population and development, and also to consider restoring the block grants for allocation for training fellowships;
- (1) To assist Governments, at their request, to exploit the full potential of population censuses and survey data by developing national capacities for demographic analysis and studies, including the further development and utilization of emerging computer software for demographic evaluation and analysis and preparation of total and sectoral popu-

lation projections as inputs to national development planning;

- (m) To further assist Governments, at their request, in establishing or strengthening national institutions, such as population units and population committees, whose purpose is to co-ordinate all population activities, particularly those relating to development planning, to integrate population factors in national development and to assist Governments in the formulation, implementation, follow-up and evaluation of population policies and programmes;
- (n) To effect the more timely publication of all population studies and projections and to promote a wide dissemination of those publications in order to provide Governments with information relevant for the formulation of policies;
- 3. Requests the Secretary-General, in carrying out the programme set out in paragraph 2 above, to seek any further needed resources only from extrabudgetary contributions;
- 4. Emphasizes the importance of maintaining the effectiveness and efficiency of the global and regional population programmes and of continuing to strengthen co-ordination and collaboration among the Department of International Economic and Social Affairs, the Department of Technical Co-operation for Development, the regional commissions, the United Nations Fund for Population Activities and organizations of the United Nations system in the planning and execution of their population programmes, as well as the need for organizations of the United Nations system to strengthen collaboration and co-ordination with national research organizations.

14th plenary meeting 16 May 1984

1984/5. Emergency assistance to the drought victims in Ethiopia

The Economic and Social Council,

Having heard the statement made by the Commissioner for Relief and Rehabilitation of Ethiopia concerning the critical food situation in the drought-affected regions of Ethiopia,8

Deeply disturbed at the gravity of the food situation and the prospect of mass starvation as a result of the drought that has affected the entire country recently,

Aware that a lasting solution to the problem of drought and environmental degradation can best be reached through regional and subregional co-operation as envisaged for the East African subregion in General Assembly resolution 35/90 of 5 December 1980 and Economic and Social Council resolution 1983/46 of 28 July 1983,

Recognizing, however, that, as a result of the unprecedented drought affecting the entire country, an emergency situation has arisen which requires prompt attention,

Noting with appreciation the continued efforts made by the Office of the United Nations Disaster

Relief Co-ordinator, the United Nations Development Programme, the United Nations Children's Fund, the Food and Agriculture Organization of the United Nations, the World Food Programme and other organs and organizations of the United Nations system, as well as the invaluable support of nongovernmental organizations,

Noting further that, despite the generous assistance offered to the Government of Ethiopia by Member States, organs and organizations of the United Nations system and voluntary agencies, enormous difficulties of relief and rehabilitation still persist,

- 1. Takes note of the statement made by the Commissioner for Relief and Rehabilitation of Ethiopia on the extremely critical food situation in the drought-affected regions of Ethiopia;
- 2. Expresses its concern at the difficulties that confront the Government of Ethiopia as a result of the unprecedented drought;
- 3. Notes with appreciation the response made thus far by the international community, organs and organizations of the United Nations system and voluntary agencies to assist the victims of the drought in Ethiopia;
- 4. Appeals to Governments of Member States, organs and organizations of the United Nations system, governmental and non-governmental organizations and all voluntary agencies to intensify and increase urgently their assistance to the Government of Ethiopia for emergency relief and rehabilitation for the victims of the drought, as well as for the recovery of the drought-affected areas of Ethiopia;
 - 5. Decides to keep the matter under review.

15th plenary meeting 17 May 1984

1984/6. Emergency assistance to the drought victims in Djibouti

The Economic and Social Council,

Having heard the statement made by the representative of Djibouti on the distressing situation of the victims of the prolonged drought in that country,9

Deeply concerned at the distressing emergency situation of the victims of the drought in Djibouti,

Aware of the adverse effects of the prolonged drought on the economic and social development of Djibouti,

Aware also of the regional character of the drought currently prevailing in the countries of East Africa,

Appreciating the unremitting efforts being made by the Government of Djibouti to meet the growing needs of the victims of the drought, in spite of the slenderness of its economic resources,

Recalling the resolutions adopted by the General Assembly and the Economic and Social Council on assistance in cases of natural disaster, in particular

Assembly resolutions 2816 (XXVI) of 14 December 1971 and 2959 (XXVII) of 12 December 1972,

- 1. Takes note of the statement made by the representative of Djibouti on the critical situation of the victims of the drought in that country;
- 2. Appreciates the assistance provided to date by Member States, United Nations organizations and intergovernmental and non-governmental organizations to the relief programme for the victims of drought in Djibouti;
- 3. Appeals to Member States, international, governmental and non-governmental organizations and the specialized agencies to contribute generously to help the populations affected by drought in Djibouti by providing, as a matter of urgency, financial, material and technical assistance;
- 4. Requests the Secretary-General to send to Djibouti, as a matter of urgency, after consultation with the Government of Djibouti, an inter-agency mission with the task, in particular, of making a study of the situation in the drought-stricken areas of the country and evaluating the short-term, medium-term and long-term needs of the Government in the face of that situation, and to report to the General Assembly at its thirty-ninth session, through the Economic and Social Council at its second regular session of 1984, on the results of that mission and on the progress achieved in the implementation of the present resolution.

15th plenary meeting 17 May 1984

1984/7. Emergency assistance to the drought victims in Somalia

The Economic and Social Council,

Having heard the statement made by the representative of Somalia on the critical need for emergency assistance to the drought victims in Somalia, 10

Recognizing the alarming situation which is developing in Somalia as a result of successive failures of seasonal rains in several regions of the country,

Cognizant of the emergency situation which, as a consequence, has overtaken the entire country, posing the severe threat of mass starvation to both people and livestock,

Appreciating the ongoing response of the Office of the United Nations Disaster Relief Co-ordinator, the United Nations Development Programme, the United Nations Children's Fund, the Food and Agriculture Organization of the United Nations, the World Food Programme and international voluntary agencies, and the vital bilateral contributions of friendly States,

Concerned, nevertheless, that despite those responses the serious food crisis in Somalia continues to escalate,

1. Takes note of the statement made by the representative of Somalia;

- 2. Notes with appreciation the response of the Government and people of Somalia and the favourable reaction to date of the international community, the United Nations and voluntary agencies to the crisis caused by the drought;
- 3. Appeals to the Governments of Member States, United Nations organizations and voluntary agencies urgently to increase their assistance to the Government of Somalia so that all victims of the drought currently afflicting Somalia may receive the necessary aid, with a minimum of delay;
- 4. Decides to keep the situation in Somalia under review.

15th plenary meeting 17 May 1984

1984/8. Convention on the Elimination of All Forms of Discrimination against Women

The Economic and Social Council,

Recalling General Assembly resolution 34/180 of 18 December 1979, by which the Assembly adopted the Convention on the Elimination of All Forms of Discrimination against Women annexed thereto,

Recalling also General Assembly resolutions 35/140 of 11 December 1980, 36/131 of 14 December 1981, 37/64 of 3 December 1982 and 38/109 of 16 December 1983,

Taking into account Council resolutions 1983/1 of 17 May 1983 and 1984/10 of 24 May 1984,

Noting that the Committee on the Elimination of Discrimination against Women, in its rules of procedure, 11 provided that it would have summary records and would include Arabic among its official languages,

Recognizing the importance of the summary records of bodies established to monitor the implementation of international human rights instruments.

Having considered the reports of the Committee on the Elimination of Discrimination against Women on its second and third sessions, 12

Welcoming the decision of the Committee to contribute to the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women: Equality, Development and Peace, to be held in 1985,

- 1. Takes note of the reports of the Committee on the Elimination of Discrimination against Women on its second and third sessions;
- 2. Emphasizes the importance of the strictest compliance by States parties with their obligations under the Convention on the Elimination of All Forms of Discrimination against Women;
- 3. Requests States parties to make all possible efforts to submit their initial implementation reports in accordance with article 18 of the Convention and requests the Committee in organizing its work to

ensure that the reports of States parties are adequately reviewed within the quadrennial cycle envisaged;

- 4. Notes the decision of the Committee, as contained in paragraphs 366 and 367 of the report on its third session, ¹³ to consider at its fourth session the achievements and obstacles experienced by States parties in the implementation of the Convention as a contribution to the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women: Equality, Development and Peace;
- 5. Requests the Secretary-General to prepare a compendium of information based upon the national reports on the achievements of and obstacles experienced by States parties in the implementation of the Convention, in conformity with article 17, paragraph 9, of the Convention, to assist the Committee in the preparation of a report on those issues as a contribution to the Conference;
- 6. Takes note of the discussion in the Committee concerning the inclusion in the agenda of a future session of an item on ways and means of implementing article 21 of the Convention, which provides that the Committee may make suggestions and general recommendations based on the examination of reports:
- 7. Recommends the General Assembly to take the necessary steps to ensure the provision and distribution in all official languages of summary records of meetings of the Committee;
- 8. Invites the Committee, once it is provided with summary records on a regular basis, to review the format and content of its report, bearing in mind the provisions of paragraphs 13, 14 and 15 of General Assembly resolution 37/14 C of 16 November 1982;
- 9. Requests the Secretary-General to transmit the reports of the Committee on the Elimination of Discrimination against Women to the General Assembly at its thirty-ninth session, as well as to the Commission on the Status of Women, for information.

17th plenary meeting 22 May 1984

1984/9. Implementation of the International Covenant on Economic, Social and Cultural Rights

The Economic and Social Council,

Bearing in mind its important responsibilities under articles 16 and 17 of the International Covenant on Economic, Social and Cultural Rights, 14

Recalling its resolutions 1988 (LX) of 11 May 1976, 1979/43 of 11 May 1979, 1983/41 of 27 May 1983 and its decision 1981/158 of 8 May 1981,

Recalling also General Assembly resolutions 37/191 of 18 December 1982 and 38/116 of 16 December 1983,

Having considered the report of the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights, 15

Mindful of the relevant resolutions and decisions adopted by the General Assembly and the Economic and Social Council on the control and limitation of documentation.

Recalling its resolution 1982/33 of 6 May 1983, by which it decided to review the composition, organization and administrative arrangements of the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights at its first regular session of 1985, taking into account the principle of equitable geographical distribution and the increase in the number of States parties to the Covenant.

Recalling also that the meetings of the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights are public, that States parties to the Covenant, States Members of the United Nations and representatives of the specialized agencies concerned may participate in its proceedings in accordance with Council decision 1978/10 of 3 May 1978, and that interested non-governmental organizations in consultative status with the Council and the public at large may attend those meetings,

Noting the concern expressed by the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights about the lack of publicity given to its work at the present session of the Council.

- 1. Takes note of the report of the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights;
- 2. *Invites* again all States that have not yet done so to become parties to the International Covenant on Economic, Social and Cultural Rights;
- 3. Calls upon States parties to the Covenant to submit reports required under article 16 thereof, in accordance with the programme established by Council resolution 1988 (LX), and urges States parties to complete the entire cycle of initial reports before submitting second periodic reports;
- 4. Invites States parties to the Covenant to comply with the guidelines established by the Secretary-General concerning the form and content of reports and to take note of the relevant recommendations of the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights in preparing and submitting their reports;
- 5. Requests the specialized agencies, on the basis of experience gained in other bodies and of reports so far submitted and considered by the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights to report on the progress made in achieving the observance of the provisions of the Covenant falling within the scope of their activities, in accordance with article 18 of the Covenant and paragraph 6 of Council resolution 1988 (LX);

- 6. Requests the Secretary-General to take all appropriate measures to ensure that the United Nations press service issues press releases on the proceedings of the next session of the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights;
- 7. Requests the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights to continue to consider including in its report to the Council brief summaries of the consideration of each country report:
- 8. Requests the Secretary-General to bring the relevant suggestions and recommendations listed in section IV of the report of the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights¹⁵ to the attention of States parties to the Covenant so that States parties may take them into account in preparing and submitting their reports under the Covenant;
- 9. Also requests the Secretary-General to submit to the Economic and Social Council at its first regular session of 1985 a report on the composition, organization and administrative arrangements of the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights and other bodies established in accordance with existing international instruments in the field of human rights in order to facilitate the review which the Council will undertake in accordance with its resolution 1982/33;
- 10. Decides that the review shall be conducted at an early date during its first regular session of 1985 to allow enough time for a full discussion of this important matter, taking into account any recommendations which the Sessional Working Group of Governmental Experts on the Implementation of the International Covenant on Economic, Social and Cultural Rights may agree upon at its next session.

19th plenary meeting 24 May 1984

1984/10. Convention on the Elimination of All Forms of Discrimination against Women

The Economic and Social Council,

Bearing in mind that one of the purposes of the United Nations, set forth in Articles I and 55 of the Charter, is to promote universal respect for human rights and fundamental freedoms without distinction of any kind, including any distinction as to sex,

Affirming that women and men should participate equally in social, economic and political development, should contribute equally to such development and should share equally in improved conditions of life.

Recalling General Assembly resolution 34/180 of 18 December 1979, by which the Assembly adopted the Convention on the Elimination of All Forms of Discrimination against Women annexed thereto,

Recalling also General Assembly resolutions 35/140 of 11 December 1980, 36/131 of 14 December 1981, 37/64 of 3 December 1982, 38/18 of 22 November 1983 and 38/109 of 16 December 1983, and Council resolution 1983/1 of 17 May 1983,

Having taken note of the report of the Committee on the Elimination of Discrimination against Women on its first session.16

- 1. Notes with appreciation the increasing number of Member States that have ratified or acceded to the Convention on the Elimination of All Forms of Discrimination against Women:
- 2. Expresses its grave concern about continuing discrimination against women and infringement of their rights in a number of States;
- 3. Urges all States that have not yet ratified or acceded to the Convention to do so as soon as possible, taking into account the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women: Equality, Development and Peace, to be held in 1985;
- Welcomes the fact that the Committee on the Elimination of Discrimination against Women began its work successfully and, in particular, adopted at its second session general guidelines regarding the form and content of reports received from States parties under article 18 of the Convention;¹⁷
- 5. Decides to include in the agenda of the thirtyfirst session of the Commission on the Status of Women the question of the Convention on the Elimination of All Forms of Discrimination against Women.

19th plenary meeting 24 May 1984

1984/11. Equal opportunity for women employed in the United Nations system

The Economic and Social Council.

Bearing in mind the long-standing commitment of the United Nations to the equal rights of women and men as expressed in the Preamble to the Charter of the United Nations and in the Convention on the Elimination of All Forms of Discrimination against Women¹⁸ and, in particular, Article 8 of the Charter of the United Nations on the eligibility of men and women to participate in any capacity and under conditions of equality in the work of the Organization,

Concerned by the lack of progress towards increasing the proportion of women in the Secretariat, in particular the failure to reach by 1982 the target of 25 per cent of the total number of women in posts subject to geographical distribution which was set by the General Assembly in section III of resolution 33/143 of 20 December 1978,

Keeping in mind that the 25 per cent target should not be viewed as a limit on the number of women employed, and paying particular attention to those

areas of the United Nations system where compliance with General Assembly resolution 33/143 has lagged,

Reaffirming section III of General Assembly resolution 33/143, section V of Assembly resolution 35/210 of 17 December 1980 and Assembly resolutions 37/235 B of 21 December 1982 and 38/231 of 20 December 1983, as well as resolution 24 of the World Conference of the United Nations Decade for Women: Equality, Development and Peace,19 in which the Conference, inter alia, called upon the Secretary-General and the heads of the specialized agencies and other United Nations bodies to end all forms of discrimination based upon sex in the recruitment, promotion and training of women and to increase the proportion of women employed, particularly at the senior levels.

- 1. Requests the Secretary-General to implement the relevant recommendations of the General Assembly and the Joint Inspection Unit and, in particular, to promote the recruitment and hiring of women in Secretariat Professional posts at middle and high levels, whether as permanent, temporary or fixed-term appointees, or as experts and consultants;
- 2. Calls upon Member States to include the names of qualified women in lists of candidates nominated for appointment to advertised United Nations posts;
- 3. Requests the Commission on the Status of Women to consider at its thirty-first session strategies for the achievement of equal employment opportunities for women in the United Nations system on the basis of the reports prepared by the Joint Inspection Unit on the status of women in the Professional category and above and of any other relevant reports;
- 4. Requests the Secretary-General to invite, through the Administrative Committee on Coordination, organizations within the United Nations system to provide information to the Commission on the Status of Women at its thirty-first session on measures taken and results achieved in pursuit of equal opportunity for women within their organizations.

19th plenary meeting 24 May 1984

1984/12. Concerns of women within the United Nations system

The Economic and Social Council,

Recalling the terms of reference of the Commission on the Status of Women set forth in Economic and Social Council resolution 48 (IV) of 29 March 1947,

Noting that, in the programme budget for the biennium 1984-1985, women are listed as only one of several specific population groups that are disadvantaged,20

Reaffirming the central but not exclusive role of the Commission on the Status of Women within the United Nations in considering matters relating to the achievement of the objectives of the United Nations Decade for Women: Equality, Development and Peace.

Reaffirming that within the United Nations system the Branch for the Advancement of Women of the Centre for Social Development and Humanitarian Affairs of the Department of International Economic and Social Affairs of the Secretariat remains the focal point for co-ordination, consultation, promotion and advice on matters relevant to women.

Recognizing that planning for, as well as monitoring of, efforts is essential to advancing the status of women within the United Nations system,

Recognizing also the efforts made by the specialized agencies to integrate women into their ongoing programmes, especially into the establishment of cross-sectoral mechanisms,

Concerned about the need to strengthen and go beyond the present integrated reporting system,

Deeply concerned that international efforts on behalf of women should keep pace with the heightened national efforts to concentrate on more effective national machineries and resources to ensure the integration of women into all stages of planning, monitoring and development activities,

- 1. Requests the Secretary-General to examine the ways in which the needs and concerns of women can be integrated into all planning and programme activities of the United Nations system and the implications of so doing, and to report the findings of such an examination to the Commission on the Status of Women at its thirty-first session;
- 2. Also requests the Secretary-General to provide in the programme budget for the biennium 1986-1987 and the revised medium-term plan for the period 1984-1989 for a special financial component, within existing overall budgetary resources, that will reflect the need for ongoing analysis of the impact of programmes on the advancement of women.
- 3. Recommends the General Assembly to request the specialized agencies to ensure continued cooperation and co-ordination with the Commission on the Status of Women beyond the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women: Equality, Development and Peace, to be held in 1985, in order to achieve the goals of the Decade;
- 4. Requests the Secretary-General to report to the Commission on the Status of Women at each session on all significant developments pertaining to the advancement of women within the United Nations system that have occurred since the previous session.

19th plenary meeting 24 May 1984

1984/13. Question of elderly women

The Economic and Social Council,

Recalling the important conclusions and recommendations of the International Plan of Action on

Aging adopted by the World Assembly on Aging,²¹ in particular paragraphs 11, 20 (b) and (c), 25 (m), 31 (g), 45, 66 (recommendations 25 and 26), 67 (recommendations 27, 28 and 29), 72 (recommendation 36 (c)) and 89, concerning elderly women,

Reaffirming General Assembly resolution 38/27 of 22 November 1983, in which the Assembly recognized that women had a longer life expectancy than men and that they would increasingly constitute a majority of the elderly population of the world,

Reaffirming resolution 4 of the World Conference of the United Nations Decade for Women: Equality, Development and Peace,²² in which the Conference emphasized that the increase in the life expectancy of women had not been dealt with comprehensively.

Appreciating that at the World Assembly on Aging special attention was given to the problems faced by some elderly women, namely, income security, education, employment, housing, health and community support services and absence of social contacts,

Believing that more data on the situation of the aging should be collected, specifically to determine the needs of elderly women and to formulate appropriate solutions.

Recalling the request made by the World Conference of the United Nations Decade for Women: Equality, Development and Peace in its resolution 4 that such data should be submitted to Member States participating in the Conference and to the Commission on the Status of Women,²²

- 1. Requests the Secretary-General to prepare, within existing budgetary resources and in accordance with the established priorities of the work of the Commission on the Status of Women, an information report on the status and situation of elderly women in their societies, their social, health and economic needs, and their entitlements as compared to those of men, comparing single, divorced and married women and widows on the basis of reports, discussions and recommendations, in particular those of the World Assembly on Aging:
- 2. Further requests the Secretary-General to submit that report to the Commission on the Status of Women at its thirty-first session with a view to recommending necessary action relating to the plight of elderly women throughout the world;
- 3. Decides to include the question of elderly women under the appropriate item of the agenda of the thirty-first session of the Commission on the Status of Women.

1984/14. Violence in the family

The Economic and Social Council,

Bearing in mind the goals of the United Nations Decade for Women: Equality, Development and Peace, and the subtheme "Employment, Health and Education",

Recalling resolution 5 of the World Conference of the United Nations Decade for Women: Equality, Development and Peace on battered women and violence in the family,²³

Recalling also Council resolution 1982/22 of 4 May 1982 on abuses against women and children,

Recognizing that violence within the family has serious negative consequences for all the individuals concerned and follows patterns of abuse that are frequently cyclical, presenting serious problems for society as a whole,

Further recognizing that violence within the family is found among various population groups,

Concerned that information on the nature of this problem and its causes is often concealed and thus is not widely available and that efforts to prevent violence in the family, to provide assistance to the victims and to prevent recurrences need greater public awareness and publicity,

Aware that many Governments and non-governmental organizations have conducted research into this issue and initiated programmes both to support victims and to treat abusers,

Recognizing that the problem of family violence is a long-standing and complex issue and needs serious and thoughtful attention,

Convinced that a more thorough exchange of information and experiences on this subject between States Members of the United Nations, organizations of the United Nations and non-governmental organizations could draw increasing attention to the problem and contribute to the development of international solutions,

- 1. Calls upon the Secretary-General to invite Member States, organizations of the United Nations and non-governmental organizations to provide the United Nations Secretariat with information on family violence and descriptions of successful programmes on the subject, or to supplement information already provided;
- 2. Urges Member States to take appropriate steps to effect a systematic exchange of information on this subject, to draw attention to the negative consequences of family violence for the men, women and children involved and for society as a whole, and to formulate solutions at the national level;
- 3. Requests the Secretary-General to convene a seminar of experts on family violence, with emphasis on its effects on women, within the resources for the biennium 1986-1987, taking into account what may emanate on this subject from the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders, to be held in 1985, with

a view to making recommendations to combat this abuse:

4. Decides to include the subject of family violence under the appropriate item of the agenda of the thirty-first session of the Commission on the Status of Women on the basis of information to be supplied in response to paragraph 1 of the present resolution.

19th plenary meeting 24 May 1984

1984/15. Promotion of opportunities for young women

The Economic and Social Council,

Recognizing that 1985 is the culminating year of the United Nations Decade for Women: Equality, Development and Peace,

Recognizing also that 1985 has been designated International Youth Year: Participation, Development, Peace,²⁴

Recognizing further that 1985 presents an opportunity to focus on the roles of young women and their participation in all activities, such as festivals, meetings, and other international youth forums to mark the International Youth Year: Participation, Development, Peace,

Bearing in mind that young women were singled out for priority attention by the World Conference of the United Nations Decade for Women: Equality, Development and Peace, particularly in its resolution 27,25

Affirming that youth is the period of growth, development and apprenticeship for the adult roles of work, citizenship and parenthood, from which all of society will benefit.

Affirming also that youth should be a period of discovery and joy in living,

Considering that young women who become mothers too early are not only deprived of their youth but are not prepared for the responsibilities of parenthood and are subject to a higher health risk,

Recognizing that, while girls and young women are found in societies at all levels of development, the world is in a period of technological revolution affecting all and women must therefore be equal partners with men in shaping and benefiting from that revolution,

Stressing that those young women who lack sufficient nutrition, education, appropriate training and health are ill prepared for their adult roles in this changing world and are thus vulnerable to economic, social and sexual exploitation,

1. Recommends that Member States should take appropriate steps to ensure that girls and young women are motivated to choose, and sufficiently trained to be chosen for, work at all levels and all the functions of a developing economy and society;

- 2. Recommends also that Member States should assist families to give equal support, guidance and encouragement to young women and men;
- 3. Recommends further that Member States should direct special assistance to girls and young women who are socially and economically disadvantaged;
- 4. Recommends that specialized agencies should undertake projects to promote global, regional and local action to accelerate the improvement in the education and training, employment and health status of girls and young women in accordance with their needs and with global, regional and local conditions;
- 5. Recommends also that specialized agencies, Member States and non-governmental organizations should undertake projects to develop cultural and sports activities aimed at promoting better international understanding and the equal right of young women and young men to fitness;
- 6. Recommends that special attention should be paid, in multilateral and bilateral co-operation programmes and projects, to the training and development of young women as managers of projects and as participants in articulating the development needs of youth;
- 7. Recommends that the Advisory Committee for the International Youth Year and the Secretary-General should, in all their reports, take special account of the needs of young women in rural and urban areas and of the problems they face.

1984/16. Implementation of the objectives of the United Nations Decade for Women: Equality, Development and Peace

The Economic and Social Council,

Considering General Assembly resolutions 3520 (XXX) of 15 December 1975 and 35/136 of 11 December 1980,

Reaffirming the objectives of the United Nations Decade for Women: Equality, Development and Peace.

Emphasizing the importance of undertaking, at the conclusion of the Decade, a critical review and appraisal of progress at the international, regional and national levels in the achievement of the goals of the Decade—equality, development and peace—and of the obstacles encountered in the implementation of the World Plan of Action for the Implementation of the Objectives of the International Women's Year²⁶ and the Programme of Action for the Second Half of the United Nations Decade for Women,²⁷ and also in developing a forward-looking perspective on the status of women,

Looking ahead to the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women: Equality, Development and Peace, to be held in 1985, at which the achievements of the Decade and the need to continue such achievements beyond the end of the Decade will be reviewed and appraised,

Conscious that further efforts are necessary to eliminate all forms of discrimination against women in every area of human activity,

Stressing that the objectives, strategies and measures to improve the socio-economic conditions of women should be an integral part of national development plans, as well as of international and development strategies, including the efforts for the establishment of the new international economic order.

Reaffirming the existence of the undeniable link between peace and development and the imperative need to halt the arms race, thereby releasing valuable additional resources that could be used for the development of the developing countries and could contribute to the well-being and prosperity of all,

Noting that, until genuine disarmament is achieved, women and men throughout the world must maintain their vigilance and do their utmost to achieve peace,

Taking into account the fact that millions of women are still experiencing untold sufferings and violations of human dignity resulting from different forms and manifestations of colonialism, foreign domination, apartheid and racial discrimination,

- 1. Reaffirms the urgent need to fulfil the goals of the United Nations Decade for Women: Equality, Development and Peace and the socio-economic development objectives established by the international community, inter alia, the elimination of hunger and malnutrition, the achievement of full employment by the year 2000, health for all by the year 2000, appropriate population policies, the reduction of the infant mortality rate, the availability of safe water and adequate sanitary facilities by 1990, the attainment of a life expectancy of 60 years as a minimum by the year 2000, universal primary school enrolment by the year 2000, and the full participation of women as both agents and beneficiaries in all sectors and at all levels of the development process;
- 2. Emphasizes that foreign occupation, colonialism, apartheid, racism and racial discrimination, and the denial of the right of peoples to self-determination and of all universally recognized human rights, are serious impediments to peace and development;
- 3. Recommends that States, especially militarily significant States, in preparing their national programmes for social and economic development, should consider taking measures to convert some resources spent for military purposes to the promotion of social progress:
- 4. Considers that the objectives of the Decade—equality, development and peace—as reflected in the World Plan of Action for the Implementation of the Objectives of the International Women's Year and in the Programme of Action for the Second Half of

the United Nations Decade for Women have not yet been achieved:

5. Considers that the activities of the world community and of the United Nations should continue beyond the end of the United Nations Decade for Women and should be directed towards equal treatment for women and their full integration in development under conditions of peace.

19th plenary meeting 24 May 1984

1984/17. Women under apartheid

The Economic and Social Council,

Taking note of the report of the Secretary-General on the situation of women and children living under racist minority régimes and in the occupied Arab territories and other occupied territories.²⁸

Bearing in mind the conclusions of the International Conference on Women and Apartheid, held at Brussels from 17 to 19 May 1982, and of the Declaration adopted by the Conference,²⁹

Noting the wide observance of 9 August annually as the International Day of Solidarity with the Struggle of Women in South Africa and Namibia, in accordance with General Assembly resolution 36/172 K of 17 December 1981.

- 1. Expresses its appreciation to the Special Committee against Apartheid and its Task Force on Women and Children for giving special attention to the plight of women and children under apartheid, in accordance with General Assembly resolution 36/172 K;
- 2. Expresses its appreciation to the International Committee of Solidarity with the Struggle of Women in South Africa and Namibia for undertaking activities in support of women and children living under apartheid, and urges the Committee to exert greater efforts in support of women and children living under apartheid;
- 3. Urges all Governments, United Nations bodies, international, regional, intergovernmental and non-governmental organizations, women's and anti-apartheid groups and other concerned groups to give the highest priority to measures of assistance to women in South Africa and Namibia until the end of the United Nations Decade for Women: Equality, Development and Peace and beyond;
- 4. Invites the Special Committee against Apartheid and its Task Force on Women and Children to continue their activities in promoting the widest possible dissemination of information concerning women and children living under apartheid;
- 5. Appeals to all Governments, United Nations bodies, international, regional, intergovernmental and non-governmental organizations, women's and anti-apartheid groups and other concerned groups to support the various projects of the national liberation movements and front-line States designed to assist

refugee women and children from South Africa and Namibia:

- 6. Requests the Secretary-General to submit to the Commission on the Status of Women at its thirty-first session a preliminary report on measures of assistance provided to women inside South Africa and Namibia and to women from South Africa and Namibia who have become refugees as the result of the practice of apartheid;
- 7. Calls upon all women's organizations to support the women of Namibia in their efforts to attain independence, in accordance with Security Council resolution 435 (1978) of 29 September 1978.

19th plenary meeting 24 May 1984

1984/18. Situation of Palestinian women within and outside the occupied Arab territories

The Economic and Social Council,

Deeply concerned about the prevailing living conditions of Palestinian women within and outside the occupied Arab territories,

Recognizing that the mass uprooting of Palestinian women from their homeland seriously affects their participation and integration in the development process,

Noting that no comprehensive study relating to the status of Palestinian women within and outside the occupied Arab territories has been conducted in the United Nations system since the World Conference of the United Nations Decade for Women: Equality, Development and Peace, held at Copenhagen from 14 to 30 July 1980.

Recalling the relevant resolutions of the General Assembly, the Economic and Social Council and other appropriate United Nations organizations,

Taking note of chapter II of the report of the Secretary-General on the situation of Palestinian women and children in the occupied Arab territories, 30 submitted to the Commission on the Status of Women at its thirtieth session.

- 1. Requests the Secretary-General to submit an updated version of that report to the Commission on the Status of Women at its thirty-first session;
- 2. Also requests the Secretary-General to prepare a comprehensive report on the situation of Palestinian women living within and outside the occupied Arab territories and to submit it to the Commission on the Status of Women at its thirty-second session;
- 3. Further requests the Secretary-General to submit an interim report on the preparation of that study to the Commission on the Status of Women at its thirty-first session;
- 4. *Invites* all Governments, intergovernmental and non-governmental organizations and United Nations bodies to extend all necessary assistance to the Secretary-General in this regard.

1984/19. Physical violence against detained women that is specific to their sex

The Economic and Social Council,

Noting with grave concern that the Commission on the Status of Women, in the report on its thirtieth session under the question of communications concerning the status of women,31 drew attention to a pattern of physical violence against women while detained—cases of rape and other sexual abuse, including violence against pregnant women,

Considering that women are especially vulnerable to sexual violence,

Considering also that pregnant women require special protection and care by society,

Recalling its resolutions 76 (V) of 5 August 1947 and 304 I (XI) of 14 and 17 July 1950,

Recalling also its resolutions 1980/39 of 2 May 1980 and 1983/27 of 26 May 1983, by which it reaffirmed the mandate of the Commission on the Status of Women to consider communications relating to the status of women, including the replies of Governments thereon, if any, and to draw to the attention of the Council emerging trends and patterns so that it may decide what action to take,

- 1. Calls upon the Member States concerned to take appropriate measures urgently to eradicate such violations:
- 2. Invites all Member States to submit their views on physical violence against detained women that is specific to their sex to the Secretary-General to enable him to report to the Commission on the Status of Women at its thirty-first session under the appropriate item of the agenda;
- 3. Decides to authorize the Secretary-General to provide, from within existing budgetary resources, the services and facilities necessary for the implementation of the present resolution.

19th plenary meeting 24 May 1984

1984/20. Future work of the Commission on the Status of Women

The Economic and Social Council,

Reaffirming the mandate of the Commission on the Status of Women established by the Economic and Social Council in resolution 11 (II) of 21 June 1946,

Considering that the objectives of the United Nations Decade for Women: Equality, Development and Peace continue to be valid, are closely interrelated and constitute a significant basis for the work of the Commission on the Status of Women,

Considering that, as the end of the Decade approaches, it is urgently necessary to reinforce the future work of the Commission on the Status of Women so that it may discharge its important role in promoting the implementation of the strategies for the

year 2000 that will emanate from the World Conference to Review and Appraise the Achievements of the United Nations Decade for Women: Equality, Development and Peace, to be held in 1985,

Emphasizing the importance of the role of women in development as both agents and beneficiaries,

Taking into account resolution 40 of the World Conference of the United Nations Decade for Women: Equality, Development and Peace,32 General Assembly resolutions 2263 (XXII) of 7 November 1967, 2626 (XXV) of 24 October 1970 and 35/56 of 5 December 1980. Economic and Social Council resolution 1980/38 of 2 May 1980 and any other relevant resolutions.

Welcoming the decision of the General Assembly to declare 1986 the International Year of Peace³³ as a contribution to the improvement of the international climate, which will alleviate existing tensions and the grave threats to the maintenance of peace which jeopardize the possibility of improving the status of women.

- 1. Recommends that the Commission on the Status of Women at its thirty-first session, as a contribution to the International Year of Peace, should consider recommendations for concrete proposals to ensure the full participation of women in the establishment of conditions conducive to the maintenance of peace and to the elimination of inequality and poverty;
- 2. Also recommends that the Commission on the Status of Women at its thirty-first session should propose concrete measures to overcome the general and specific trends that impede the advancement of women, in particular by proposing the establishment, by other organs of the United Nations, of training programmes and socially and economically profitable projects that give women a part in the development process on a footing of equality.

Demand and supply of opiates for medical 1984/21. and scientific needs

The Economic and Social Council,

Recalling its resolutions 1979/8 of 9 May 1979. 1980/20 of 30 April 1980, 1981/8 of 6 May 1981, 1982/12 of 30 April 1982 and 1983/3 of 24 May 1983, as well as Commission on Narcotic Drugs resolution 1 (XXIX) of 11 February 1981 entitled "Strategy and policies for drug control", 14

Having considered the report of the International Narcotics Control Board for 1983,35 on the demand and supply of opiates for medical and scientific needs,

Noting with concern the apprehension of the International Narcotics Control Board that a return to overproduction is likely and that the possibility of an increase in the already excessive stocks cannot be excluded,

Further noting with concern that the traditional supplier countries continue to hold large accumulated stocks of opiate raw materials which constitute heavy financial and other burdens for them,

Bearing in mind the urgent need to liquidate the accumulated stocks held by the traditional supplier countries with a view to achieving a lasting worldwide balance between demand and supply of opiates for medical and scientific purposes,

Taking into account paragraph 55 of the report of the International Narcotics Control Board for 1983,

- 1. Urges the Governments of those countries that have not already done so to take urgent and effective steps to implement the above-mentioned resolutions;
- 2. Requests the International Narcotics Control Board to devise and take, in accordance with the Single Convention on Narcotic Drugs, 1961,³⁶ appropriate measures with a view to promoting and monitoring the urgent implementation of the abovementioned resolutions;
- 3. Further requests the International Narcotics Control Board, in consultation with the producing and the consuming countries and the concerned United Nations bodies, to assist in the further development of effective ways of ensuring a balance in supply and demand and of reducing excessive stocks of licit opiate raw materials, included as activity A.1 to be undertaken by the Secretary-General, during the biennium 1984-1985,³⁷ under the basic five-year programme of action of the International Drug Abuse Control Strategy, adopted by the General Assembly in its resolution 36/168 of 16 December 1981;
- 4. Requests the Secretary-General to transmit the present resolution to all Governments for their consideration and implementation.

19th plenary meeting 24 May 1984

1984/22. The cannabis problem

The Economic and Social Council,

Recalling its resolution 1933 (LVIII) of 6 May 1975,

Bearing in mind that the Single Convention on Narcotic Drugs, 1961,³⁸ requires, inter alia, that the use and possession of all the substances listed in Schedule I should be confined exclusively to medical and scientific purposes,

Bearing in mind also that the Convention recommends, for the substances listed in Schedule IV, including cannabis and cannabis resin, application of all the special control measures which the contracting

parties have deemed necessary in the light of the particularly dangerous properties of those substances,

Recognizing that knowledge concerning the harm that the use of cannabis and cannabis resin can cause to the human organism, especially to the brain, the lungs and cell structures, is considerably greater today than it was a few years ago,

Noting with great concern that the International Narcotics Control Board, in its two most recent annual reports, has emphasized that the abuse, illicit cultivation and trafficking of cannabis and cannabis resin are increasing in a majority of regions of the world,

Aware that in many regions of the world cannabis and cannabis resin obviously play an important role in the spread of drug abuse and in the illicit drug traffic, particularly among young persons,

- 1. Recommends that all Governments should combat systematically the abuse of cannabis and cannabis resin and intensify national and international efforts to fight the illicit cultivation of, and traffic in, those narcotic drugs:
- 2. Recommends also that all Governments that have not yet done so should consider all appropriate measures needed to confine the cultivation and the licit use of cannabis products to medical and scientific research, in accordance with article 2, paragraph 5 (b), of the Single Convention on Narcotic Drugs, 1961;
- 3. Recommends further that scientific research, especially long-term investigations into the effects of cannabis abuse on the human organism, should be continued and accelerated;
- 4. Recommends, in addition, that all Governments should maintain or adopt appropriate preventive measures concerning the hazardous consequences of cannabis abuse;
- 5. Requests the Secretary-General to inform all Governments of the present resolution, and to invite them to take action with a view to its effective implementation, in accordance with the pertinent provisions of the Single Convention on Narcotic Drugs, 1961.

19th plenary meeting 24 May 1984

1984/23. Review for scheduling of the amphetaminelike drugs

The Economic and Social Council,

Recalling Commission on Narcotic Drugs resolution 4 (XXX) of 16 February 1983,³⁹

Noting with concern the serious health and social problems posed by amphetamine-like drugs in some countries,

Noting also with concern the growing traffic in and abuse of amphetamine-like drugs in some countries not currently subject to international control,

Aware that many of those substances have limited or no recognized therapeutic use,

Recognizing that the Secretary-General has recently obtained information from many States with respect to those substances, in response to his request,40

- 1. Urges the World Health Organization to select any of those amphetamine-like drugs for which data have been collected and which represent the most serious social and health consequences, to review those substances immediately, in accordance with Commission on Narcotic Drugs resolution 2 (S-VII) of 8 February 1982⁴¹ and consistent with the principles governing the new review procedures of the World Health Organization,42 and to make its findings available to the Commission at its thirty-first session;
- 2. Welcoming the decision of the General Assembly, in its resolution 37/53 of 3 December 1982, to proclaim the period 1983-1992 United Nations Decade of Disabled Persons,

Deeply concerned that serious violations of human rights remain a significant cause of temporary and permanent disability,

Taking note also of the work done by the Committee on Crime Prevention and Control in the area of summary and arbitrary executions, including the

- 1. Strongly deplores, once again, the large number of summary or arbitrary executions, including extralegal executions, which continue to take place in various parts of the world:
- 2. Appeals urgently to Governments, United Nations bodies, the specialized agencies, regional intergovernmental organizations and non-governmental organizations to take effective action to combat and eliminate summary or arbitrary executions, including extra-legal executions;
- 3. Takes note with appreciation of the report of the Special Rapporteur, Mr. S. Amos Wako;⁷⁶
- 4. Decides to continue the mandate of the Special Rapporteur for another year, in order to enable him to submit further conclusions and recommendations to the Commission on Human Rights;
- 5. Requests the Special Rapporteur in carrying out his mandate to continue to examine situations of summary or arbitrary executions and to pay special attention to cases in which a summary or arbitrary execution is imminent or threatened;
- 6. Requests the Special Rapporteur in carrying out his mandate to respond effectively to information that comes before him;

Requests the Commission on Human Rights to consider the question of summary or arbitrary executions as a matter of high priority at its forty-first session, under the item entitled "Question of the violation of human rights and fundamental freedoms in any part of the world, with particular reference to colonial and other dependent countries and territories".

1984/41. Measures to improve the situation and ensure the human rights and dignity of all migrant workers and their families

The Economic and Social Council,

Mindful of the need for international co-operation in solving international problems of an economic, social, intellectual or humanitarian nature and in developing and encouraging respect for human rights and fundamental freedoms for all, without distinction as to race, sex, language or religion,

Recalling in that regard the provisions of the Universal Declaration of Human Rights, 88 of the International Convention on the Elimination of All Forms of Racial Discrimination 89 and of the International Covenants on Human Rights, 90

Mindful of the contribution made by migrant workers to the economic growth and the social and cultural development of the host countries,

Noting, in particular, that the problems of migrant workers, which are becoming more serious in some regions for political and economic reasons and for social and cultural reasons, constitute a matter of grave concern and continue to be of the greatest importance to certain countries,

Mindful of the important contribution made by the International Labour Organisation in the protection of the rights of all migrant workers,

Appreciating also the efforts of the United Nations Educational, Scientific and Cultural Organization in matters relating to migrant workers,

Deeply concerned at the fact that, despite the general effort made by Member States, regional intergovernmental organizations and various United Nations bodies, migrant workers are still unable fully to

exercise their rights in the social field and in the labour field, as defined in the Universal Declaration of Human Rights,

Emphasizing, therefore, the efforts that must still be made effectively to protect the rights of all migrant workers and their living conditions,

Recalling its resolutions 1981/21 of 6 May 1981 and 1983/40 of 27 May 1983, and Commission on Human Rights resolution 1984/61 of 15 March 1984,91

Recalling also its resolutions 1980/16 of 30 April 1980 and 1981/35 of 8 May 1981,

- 1. Welcomes the progress made by the Working Group on the Drafting of an International Convention on the Protection of the Rights of All Migrant Workers and Their Families, established in pursuance of General Assembly resolution 34/172 of 17 December 1979;
- 2. Expresses again its conviction that the drafting of that convention will further facilitate the exchanges of views needed for protecting the human rights and improving the situation of migrant workers and their families:
- 3. Expresses the hope that substantial progress will be made by the Working Group during the two meetings to be held in 1984 in accordance with General Assembly resolution 38/86 of 16 December 1983, with a view to completing the drafting of the convention during the thirty-ninth session of the Assembly;
- 4. Decides to consider at its first regular session of 1985 the question of measures to improve the situation and ensure the human rights and dignity of all migrant workers and to monitor the status of work done with a view to protecting the rights of all migrant workers and their families.

1984/42. Report of the Ad Hoc Working Group of Experts of the Commission on Human Rights on allegations of infringements of trade union rights in the Republic of South Africa

The Economic and Social Council,

Recalling its resolution 1982/40 of 7 May 1982,

Having examined the extract from the progress report of the Ad Hoc Working Group of Experts on southern Africa, 92

Noting with grave concern that police and State interference in industrial disputes and repression against independent black trade union movements have persisted,

- 1. Takes note of the extract from the progress report of the Ad Hoc Working Group of Experts on southern Africa;
- 2. *Demands* the cessation of persecution of trade unionists by the Government of South Africa:

- 3. Calls once again for the immediate recognition of the unimpeded exercise of freedom of association and trade union rights by the entire population of South Africa, without discrimination of any kind;
- 4. Demands the immediate release of all imprisoned trade unionists and the lifting of the orders banning trade unionists and trade union organizations;
- 5. Requests the Ad Hoc Working Group of Experts to continue to study the situation and to report thereon to the Commission on Human Rights and the Council;
- 6. Also requests the Ad Hoc Working Group of Experts, in the discharge of its mandate, to consult with the International Labour Organisation and the Special Committee against Apartheid, as well as with international and African trade union confederations;
- 7. Decides to consider at its first regular session of 1985 the question of allegations of infringements of trade union rights in South Africa as a sub-item under the item entitled "Human rights questions".

1984/43. Second Decade to Combat Racism and Racial Discrimination

The Economic and Social Council,

Welcoming the proclamation by the General Assembly in its resolution 38/14 of 22 November 1983 of the Second Decade to Combat Racism and Racial Discrimination.

Bearing in mind the Programme of Action for the Second Decade approved by the General Assembly in its resolution 38/14,

Mindful of the responsibilities conferred upon it by the General Assembly of co-ordinating the implementation of the Programme of Action and of evaluating the activities to be undertaken during the Second Decade.

Recalling the guidance provided to the Secretary-General by the General Assembly in its resolution 38/14 for the preparation of the plan of activities for the period 1985-1989 for implementing the Programme of Action and achieving the objectives of the Second Decade.

Having considered the plan of activities for the period 1985-1989 proposed by the Secretary-General, 93

- 1. Welcomes the adoption by the General Assembly of the Programme of Action for the Second Decade to Combat Racism and Racial Discrimination;
- 2. Takes note of the plan of activities for the period 1985-1989 proposed by the Secretary-General;
- 3. Requests the Secretary-General to submit to the General Assembly at its thirty-ninth session a revised plan of activities for the period 1985-1989, taking into account the priorities reflected in the Programme of Action for the Second Decade and the relevant resolutions and recommendations, including the Programme for the Decade for Action to Combat

Racism and Racial Discrimination and the programme of activities to be undertaken during the second half of that Decade, as contained in General Assembly resolutions 3057 (XXVIII) of 2 November 1973, particularly paragraphs 18 (b) and (e) thereof, and 34/24 of 15 November 1979;

- 4. Invites all Governments, United Nations bodies, the specialized agencies and other intergovernmental organizations, as well as interested non-governmental organizations in consultative status with the Economic and Social Council, to participate in the implementation of the plan of activities for the Second Decade by intensifying and expanding their efforts to ensure the rapid elimination of apartheid and all forms of racism and racial discrimination;
- 5. Decides to consider on an annual basis an item entitled "Implementation of the Programme of Action for the Second Decade to Combat Racism and Racial Discrimination".

1984/44. Co-ordination and information in the field of youth

The Economic and Social Council,

Recalling its resolutions 1979/27 of 9 May 1979, 1980/25 of 2 May 1980, 1981/25 of 6 May 1981, 1982/28 of 4 May 1982 and 1983/26 of 26 May 1983 on coordination and information in the field of youth,

Recalling also General Assembly resolutions 34/151 of 17 December 1979, 36/28 of 13 November 1981, 37/48 of 3 December 1982 and 38/22 of 22 November 1983 on the International Youth Year: Participation, Development, Peace,

Considering that the implementation of the Specific Programme of Measures and Activities to be undertaken prior to and during the International Youth Year, 94 of the recommendations made by the Advisory Committee for the International Youth Year and endorsed by the General Assembly in its resolution 37/48, and of the relevant recommendations of the five regional meetings devoted to the International Youth Year held in 1983 could contribute to intensifying and improving the co-ordination of the activities of the United Nations and specialized agencies relating to youth,

Convinced of the importance of giving widespread publicity to the activities of the United Nations in the field of youth, especially in the context of the preparations for the International Youth Year,

Taking note of the report of the Secretary-General on co-ordination and information in the field of youth, 95

- 1. Endorses the conclusions contained in the report of the Secretary-General on co-ordination and information in the field of youth;
- 2. Invites again all United Nations bodies, specialized agencies, regional commissions and other international intergovernmental organizations, as well

- 3. Requests the Secretary-General to take all necessary organizational measures to ensure the success of the observance of the International Youth Year in 1985 within the United Nations system in accordance with the recommendations made by the Advisory Committee for the International Youth Year;
- 4. Decides to consider at its first regular session of 1985, on the basis of a report of the Secretary-General, the progress achieved in co-ordination and information in the field of youth.

21st plenary meeting 25 May 1984

Continuation of preparations for the Seventh 1984/45. United Nations Congress on the Prevention of Crime and the Treatment of Offenders

The Economic and Social Council,

Recalling General Assembly resolutions 415 (V) of 1 December 1950, 32/60 of 8 December 1977 and 36/21 of 9 November 1981,

Recalling also Council resolutions 1982/29 and 1982/30 of 4 May 1982,

Having considered the report of the Secretary-General⁹⁶ and the note by the Secretariat⁹⁷ relating to preparations for the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders.

Conscious of the need to increase the publicity relating to the Seventh Congress, and the impact of its results.

Aware of the important work to be accomplished by the interregional preparatory meetings,

- 1. Takes note of the reports of the regional preparatory meetings98 with their respective recommendations on the substantive items of the provisional agenda for the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders:99
- 2. Takes note also of the discussion guide for the regional and interregional preparatory meetings for the Seventh Congress;100
- 3. Recommends the Seventh Congress to consider in depth the resolutions adopted at the regional preparatory meetings;
- 4. Recommends also the Seventh Congress to finalize, under item 3 of its provisional agenda, the guiding principles for crime prevention and criminal

justice in the context of development and a new international economic order as reviewed by the Committee on Crime Prevention and Control on the basis of the observations made at the regional preparatory meetings, 101 and to make every effort to secure their adoption for the strengthening of international cooperation in this field;

- 5. Decides that the Seventh Congress should be held from 26 August to 6 September 1985, with two days of pre-Congress consultations;
- 6. Decides also that items 1, 2, 3 and 8 of the provisional agenda should be considered in plenary meeting, and that items 4 and 7 should be allocated to Committee I and items 5 and 6 to Committee II;
- 7. Decides further that the general theme for the Seventh Congress should be "Crime prevention for freedom, justice, peace and development";
- 8. Approves the documentation for the Seventh Congress as outlined by the Secretary-General;¹⁰²
- 9. Invites Governments to finalize national preparations related to the Seventh Congress, including the submission of national papers, and to consider the inclusion of national correspondents in their delegations to the Congress;
- 10. Invites representatives of the Committee on Crime Prevention and Control attending the interregional preparatory meetings for the Seventh Congress to ensure that reports of the meetings, with related recommendations, are in conformity with the policy guidelines given by the Committee;
- 11. Requests the Secretary-General to appoint a Secretary-General for the Seventh Congress, in accordance with the standard practice for major United Nations conferences;
- 12. Also requests the Secretary-General to invite 25 expert consultants to participate in the Seventh Congress, at the expense of the United Nations, as was done on the occasion of the Sixth Congress, so as to ensure that adequate expertise is provided to the Congress by each region for each substantive item of the provisional agenda;
- 13. Further requests the Secretary-General, in the organization of the Seventh Congress, to include the following activities:
- (a) Lectures to be given by outstanding experts and scholars selected on the basis of equitable geographical distribution;
- (b) Research workshop on youth crime and juvenile justice, to be organized with the joint co-operation of the United Nations Social Defence Research Institute. the United Nations regional institutes for the prevention of crime and the treatment of offenders and national and international research competent institutes:
- (c) Ancillary meetings of non-governmental organizations in consultative status with the Economic and Social Council concerning items of the provisional agenda, in accordance with existing legislative regulations;

1984/46. Alternatives to imprisonment

The Economic and Social Council,

Recalling resolutions 8 and 10 of the Sixth United Nations Congress on the Prevention of Crime and the Treatment of Offenders, 103

Acknowledging the importance of further developing alternatives to the sanction of imprisonment,

Considering the noticeable progress made in various countries in intensifying contacts between sentenced persons and the community at large,

Aware that further progress is needed in order to reduce the social and psychological costs related to imprisonment.

- 1. Takes note with appreciation of the report of the Secretary-General on alternatives to imprisonment and measures for the social resettlement of offenders:104
- 2. Encourages Member States to increase their efforts in order to further expand the use of such measures:
- 3. Calls the attention of Member States to the recommendation of the Sixth United Nations Congress on the Prevention of Crime and the Treatment of Offenders that the principles on linking the rehabilitation of offenders to related social services should be taken into account when formulating strategies for deinstitutionalization within the overall framework of crime prevention; 105
- Welcomes the recommendation of the Committee on Crime Prevention and Control that these matters should be considered by the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders, under the item of the provisional agenda¹⁰⁶ entitled "Formulation and application of United Nations standards and norms in criminal justice";
- 5. Requests the Secretary-General to update the report on alternatives to imprisonment, on the basis of information to be provided by Member States and other sources, including relevant non-governmental

organizations and professional organizations, for submission to the Seventh Congress.

1984/47. Procedures for the effective implementation of the Standard Minimum Rules for the Treatment of Prisoners

The Economic and Social Council,

Considering the importance of the recommendations contained in the Standard Minimum Rules for the Treatment of Prisoners adopted by the First United Nations Congress on the Prevention of Crime and the Treatment of Offenders, and approved by the Council in its resolution 663 C (XXIV) of 31 July 1957,

Noting with satisfaction the impact of the Rules on national laws and practices,

Concerned, however, that there still exist obstacles of various kinds to the full implementation of the Rules, as evidenced in the periodic United Nations reports on their implementation,

Recalling the recommendations of the Fifth United Nations Congress on the Prevention of Crime and the Treatment of Offenders, 107 and Council resolution 1993 (LX) of 12 May 1976, in which the Committee on Crime Prevention and Control was requested at its fourth session to study the range of application of the Rules and to formulate a set of implementing procedures for the Rules,

Taking note with appreciation of the work accomplished in pursuance of that mandate by the Committee on Crime Prevention and Control at its fourth session in 1976108 and at its eighth session109 in pursuance of the recommendations of the Sixth United Nations Congress on the Prevention of Crime and the Treatment of Offenders, which invited the Committee to finalize the procedures in the light of its report, 110

- 1. Approves the procedures for the effective implementation of the Standard Minimum Rules for the Treatment of Prisoners, as set out in the annex to the present resolution;
- 2. Invites Member States to take the procedures annexed hereto into consideration in the process of implementing the Rules and in their periodic reports to the United Nations:
- Requests the Secretary-General to bring the present resolution to the attention of the Governments of the Member States, and to assist them at their

ANNEX

Procedures for the effective implementation of the Standard Minimum Rules for the Treatment of Prisoners

Procedure 1

All States whose standards for the protection of all persons subjected to any form of detention or imprisonment fall short of the Standard Minimum Rules for the Treatment of Prisoners shall adopt the Rules.

Commentary

The General Assembly, in its resolution 2858 (XXVI) of 20 December 1971, invited the attention of Member States to the Standard Minimum Rules and recommended that they should be effectively implemented in the administration of penal and correctional institutions and that favourable consideration should be given to their incorporation in national legislation. Some States may have standards that are more advanced than the Rules, and the adoption of the Rules is therefore not requested on the part of such States. Where States feel that the Rules need to be harmonized with their legal system and adapted to their culture, the emphasis is placed on the substance rather than the letter of the Rules.

Procedure 2

Subject, as necessary, to their adaptation to the existing laws and culture but without deviation from the spirit and purpose of the Rules, the Standard Minimum Rules shall be embodied in national legislation and other regulations.

Commentary

This procedure emphasizes that it is necessary to embody the Rules within national legislation and regulations, thus covering also some aspects of procedure 1.

Procedure 3

The Standard Minimum Rules shall be made available to all persons concerned, particularly to law enforcement officials and correctional personnel, for purposes of enabling their application and execution in the criminal justice system.

Commentary

This procedure stresses that the Rules, as well as national statutes and regulations implementing the Rules, should be made available to all persons concerned with their implementation, in particular law enforcement officials and correctional personnel. The effective implementation of the Rules might also involve the organization of training courses by the central administration in charge of correctional matters. The dissemination of procedures is discussed in procedures 7 to 9.

Procedure 4

The Standard Minimum Rules, as embodied in national legislation and other regulations, shall also be made available and understandable to all prisoners and all persons under detention, on their admission and during their confinement.

Commentary

To achieve the goal of the Standard Minimum Rules, it is necessary to make the Rules, as well as the implementing national statutes and regulations, available to prisoners and all persons under detention (rule 95), in order to further the awareness that the Rules represent the minimum conditions that are accepted as suitable by the United Nations. Thus, this procedure supplements the provisions contained in procedure 3.

A similar requirement, that the Rules be made available to the persons for whose protection they have been elaborated, has been already established in the four Geneva Conventions of 12 August 1949,¹¹¹ of which articles 47 of the first Convention, 48 of the second, 127 of the third and 144 of the fourth state in common:

"The High Contracting Parties undertake, in time of peace as in time of war, to disseminate the text of the present Convention as widely as possible in their respective countries, and, in particular, to include the study thereof in their programmes of military and, if possible, civil instruction, so that the principles thereof may become known to the entire population, in particular to the armed fighting forces, the medical personnel and the chaplains."

Procedure 5

States shall inform the Secretary-General of the United Nations every five years of the extent of the implementation and the progress made with regard to the application of the Standard Minimum Rules, and of the factors and difficulties, if any, affecting their implementation, by responding to the Secretary-General's questionnaire. This questionnaire should, following a specified schedule, be selective and limited to specific questions in order to secure an in-depth review and study of the problems selected. Taking into account the reports of Governments as well as other relevant information available within the United Nations system, the Secretary-General shall prepare independent periodic reports on progress made with respect to the implementation of the Standard Minimum Rules. In the preparation of those reports the Secretary-General may also enlist the co-operation of specialized agencies and of the relevant intergovernmental organizations and non-governmental organizations in consultative status with the Economic and Social Council. The Secretary-General shall submit the above-mentioned reports to the Committee on Crime Prevention and Control for consideration and further action, as appropriate.

Commentary

It will be recalled that the Economic and Social Council, in its resolution 663 C (XXIV) of 31 July 1957, recommended that the Secretary-General be informed every five years of the progress made with regard to the application of the Standard Minimum Rules and authorized the Secretary-General to make arrangements for the publication, as appropriate, of such information and to ask for supplementary information if necessary. Seeking the cooperation of specialized agencies and relevant intergovernmental and non-governmental organizations is a well-established United Nations practice. In the preparation of his independent reports on progress made with respect to the implementation of the Standard Minimum Rules, the Secretary-General will take into account, inter alia, information available in the human rights organs of the United Nations, including the Commission on Human Rights, the Sub-Commission on Prevention of Discrimination and Protection of Minorities, the Human Rights Committee functioning under the International Covenant on Civil and Political Rights, and the Committee on the Elimination of Racial Discrimination. The implementation work under the future convention against torture could also be taken into account, as well as any information which might be gathered under the body of principles for the protection of prisoners and detainees currently under preparation in the General Assembly.

Procedure 6

As part of the information mentioned in procedure 5 above, States should provide the Secretary-General with:

- (a) Copies or abstracts of all laws, regulations and administrative measures concerning the application of the Standard Minimum Rules to persons under detention and to places and programmes of detention:
- (b) Any data and descriptive material on treatment programmes, personnel and the number of persons under any form of detention, and statistics, if available:

(c) Any other relevant information on the implementation of the Rules, as well as information on the possible difficulties in their application.

Commentary

This requirement derives from both resolution 663 C (XXIV) of the Economic and Social Council and the recommendations of the United Nations congresses on the prevention of crime and the treatment of offenders. Although the items of information suggested here are not specifically provided for, it seems feasible to collect such information in order to assist Member States in overcoming difficulties through an exchange of experience. Furthermore, the request for such information is analogous to the existing periodic reporting system on human rights originally established by the Economic and Social Council in its resolution 624 B (XXII) of 1 August 1956.

Procedure 7

The Secretary-General shall disseminate the Standard Minimum Rules and the present implementing procedures, in as many languages as possible, and make them available to all States and intergovernmental and non-governmental organizations concerned, in order to ensure the widest circulation of the Rules and the present implementing procedures.

Commentary

The need for the widest possible dissemination of the Standard Minimum Rules is self-evident. Close co-operation with all appropriate intergovernmental and non-governmental organizations is important to secure more effective dissemination and implementation of the Rules. Therefore, the Secretariat should maintain close contacts with such organizations and should make relevant information and data available to them. It should also encourage those organizations to disseminate information about the Standard Minimum Rules and the implementing procedures.

Procedure 8

The Secretary-General shall disseminate his reports on the implementation of the Rules, including analytical summaries of the periodic surveys, reports of the Committee on Crime Prevention and Control, reports prepared for the United Nations congresses on the prevention of crime and the treatment of offenders as well as the reports of the congresses, scientific publications and other relevant documentation as from time to time may be deemed necessary to further the implementation of the Standard Minimum Rules.

Commentary

This procedure reflects the present practice of disseminating such reports as part of the documentation for the United Nations bodies concerned, as United Nations publications or as articles in the Yearbook on Human Rights and the International Review of Criminal Policy, the Crime Prevention and Criminal Justice Newsletter and any other relevant publications.

Procedure 9

The Secretary-General shall ensure the widest possible reference to and use of the text of the Standard Minimum Rules by the United Nations in all its relevant programmes, including technical co-operation activities.

Commentary

It should be ensured that all relevant United Nations bodies include or make reference to the Rules and the implementing procedures, thus contributing to wider dissemination and increasing the awareness of specialized agencies, governmental, intergovernmental and non-governmental bodies and the general public of the Rules and of the commitment of the Economic and Social Council and the General Assembly to their implementation.

The extent to which the Rules have any practical effect on correctional administrations depends to a great extent on the measures through which they permeate local legislative and administrative practices. They should be known and understood by a wide range of professionals and non-professionals throughout the world. Therefore there is a great need for more publicity in

any form, which could also be attained by frequent references to the Rules, accompanied by public information campaigns.

Procedure 10

As part of its technical co-operation and development programmes the United Nations shall:

- (a) Aid Governments, at their request, in setting up and strengthening comprehensive and humane correctional systems;
- (b) Make available to Governments requesting them the services of experts and regional and interregional advisers on crime prevention and criminal justice;
- (c) Promote national and regional seminars and other meetings at the professional and non-professional levels to further the dissemination of the Standard Minimum Rules and the present implementing procedures:
- (d) Strengthen substantive support to regional research and training institutes in crime prevention and criminal justice that are associated with the United Nations.

The United Nations regional research and training institutes in crime prevention and criminal justice, in co-operation with national institutions, shall develop curricula and training materials, based on the Standard Minimum Rules and the present implementing procedures, suitable for use in criminal justice educational programmes at all levels, as well as in specialized courses on human rights and other related subjects.

Commentary

The purpose of this procedure is to ensure that the United Nations technical assistance programmes and the training activities of the United Nations regional institutes are used as indirect instruments for the application of the Standard Minimum Rules and the present implementing procedures. Apart from regular training courses for correctional personnel, training manuals and the like, particularly at the policy and decision-making level, provision should be made for expert advice on the questions submitted by Member States, including an expert referral system to interested States. This expert referral system seems particularly necessary in order to implement the Rules according to their spirit and with a view to the socio-economic structure of the countries requesting such assistance.

Procedure 11

The United Nations Committee on Crime Prevention and Control shall:

- (a) Keep under review, from time to time, the Standard Minimum Rules, with a view to the elaboration of new rules, standards and procedures applicable to the treatment of persons deprived of liberty:
- (b) Follow up the present implementing procedures, including periodic reporting under procedure 5 above.

Commentary

As most of the information collected in the course of periodic inquiries as well as during technical assistance missions would be brought to the attention of the Committee on Crime Prevention and Control, ensuring the effectiveness of the Rules in improving correctional practices rests with the Committee, whose recommendations would determine the future course in the application of the Rules, together with the implementing procedures. The Committee should therefore clearly define existing shortcomings in or the reasons for the lack of implementation of the Rules, inter alia, through contacts with the judiciary and ministries of justice of the countries concerned, with the view to suggesting appropriate remedies.

Procedure 12

The Committee on Crime Prevention and Control shall assist the General Assembly, the Economic and Social Council and any other United Nations human rights bodies, as appropriate, with recommendations relating to reports of *ad hoc* inquiry commissions, with respect to matters pertaining to the application and implementation of the Standard Minimum Rules.

Commentary

As the Committee on Crime Prevention and Control is the relevant body to review the implementation of the Standard Minimum Rules, it should also assist the above-mentioned bodies.

Procedure 13

Nothing in the present implementing procedures should be construed as precluding resort to any other means or remedies available under international law or set forth by other United Nations bodies and agencies for the redress of violations of human rights, including the procedure on consistent patterns of gross violations of human rights under Economic and Social Council resolution 1503 (XLVIII) of 27 May 1970, the communication procedure under the Optional Protocol to the International Covenant on Civil and Political Rights¹¹² and the communication procedure under the International Convention on the Elimination of All Forms of Racial Discrimination. 113

Since the Standard Minimum Rules are only partly concerned with specific human rights issues, the present procedures should not exclude any avenue for redress of any violation of such rights, in accordance with existing international or regional standards and norms.

Crime prevention and criminal justice in the 1984/48. context of development

The Economic and Social Council,

Having considered the report of the Committee on Crime Prevention and Control in respect of crime trends, operations of criminal justice systems and crime prevention strategies in the context of social and economic change, and with respect to the different facets of development,114

Emphasizing the progress made towards the provision of assistance to Member States in improving national crime-related statistics, the establishment of a United Nations crime-related data base, and the long-term nature of such programmes of work,

- 1. Takes note, with appreciation, of the reports of the Secretary-General on the relationship between crime and specific socio-economic issues 115 and on crime trends and crime prevention strategies;116
- 2. Recommends the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders to give detailed consideration both to the further development of such studies, including specific questions such as the relationship between criminality and particular socio-economic factors, for example, the transmission of social values and changes in family functions, and to concrete problems of crime and criminal justice data, in the light of the Second United Nations Survey of Crime Trends, Operations of Criminal Justice Systems and Crime Prevention Strategies, and the proposed manual on the collection and analysis of crime statistics;
- 3. Requests the Secretary-General to submit a report on crime prevention and criminal justice in

relation to socio-economic change and development to the Committee on Crime Prevention and Control at its ninth session:

- 4. Also requests the Secretary-General to maintain and develop the United Nations crime-related data base by continuing to conduct quinquennial surveys of crime trends, operations of criminal justice systems and crime prevention strategies, and to report periodically to the Committee on Crime Prevention and Control on the progress made;
- 5. Further requests the Secretary-General to develop concrete projects of technical co-operation for assistance in the collection and analysis of criminal justice data to Member States requesting such assistance.

21st plenary meeting 25 May 1984

Fair treatment of women by the criminal 1984/49. justice system

The Economic and Social Council,

Having considered the report of the Secretary-General on the fair treatment of women by the criminal justice system,117

Taking into account resolution 9 of the Sixth United Nations Congress on the Prevention of Crime and the Treatment of Offenders, 118 on the specific needs of women prisoners,

- 1. Takes note of the report of the Secretary-General on the fair treatment of women by the criminal justice system;
- 2. Reaffirms resolution 9 of the Sixth United Nations Congress on the Prevention of Crime and the Treatment of Offenders, in particular paragraph 4 thereof, in which the Congress requested that, at future Congresses and their preparatory meetings, as well as in the work of the Committee on Crime Prevention and Control, time should be allotted for the study of women as offenders and victims;
- 3. Decides that the question of the fair treatment of women by the criminal justice system and the question of the situation of women as victims of crime should be included in the provisional agenda for the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders¹¹⁹ under the items entitled "Criminal justice processes and perspectives in a changing world" and "Victims of crime", respectively;
- 4. Requests the Secretary-General to submit reports on the two above-mentioned questions to the Seventh Congress.

1984/50. Safeguards guaranteeing protection of the rights of those facing the death penalty

The Economic and Social Council,

Having regard to the provisions bearing on capital punishment in the International Covenant on Civil and Political Rights, ¹²⁰ in particular article 2, paragraph 1, and articles 6, 14 and 15 thereof,

Recalling General Assembly resolution 38/96 of 16 December 1983, in which, inter alia, the Assembly expressed its deep alarm at the occurrence on a large scale of summary or arbitrary executions,

Recalling also General Assembly resolution 36/22 of 9 November 1981, in which the Committee on Crime Prevention and Control was requested to examine the problem with a view to making recommendations,

Recalling further Council resolution 1983/24 of 26 May 1983, in which it decided that the Committee on Crime Prevention and Control should further study the question of death penalties that did not meet the acknowledged minimum legal guarantees and safeguards, as contained in the International Covenant on Civil and Political Rights and other international instruments, and welcomed the intention of the Committee that the issue should be discussed at the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders,

Acknowledging the work done by the Commission on Human Rights and the Sub-Commission on Prevention of Discrimination and Protection of Minorities in the areas of summary or arbitrary executions, including the reports of the Special Rapporteur, 121

Considering the relevant views and comments of the Human Rights Committee established under the International Covenant on Civil and Political Rights,

Expressing its concern at the tragic incidence of arbitrary or summary executions in the world,

Having considered the note by the Secretary-General on arbitrary and summary executions, 122

Guided by the desire to continue to contribute to the strengthening of the international instruments relating to the prevention of arbitrary or summary executions.

- 1. Takes note of the note by the Secretary-General on arbitrary and summary executions;
- 2. Again strongly condemns and deplores the brutal practice of arbitrary or summary executions in various parts of the world;
- 3. Approves the safeguards guaranteeing protection of the rights of those facing the death penalty, recommended by the Committee on Crime Prevention and Control and annexed to the present resolution, on the understanding that they shall not be invoked to delay or to prevent the abolition of capital punishment;
- 4. Invites the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders to consider the safeguards with a view to establishing an implementation mechanism, within

the framework of the item of its provisional agenda¹²³ entitled "Formulation and application of United Nations standards and norms in criminal justice".

ANNEX

Safeguards guaranteeing protection of the rights of those facing the death penalty

- 1. In countries which have not abolished the death penalty, capital punishment may be imposed only for the most serious crimes, it being understood that their scope should not go beyond intentional crimes with lethal or other extremely grave consequences.
- 2. Capital punishment may be imposed only for a crime for which the death penalty is prescribed by law at the time of its commission, it being understood that if, subsequent to the commission of the crime, provision is made by law for the imposition of a lighter penalty, the offender shall benefit thereby.
- 3. Persons below 18 years of age at the time of the commission of the crime shall not be sentenced to death, nor shall the death sentence be carried out on pregnant women, or on new mothers, or on persons who have become insane.
- 4. Capital punishment may be imposed only when the guilt of the person charged is based upon clear and convincing evidence leaving no room for an alternative explanation of the facts.
- 5. Capital punishment may only be carried out pursuant to a final judgement rendered by a competent court after legal process which gives all possible safeguards to ensure a fair trial, at least equal to those contained in article 14 of the International Covenant on Civil and Political Rights, 124 including the right of anyone suspected of or charged with a crime for which capital punishment may be imposed to adequate legal assistance at all stages of the proceedings
- 6. Anyone sentenced to death shall have the right to appeal to a court of higher jurisdiction, and steps should be taken to ensure that such appeals shall become mandatory.
- 7. Anyone sentenced to death shall have the right to seek pardon, or commutation of sentence; pardon or commutation of sentence may be granted in all cases of capital punishment.
- 8. Capital punishment shall not be carried out pending any appeal or other recourse procedure or other proceeding relating to pardon or commutation of the sentence.
- 9. Where capital punishment occurs, it shall be carried out so as to inflict the minimum possible suffering.

1984/51. Technical co-operation in crime prevention and criminal justice

The Economic and Social Council,

Recalling General Assembly resolution 36/21 of 9 November 1981, in which the Assembly urged the Department of Technical Co-operation for Development of the United Nations Secretariat and the United Nations Development Programme to increase their level of support to programmes of technical assistance in the field of crime prevention and criminal justice, and to encourage technical co-operation among developing countries.

Recalling also General Assembly resolution 35/171 of 15 December 1980, in which the Assembly endorsed

the Caracas Declaration annexed thereto, wherein it was stressed that appropriate measures should be taken to strengthen, as necessary, the activities of the competent United Nations organs concerned with crime prevention and the treatment of offenders, especially activities at the regional and subregional levels.

Recalling further Economic and Social Council resolution 1979/20 of 9 May 1979, in which the Council took note, inter alia, of the growing number of countries that expressed a need for interregional and technical advisory services capable of assisting Governments in planning and implementing their crime prevention policies, and Council resolution 1979/21 of 9 May 1979,

Convinced of the crucial importance of international co-operation in crime prevention and criminal justice, both among developing countries and between developed and developing countries,

Conscious of the financial and other difficulties encountered by many countries in their efforts to introduce efficient and humane crime prevention policies,

Recognizing the vital role performed by the United Nations regional training and research institutes in effectively supporting various forms and modalities of technical co-operation despite serious financial and budgetary constraints,

Recognizing also the important role of the United Nations Social Defence Research Institute in United Nations efforts to strengthen research in an interregional context,

Aware that the existing interregional and regional institutes are heavily dependent for financial support on the host countries,

Noting that the post of Interregional Adviser in the area of crime prevention and criminal justice was reestablished in 1981,

Aware that, since the appointment of an Interregional Adviser in July 1982, Governments of developing countries have requested his advisory services on fifty-six occasions,

- 1. Takes note of the recommendations concerning regional and international co-operation in crime prevention and criminal justice contained in the resolutions adopted by the Asia and Pacific, 125 Latin American, 126 African 127 and Western Asia 128 Regional Preparatory Meetings for the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders;
- 2. Notes also that the African Regional Preparatory Meeting, in its resolution on subregional, regional and interregional co-operation in crime prevention and criminal justice, 127 viewed with great concern the delay in the establishment of an African regional

institute on the prevention of crime and the treatment of offenders;

- 3. Emphasizes the usefulness of regional cooperation as fostered by the United Nations Latin American Institute for the Prevention of Crime and the Treatment of Offenders, the United Nations Asia and Far East Institute for the Prevention of Crime and the Treatment of Offenders and the Helsinki Institute for Crime Prevention and Control, affiliated with the United Nations;
- 4. Urges the Secretary-General and all the organizations and agencies involved in the establishment of the institute for the African region to take steps to ensure its prompt creation, if possible before the Seventh United Nations Congress on the Prevention of Crime and the Treatment of Offenders, and also appeals to Governments in that region to co-operate fully and act expeditiously in this respect;
- 5. Recommends the regional commissions and the regional institutes to increase their co-operation in undertaking joint activities;
- 6. Requests the organs, organizations and bodies of the United Nations to strengthen appropriate arrangements for the support of technical co-operation in crime prevention and criminal justice between developed and developing countries and also among developing countries, in the spirit of the Buenos Aires Plan of Action for Promoting and Implementing Technical Co-operation among Developing Countries and General Assembly resolutions 35/171 and 36/21 and Economic and Social Council resolutions 1979/20 and 1979/21;
- 7. Urges the Secretary-General to ensure increased support for the critically needed interregional advisory services in the field of crime prevention and criminal justice, and to provide additional interregional and regional advisers as quickly as budgetary resources will permit, especially to serve the needs of those regions without regional institutes;
- 8. Also urges the Secretary-General to find appropriate means to strengthen the financial capacity of the existing interregional and regional institutes;
- 9. Calls upon Member States in each region, in considering crime prevention and criminal justice in the context of development, to encourage the exchange of data, information and experiences, to engage in joint activities for training and research, to assist in demonstration projects of a bilateral and multilateral nature, to enter into agreements on the provision of human, financial and material resources in support of regional and subregional seminars involving the various modalities of technical co-operation, and to encourage the involvement in such efforts of scientific and professional non-governmental organizations active in the field of crime prevention and criminal justice.

- 4. The Council decided that agenda items 1 to 8. 23 and 24 would be considered in plenary meeting, items 9 to 17 by the First (Economic) Committee and items 18 to 22 by the Third (Programme and Coordination) Committee.
 - 5. The Council also decided:
- (a) To give priority consideration, at its second regular session of 1984, to the critical economic situation in Africa;
- (b) To consider, at its first regular session of 1984, the question of the second priority issue for consideration at the second regular session of 1984, bearing in mind the text of the proposal made by the Chairman of the informal working group on priority items during the organizational session for 1984;
- (c) That an informal sessional working group of the whole, under the chairmanship of one of the Vice-Presidents of the Council, should review, during the first regular session of 1984, the draft guidelines on consumer protection, 132 and that the Vice-President should submit a report thereon to the Council at its second regular session of 1984 under the item entitled "International co-operation and co-ordination within the United Nations system", with a view to the adoption of the draft guidelines by the General Assembly at its thirty-ninth session;
- (d) To consider in detail, under the item entitled "Regional co-operation", in pursuance of paragraph 1 (h) of Council resolution 1982/50 of 28 July 1982 and taking into account the joint recommendations made by the executive secretaries of the regional commissions pursuant to Council decision 1982/174 of 30 July 1982, progress in the implementation of its resolution 1983/66 of 29 July 1983 on the promotion of interregional economic and technical co-operation among developing countries;
- (e) Not to consider draft proposals under the items entitled "Industrial development co-operation", "Development and utilization of new and renewable sources of energy" and "Operational activities for development", except for specific proposals requiring action by the Council contained in the reports of the intergovernmental bodies concerned; reports submitted to the General Assembly through the Economic and Social Council under these items shall be transmitted directly to the Assembly;
- (f) To welcome the positive response of the Council of the United Nations University, pursuant to Council decisions 1983/101 of 4 February 1983 and 1983/184 of 29 July 1983, in changing its annual reporting period in order to submit its report to the Economic and Social Council at its second regular session beginning in 1985;
- (g) To request the Secretary-General to transmit directly to the General Assembly at its thirty-ninth session, for consideration, the annual reports of the Trade and Development Board, the Human Rights Committee and the Council of the United Nations University; the Council will again consider in 1984, under the relevant agenda items, the rescheduling of the meetings of the Trade and Development Board and

the Human Rights Committee requested in paragraph 2 (i) of its decision 1983/101;

- (h) To review, within the context of its consideration of the items of the agenda of its regular sessions, in accordance with paragraph 1 (i) of Council resolution 1982/50 of 28 July 1982 and General Assembly resolution 38/32 E of 25 November 1983, all its recurrent and other documentation requested under an existing legislative authority, including publications, in order to determine whether any document has become redundant, has lost its usefulness or could be issued at less frequent intervals;
- (i) To request its subsidiary organs responsible for recurrent publications to review them with the objective of identifying and discontinuing those which no longer serve a useful purpose, bearing in mind the criteria set out in paragraph 17 of General Assembly resolution 38/32 E, and to report thereon to the Council;
- (j) To direct all its subsidiary bodies to take into consideration and, as required, act on the relevant resolutions and decisions adopted by the General Assembly at its thirty-eighth session.

At its 20th plenary meeting, on 24 May 1984, the Council, noting Commission on Human Rights resolution 1984/23 of 6 March 1984, 159 approved the Commission's decision to extend for one year the mandate of the Working Group on Enforced or Involuntary Disappearances, as laid down in Commission resolution 20 (XXXVI) of 29 February 1980. 164 The Council endorsed the Commission's request to the Secretary-General to continue to provide the Working Group with all necessary assistance, in particular the staff and resources it may require to perform its functions in an effective and expeditious manner and, if necessary, to make the appropriate arrangements to ensure the continuity of the Secretariat's work.

1984/136. Situation of human rights in El Salvador

At its 20th plenary meeting, on 24 May 1984, the Council, noting Commission on Human Rights resolution 1984/52 of 14 March 1984,¹⁵⁹ endorsed the Commission's decision to extend the mandate of the Special Representative on the situation of human rights in El Salvador for another year and to request him to submit his report on further developments in the situation of human rights in that country to the General Assembly at its thirty-ninth session and to the Commission at its forty-first session. The Council further endorsed the Commission's request to the Secretary-General to give all necessary assistance to the Special Representative of the Commission.

1984/137. Situation of human rights in Guatemala

At its 20th plenary meeting, on 24 May 1984, the Council, noting Commission on Human Rights resolution 1984/53 of 14 March 1984,159 endorsed the Commission's decision to extend the mandate of the Special Rapporteur on the situation of human rights in Guatemala for another year and to request him to report on the subsequent development of the situation of human rights in that country, taking into account developments in regard to the recommendations in his reports as well as information from other reliable sources, and to submit an interim report to the General Assembly at its thirty-ninth session and a final report to the Commission at its forty-first session. The Council further endorsed the Commission's request to the Secretary-General to give all necessary assistance to the Special Rapporteur.

1984/138. Situation of human rights in the Islamic Republic of Iran

At its 20th plenary meeting, on 24 May 1984, the Council, noting Commission on Human Rights resolution 1984/54 of 14 March 1984, 159 endorsed the Commission's decision to request its Chairman to appoint,

after consultation within the Bureau, a special representative of the Commission, whose mandate will be to establish contacts with the Government of the Islamic Republic of Iran and to make a thorough study of the human rights situation in that country based on such information as he may deem relevant, including comments and materials provided by the Government, containing conclusions and appropriate suggestions, to be submitted to the Commission at its forty-first session. The Council further endorsed the Commission's request to the Secretary-General to give all necessary assistance to the special representative of the Commission.

1984/139. Review of the work of the Sub-Commission on Prevention of Discrimination and Protection of Minorities

At its 20th plenary meeting, on 24 May 1984, the Council, noting Commission on Human Rights resolution 1984/60 of 15 March 1984,¹⁵⁹ noted the decision of the Sub-Commission on Prevention of Discrimination and Protection of Minorities to establish at its thirty-seventh session a working group to study in depth the working methods and the programme of work of the Sub-Commission, including its relationship with the Commission and the Secretariat, and endorsed the Commission's invitation for an exchange of views between a spokesman for that working group and the Commission or a working group of the Commission during the forty-first session of the Commission.

1984/140. Question of human rights in Chile

At its 20th plenary meeting, on 24 May 1984, the Council, noting Commission on Human Rights resolution 1984/63 of 15 March 1984, 159 endorsed the Commission's decision to extend the mandate of the Special Rapporteur on the situation of human rights in Chile for another year and to request him to report on the situation of human rights in that country to the General Assembly at its thirty-ninth session and to the Commission at its forty-first session. The Council requested the Secretary-General to make appropriate arrangements to ensure that the necessary financial resources and sufficient staff are provided to implement the resolution of the Commission.

1984/141. Measures to combat racism and racial discrimination

At its 20th plenary meeting, on 24 May 1984, the Council, noting Commission on Human Rights decision 1984/107 of 12 March 1984,¹⁵⁹ decided that the report prepared by Mr. Abu Sayeed Chowdhury, Special Rapporteur of the Sub-Commission on Prevention of Discrimination and Protection of Minorities, entitled "Study on discriminatory treatment of members of racial, ethnic, religious or linguistic groups at the various levels in the administration of criminal justice, such as police, military, administrative and judicial investigations, arrest, detention, trial and execution of sentences, including the ideologies or beliefs which contribute or lead to racism in the administration of criminal justice". ¹⁶⁵ in accordance with section A of

1984/142. Principles, guidelines and guarantees for the protection of persons detained on grounds of mental ill-health or suffering from mental disorder

At its 20th plenary meeting, on 24 May 1984, the Council, noting Commission on Human Rights decision 1984/108 of 13 March 1984, 159 decided that the report entitled "Principles, guidelines and guarantees for the protection of persons detained on grounds of mental ill-health or suffering from mental disorder" should be published, without annex III, and given the widest possible distribution in all the official languages of the United Nations.

1984/143. Study of situations which appear to reveal a consistent pattern of gross violations of human rights as provided in Commission on Human Rights resolution 8 (XXIII) and Economic and Social Council resolutions 1235 (XLII) and 1503 (XLVIII)

At its 20th plenary meeting, on 24 May 1984, the Council, noting Commission on Human Rights decision 1984/109 of 1 March 1984,159 decided to request the Secretary-General to continue his consultations with the Government of Haiti, as envisaged in his report to the Commission, with a view to further exploring ways and means of providing the Government of Haiti with assistance to facilitate the realization of full enjoyment of human rights for the people of Haiti, and to report to the Commission at its fortyfirst session on the implementation of the present decision.

1984/144. Organization of the work of the Commission on Human Rights

At its 20th plenary meeting, on 24 May 1984, the Council, noting Commission on Human Rights decision 1984/113 of 16 March 1984,159 decided to authorize, if possible within the existing financial resources, twenty fully-serviced additional meetings. including summary records, for the Commission's forty-first session. The Council took note of the Commission's decision to request its Chairman at the forty-first session to make every effort to organize the work of the session within the normal allotted time, the additional meetings authorized by the Council to be utilized only if such meetings prove to be absolutely necessary.

At its 20th plenary meeting, on 24 May 1984, the Council took note of the report of the Commission on Human Rights on its fortieth session. 168

1984/148. Right of peoples to self-determination and its application to peoples under colonial or alien domination or foreign occupation

At its 20th plenary meeting, on 24 May 1984, the Council fully endorsed Commission on Human Rights resolution 1984/12 of 29 February 1984,159 by which the Commission, inter alia, reaffirmed that the continuing occupation of Kampuchea by foreign forces deprived the people of Kampuchea of the exercise of their right to self-determination and constituted the primary violation of human rights in Kampuchea at present. The Council reaffirmed its decisions 1981/154 of 8 May 1981, 1982/143 of 7 May 1982 and 1983/155 of 27 May 1983 and reiterated its call for the withdrawal of all foreign forces from Kampuchea in order to allow the people of Kampuchea to exercise their fundamental freedoms and human rights, including the right to selfdetermination as contained in the Declaration on Kampuchea adopted by the International Conference on Kampuchea on 17 July 1981169 and in General Assembly resolutions 34/22 of 14 November 1979, 35/6 of 22 October 1980, 36/5 of 21 October 1981, 37/6 of 28 October 1982 and 38/3 of 27 October 1983.

The Council expressed its grave concern at the activities of the foreign forces in Kampuchea, particularly the continuing attacks on Kampuchean civilian encampments along the Thai-Kampuchean border, resulting in serious loss of life and property of Kampucheans and forcing even larger numbers of Kampuchean civilians to flee into Thailand.

The Council took note with appreciation of the note by the Secretary-General, 170 prepared pursuant to its

decision 1983/155, requested him to report to the Council any further violations of humanitarian principles perpetrated against Kampuchean civilian refugees by the foreign occupying troops along the border, and also requested him to continue to monitor closely the developments in Kampuchea and to intensify efforts, including the use of his good offices, to bring about a comprehensive political settlement of the Kampuchean problem and the restoration of fundamental human rights in Kampuchea.

The Council noted with appreciation the ongoing efforts of the Ad Hoc Committee of the International Conference on Kampuchea and requested that the Committee continue its work, pending the reconvening of the Conference.
