At its 12th meeting, on 24 May 2007, the Economic and Social Council, recalling its resolution 2006/46 of 28 July 2006, entitled "Follow-up to the World Summit on the Information Society and review of the Commission on Science and Technology for Development", and its decision 2007/208 of 2 March 2007, containing the provisional agenda and documentation for the tenth session of the Commission on Science and Technology for Development, took note of the report of the Commission on Science and Technology for Development on its ninth session, and encouraged the Commission to continue, within its mandate and agenda, its consideration of such matters.
