Decision 2010/201 A Elections to the Committee for the United Nations Population Award

At its 2nd plenary meeting, on 9 February 2010, the Economic and Social Council elected **Egypt, Ghana, Malaysia and Norway** to fill postponed vacancies on the Committee for the United Nations Population Award for a term beginning on the date of election and expiring on 31 December 2012.

2010/201 B Elections, nominations and appointments to subsidiary and related bodies of the Economic and Social Council

At its 8th and 9th plenary meetings, on 28 April 2010, the Economic and Social Council took the following action with regard to vacancies in its subsidiary and related bodies:

Elections

Commission on Population and Development

The Council elected the following four Member States for a four-year term beginning at the first meeting (to be held in 2011) of the Commission's forty-fifth session and expiring at the close of the Commission's forty-eighth session, in 2015: **Algeria, Gabon, Georgia and United States of America.**

The Council postponed the election of two members from Asian States and two members from Latin American and Caribbean States for a four-year term beginning at the first meeting of the Commission's forty-fifth session and expiring at the close of the Commission's forty-eighth session.

Commission for Social Development

The Council elected the following nine Member States for a four-year term beginning at the first meeting (to be held in 2011) of the Commission's fiftieth session and expiring at the close of the Commission's fifty-third session in 2015: **Andorra, Burkina Faso, Cameroon, Cuba, Egypt, Mexico, Peru, Spain and Zimbabwe.**

The Council postponed the election of three members from Asian States, one member from Eastern European States and one member from Western European and other States for a four-year term beginning at the first meeting of the Commission's fiftieth session and expiring at the close of the Commission's fifty-third session.

Commission on the Status of Women

The Council elected the following eleven Member States for a four-year term beginning at the first meeting (to be held in 2011) of the Commission's fifty-sixth session and expiring at the close of the Commission's fifty-ninth session in 2015:

Belgium, Democratic Republic of the Congo, Estonia, Georgia, Iran (Islamic Republic of), Jamaica, Liberia, Netherlands, Spain, Thailand and Zimbabwe.

Commission on Sustainable Development

The Council elected the following nineteen Member States for a three-year term beginning at the first meeting (to be held in 2011) of the Commission's twentieth session and expiring at the close of the Commission's twenty-second session in 2014: **Angola, Armenia, Belgium, Botswana, Brazil, Congo, El Salvador, Equatorial Guinea, Germany, Indonesia, Italy, Japan, Lebanon, Lesotho, Mexico, Montenegro, Nicaragua, Saudi Arabia and Spain.**

The Council postponed the election of one member from Western European and other States for a three-year term beginning at the first meeting of the Commission's twentieth session and expiring at the close of the Commission's twenty-second session.

Commission on Science and Technology for Development

The Council elected the following sixteen Member States for a four-year term beginning on 1 January 2011: **China, Cuba, Dominican Republic, El Salvador, India, Iran (Islamic Republic of), Latvia, Lesotho, Mauritius, Peru, Philippines, Rwanda, Togo, Tunisia, United Republic of Tanzania and United States of America.**

The Council postponed the election of one member from Asian States, two members from Eastern European States and four members from Western European and other States for a four-year term beginning on 1 January 2011.

Committee on Non-Governmental Organizations

The Council elected the following nineteen Member States for a four-year term beginning on 1 January 2011: **Belgium, Bulgaria, Burundi, China, Cuba, India, Israel, Kyrgyzstan, Morocco, Mozambique, Nicaragua, Pakistan, Peru, Russian Federation, Senegal, Sudan, Turkey, United States of America and Venezuela (Bolivarian Republic of).**

Intergovernmental Working Group of Experts on International Standards of Accounting and Reporting

The Council elected **France, Niger and Portugal** to fill outstanding vacancies on the Intergovernmental Working Group for a term beginning on the date of election and expiring on 31 December 2011, and **Poland** and **Saint Kitts and Nevis** to fill outstanding vacancies for a term beginning on the date of election and expiring on 31 December 2012.

The Council further postponed the election of three members from Latin American and Caribbean States and four members from Western European and other States for a term beginning on the date of election and expiring on 31 December 2011 and four members from Asian States, one member from Eastern European States and one member from Latin American and Caribbean States for a term beginning on the date of election and expiring on 31 December 2012.

Committee on Economic, Social and Cultural Rights

The Council elected the following nine experts for a four-year term beginning on 1 January 2011: Aslan **Abashidze** (Russian Federation), Clément **Atangana** (Cameroon), Chandrashekhar **Dasgupta** (India), Azzouz **Kerdoun** (Algeria), Jaime **Marchán Romero** (Ecuador), Renato Zerbini **Ribeiro Leão** (Brazil), Eibe **Riedel** (Germany), Heisoo **Shin** (Republic of Korea) and Álvaro **Tirado Mejía** (Colombia).

The Council also decided that, on an exceptional basis, the Group of Latin American and Caribbean States would be allocated the third rotating seat on the Committee for the four-year term beginning on 1 January 2011 and that the Group of Western European and other States would be allocated the same seat for the four-year term beginning on 1 January 2015, and that such arrangement would not be affected by the number of ratifications to the International Covenant on Economic, Social and Cultural Rights received by any regional group during that eight-year period.

Permanent Forum on Indigenous Issues

The Council elected the following eight members for a three-year term beginning on 1 January 2011: Eva **Biaudet** (Finland), Megan **Davis** (Australia), Paimaneh **Hasteh** (Islamic Republic of Iran), Helen **Kaljuläte** (Estonia), Mirian **Masaquiza** (Ecuador), Simon William **M'Viboudoulou** (Congo), Andrey A. **Nikiforov** (Russian Federation) and Álvaro Esteban **Pop Ac** (Guatemala).

Pursuant to Economic and Social Council resolution 2000/22 of 28 July 2000, the President of the Council appointed the following eight members for a three-year term beginning on 1 January 2011: Mirna **Cunningham Kain** (Nicaragua), Raja **Devashish Roy** (Bangladesh), Dalee Sambo **Dorough** (United States of America), Edward **John** (Canada), Anna **Naikanchina** (Russian Federation), Paul Kanyinke **Sena** (Kenya), Valmaine **Toki** (New Zealand) and Saúl **Vicente Vázquez** (Mexico).

Executive Board of the United Nations Children's Fund

The Council elected the following eleven Member States for a three-year term beginning on 1 January 2011: **Antigua and Barbuda, China, Colombia, Estonia, Indonesia, Italy, Namibia, Netherlands, New Zealand, Russian Federation and United Kingdom of Great Britain and Northern Ireland.**

The Council also elected the following Member States to replace members of the Executive Board who were resigning their seats effective 1 January 2011: **Japan** to complete the term of office of Iceland (expiring 31 December 2011), **Belgium** to complete the term of office of Norway (expiring 31 December 2011), **Spain** to complete the term of office of Switzerland (expiring 31 December 2011), **Germany** to complete the term of office of Ireland (expiring 31 December 2012) and **Sweden** to complete the term of office of Luxembourg (expiring 31 December 2012).

Executive Committee of the Programme of the United Nations High Commissioner for Refugees

The Council elected **Slovenia** to fill a new seat on the Executive Committee in accordance with General Assembly resolution 64/128 of 18 December 2009.

**Executive Board of the United Nations Development Programme/
United Nations Population Fund**

The Council elected the following eleven Member States for a three-year term beginning on 1 January 2011: **Argentina, Bangladesh, Belarus, Canada, China, Czech Republic, Djibouti, El Salvador, Finland, Luxembourg and United States of America.**

The Council also elected the following Member States to replace members of the Executive Board who were resigning their seats effective 1 January 2011: **Denmark** to complete the term of office of Austria (expiring 31 December 2011), **Germany** to complete the term of office of Belgium (expiring 31 December 2011), **Italy** to complete the term of office of France (expiring 31 December 2012), **Ireland** to complete the term of office of Spain (expiring 31 December 2012) and **Estonia** to complete the term of office of Slovenia (expiring 31 December 2012).

Executive Board of the World Food Programme

At its 8th meeting, on 28 April 2010, the Economic and Social Council decided, with regard to the event to discuss transition from relief to development, that:

- (a) The title of the event would be “From relief to recovery, lessons learned from the experience of Haiti”;
- (b) The event would be an informal activity held in the afternoon of 13 July 2010;
- (c) The event would consist of one panel discussion and there would be no negotiated outcome.
