# Annotated agenda for the 2016 session of the Economic and Social Council

The Economic and Social Council, in its decision 2016/202, adopted the provisional agenda for its 2016 session.

Section I of the present document reflects the list of items on the agenda for the 2016 session of the Council (E/2016/1). Section II contains the annotations for the items. The annotations are intended to provide a brief history of each item and to indicate, where applicable, the documentation that is to be made available during the course of the session. The present document does not include items that are considered by the Council on a biennial basis.<sup>1</sup>

The Council, in its resolution 2016/1, adopted the working arrangements for its 2016 session, which includes the coordination and management meetings, the operational activities for development segment, the integration segment, the humanitarian affairs segment, the high-level segment, and the high-level political forum on sustainable development, convened under the auspices of the Council.

The Council is to further update its working arrangements for the 2016 session to revise the dates of some meetings as originally decided in its resolution 2016/1 and to include additional meetings as requested by the General Assembly in its resolutions 69/313 on the Addis Ababa Action Agenda of the Third International Conference on Financing for Development, 70/1 on the 2030 Agenda for Sustainable Development and 70/192 on the follow-up to the International Conference on Financing for Development.

# II. Annotations

# 1. Election of the Bureau

Pursuant to General Assembly resolution 68/1, the programme of work of the Economic and Social Council is on a July-to-July cycle. The term of office of the officers of the Council (the Bureau) for the 2016 session will be from the date of their election until the date of election of their successors, in accordance with rule 19 of the rules of procedure of the Council. In accordance with the principle of equitable geographical rotation of the office of the President among the regional groups, the President of the Council at its 2016 session should be from the Asia-Pacific States. The four Vice-Presidents of the Council will be elected from the other regional groups.

In its decision 2016/200 A, the Council elected by acclamation Oh Joon of the Republic of Korea as President of the Council, and Frederick Musiiwa Makamure Shava of Zimbabwe, Vladimir Drobnjak of Croatia, María Cristina Perceval of Argentina and Paul Seger of Switzerland as Vice-Presidents of the Council for its 2016 session.

In its decision 2016/200 B, the Council elected by acclamation Sven Jürgenson of Estonia and Jürg Lauber of Switzerland as Vice-Presidents of the Council, to complete the term of office of Vladimir Drobnjak (Croatia) and Paul Seger (Switzerland), respectively.

In its decision 2016/200 C, the Council elected by acclamation Héctor Alejandro Palma Cerna of Honduras as Vice-President of the Council to complete the term of office of María Cristina Perceval (Argentina).

On the recommendation of the President, the Council, in its decision 2016/203, decided on the special responsibilities of the Bureau for the 2016 session.

# 5. High-level segment

The General Assembly, in its resolution 68/1, decided that a high-level segment will be held in July. It will continue to discharge the functions of the high-level segment of the Council as provided for in General Assembly resolutions 45/264, 48/162, 50/227 and 61/16.

Pursuant to General Assembly resolution 68/1, the Council will hold an annual dialogue with the Executive Secretaries of the regional commissions.

The Council, in its resolution 2015/11, requested the Committee for Development Policy, at its eighteenth session (14-18 March 2016), to examine and make recommendations on the annual theme of the 2016 session of the Council.

The Council, in its decision 2015/203, decided that the theme for the 2016 session would be "Implementing the post-2015 development agenda: moving from commitments to results".

# (b) High-level policy dialogue with international financial and trade institutions

In accordance with General Assembly resolutions 48/162 and 61/16, the Council will hold a high-level policy dialogue with the executive heads of international financial and trade institutions on current developments in the world economy during its high-level segment.

# (c) Development Cooperation Forum

Pursuant to General Assembly resolutions 60/1, 61/16 and 68/1, the Council will hold its biennial high-level Development Cooperation Forum to review trends in international development cooperation, including strategies, policies and financing, promote greater coherence among the development activities of different development partners and strengthen the links between the normative and operational work of the United Nations.

Pursuant to General Assembly resolutions 60/1, 61/16 and 68/1, the Council continues to promote global dialogue, inter alia, by strengthening existing arrangements, including a thematic discussion on a theme from the economic, social and related fields to be decided by the Council and informed by a report of the Secretary-General.

The Council is to decide at a later date on the theme of the thematic discussion to be held during the high-level segment of its 2016 session.

# 6. High-level political forum on sustainable development, convened under the auspices of the Economic and Social Council

The General Assembly, in its resolution 67/290, decided that the high-level political forum on sustainable development under the auspices of the Council would be convened annually by the President of the Council and would have a thematic focus reflecting the integration of the three dimensions of sustainable development, in line with the thematic focus of the activities of the Council and consistent with the post-2015 development agenda.

Pursuant to General Assembly resolution 70/1, the high-level political forum, under the auspices of the Council, will carry out regular reviews, in line with Assembly resolution 67/290; follow-up and review at the high-level political forum will be informed by an annual progress report on the Sustainable Development Goals to be prepared by the Secretary-General in cooperation with the United Nations system and the *Global Sustainable Development Report*.

The General Assembly, in its resolution 70/1, invited the President of the Council to conduct a process of consultations on the scope, methodology and frequency of the *Global Sustainable Development Report* as well as its relation to the progress report on the Sustainable Development Goals, the outcome of which should be reflected in the ministerial declaration of the session of the high-level political forum in 2016.

The General Assembly, in its resolution 67/290, invited the regional commissions to contribute to the work of the high-level political forum on sustainable development convened under the auspices of the Economic and Social Council, including through annual regional meetings.

Pursuant to General Assembly resolutions 69/313 and 70/1, the meetings of the high-level political forum will be informed by the summary of the multi-stakeholder forum on science, technology and innovation for the Sustainable Development Goals.

Pursuant to General Assembly resolutions 69/313, 70/1 and 70/192, the intergovernmentally agreed conclusions and recommendations of the Council forum on financing for development follow-up will be fed into the overall follow-up and review of the implementation of the 2030 Agenda for Sustainable Development in the high-level political forum.

The General Assembly, in its resolutions 69/214 and 70/201, reiterated the call of the United Nations Conference on Sustainable Development and in the 2030 Agenda for Sustainable Development for the further mainstreaming of the three dimensions of sustainable development throughout the United Nations system, and in this regard invited the Secretary-General to continue to report to the Assembly, through the Economic and Social Council, on the progress made, including for the consideration of the high-level political forum on sustainable development.

The General Assembly, in its resolution 70/201, affirmed that due consideration should continue to be given to sustainable consumption and production at the meetings of the high-level political forum on sustainable development held under the auspices of the Council. The high-level political forum on sustainable development will therefore continue to consider reports from the board and the secretariat of the 10-year framework of programmes on sustainable consumption and production patterns, as elaborated in the 10-year framework of programmes.

The General Assembly, in its resolution 70/125, invited the high-level political forum on sustainable development to consider the annual reports of the Commission on Science and Technology for Development.

The General Assembly, in its resolution 70/204, decided to give due consideration to the review of the global progress in the implementation of the Sendai Framework as part of the processes of integrated and coordinated follow-up to United Nations conferences and summits, aligned with the Economic and Social Council, the high-level political forum on sustainable development and the quadrennial comprehensive policy review cycles, as appropriate, taking into account the contributions of the Global Platform for Disaster Risk Reduction and regional platforms for disaster risk reduction and the updated monitoring tool based on the Hyogo Framework for Action Monitor.

The General Assembly, in its resolution 70/202, recalled paragraph 11 of its resolution 67/290, paragraph 123 of the Samoa Pathway and paragraph 16 of its resolution 69/217, and noted that the high-level political forum shall devote adequate time at its 2016 meeting and at its future meetings to continuing to address the sustainable development challenges facing small island developing States and the follow-up to and implementation of the Samoa Pathway, and further encouraged the high-level political forum to devote sufficient attention to these discussions, bearing in mind that small island developing States are a special case for sustainable development, as well as lessons learned from the follow-up and review processes of previous conferences on small island developing States and their outcome documents.

# 7. Operational activities of the United Nations for international development cooperation

The General Assembly, in its resolution 67/226, and the Council, in its resolution 2015/15, requested the Secretary-General to submit a report on the quadrennial comprehensive policy review of operational activities for development of the United Nations system.

# (c) South-South cooperation for development

Pursuant to General Assembly resolutions 33/134 and 58/220, the High-level Committee on South-South Cooperation meets once every two years in odd numbered years and reports to the Assembly through the Executive Board of the United Nations Development Programme/United Nations Population Fund/United Nations Office for Project Services and the Council.

At its eighteenth session, the High-level Committee on South-South Cooperation, in its decision 18/2, approved the provisional agenda for its nineteenth session, to be held in 2016. The Council will therefore consider the report of the nineteenth session of the Committee at its 2016 session.

# 8. Integration segment

Pursuant to General Assembly resolution 68/1, an integration segment is held annually, the timing and modalities of which are decided by the Council. The main functions of the segment are to consolidate all the inputs of Member States, the subsidiary bodies of the Council, the United Nations system and other relevant stakeholders and to promote the balanced integration of the three dimensions of sustainable development. The integration segment brings together the key messages from the Council system on the main theme and develops action-oriented recommendations for follow-up.

The Council, in its decision 2016/206, decided that the theme of the integration segment of its 2016 session would be "Implementing the 2030 Agenda for Sustainable Development through policy innovation and integration".

# 9. Special economic, humanitarian and disaster relief assistance

In accordance with General Assembly resolution 52/12 B, by which the Assembly established a humanitarian affairs segment of the Economic and Social Council, and pursuant to paragraph 11 (b) of the annex to General Assembly resolution 68/1, a humanitarian affairs segment will be held in June, through which the Council should continue to contribute to strengthening the coordination and effectiveness of United Nations humanitarian assistance and support and complement international efforts aimed at addressing humanitarian emergencies, including natural disasters, in order to promote an improved, coordinated response by the United Nations. The Council should also continue to hold a special event to discuss the transition from relief to development, to be convened immediately preceding the humanitarian affairs segment and following the annual session of the executive boards of the funds and programmes of the United Nations system.

# 10. The role of the United Nations system in implementing the ministerial declaration of the high-level segment of the substantive session of the Economic and Social Council

In its resolution 45/264, the General Assembly requested the Secretary-General to implement the recommendations addressed to him in the annex to the resolution, which included the recommendation that the substantive session of the Council be organized under segments, including a coordination segment, and that the coordination segment focus on the coordination of the activities of the specialized agencies, organs, organizations and bodies of the United Nations system in the economic, social and related fields, in accordance with Articles 63 and 64 of the Charter of the United Nations. In its resolution 2008/29, the Council requested the Secretary-General to submit a report on measures taken to implement the annual ministerial declaration of the high-level segment of the Council for consideration by the Council at the coordination segment of its substantive session of the following year. In its resolution 68/1, the Assembly decided that dedicated coordination and management meetings would be held regularly to perform the functions of the coordination and general segments.

# 11. Implementation of and follow-up to major United Nations conferences and summits

At the United Nations Conference on Sustainable Development, the United Nations system was requested to mainstream the economic, social and environmental dimensions of sustainable development throughout its work. The General Assembly, in its resolutions 69/214 and 70/201, invited the Secretary-General to continue to report to the General Assembly, through the Council, on progress made in further mainstreaming the three dimensions of sustainable development throughout the United Nations system.

In its decision 2011/217, the Council invited the Chair of the Committee on World Food Security to transmit to the Council annually, starting in 2012, a report on the main decisions and policy recommendations made as well as the results achieved by the Committee in the area of food security and nutrition, in accordance with its new roles and vision.

# (a) Follow-up to the International Conference on Financing for Development

Pursuant to General Assembly resolution 69/313 the Economic and Social Council will hold an annual forum on financing for development follow-up, consisting of up to five days, one of which will be the special high-level meeting with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development and up to four days of which will be dedicated to discussing the follow-up and review of the financing for development outcomes and the means of implementation of the post-2015 development agenda. The forum's intergovernmentally agreed conclusions and recommendations will be fed into the overall follow-up and review of the implementation of the post-2015 development agenda in the high-level political forum on sustainable development.

The General Assembly, in its resolution 70/192, decided that the sessions of the forum would be held at United Nations Headquarters in New York in the spring and that its inaugural session would be held in 2016. It also decided that the forum would be chaired by the President of the Council, who would take the steps necessary to prepare the work of the forum according to paragraph 132 of the Addis Ababa Action Agenda.

The Council, in its resolution 2015/35, requested the Secretary-General to submit to it a progress report on the implementation of the Programme of Action for the Least Developed Countries for the Decade 2011-2020.

The General Assembly, in its resolution 69/231, invited the Economic and Social Council to consider the issue of the comprehensive high-level midterm review of the implementation of the Programme of Action for the Least Developed Countries as part of its coordination and management meetings in 2016. In its resolution 62/220, the General Assembly decided that the Assembly, through its role in policy formulation, the Council, through its role in overall guidance and coordination, in accordance with their respective roles under the Charter and Assembly resolution 50/227, and the Human Rights Council should constitute a three-tiered intergovernmental process for the comprehensive implementation of and follow-up to the Durban Declaration and Programme of Action, adopted by the World Conference against Racism, Racial Discrimination, Xenophobia and Related Intolerance. In the same resolution, the Assembly reaffirmed that the Human Rights Council should continue to have a central role in the monitoring of the implementation of the Durban Declaration and Programme of Action within the United Nations system and in advising the Assembly thereon.

# Working arrangements for the 2016 session of the Economic and Social Council

As set out in Council resolution 2016/1:

- (a) The coordination and management meetings will be held from 4 to 6 April 2016; from 1 to 3 June 2016; and from 25 to 27 July 2016;
  - (b) The youth forum will be held on 1 and 2 February 2016;
- (c) The operational activities for development segment will be held from 22 to 24 February 2016;
  - (d) The partnership forum will be held on 31 March 2016;
- (e) The special high-level meeting of the Council with the World Bank, the International Monetary Fund, the World Trade Organization and the United Nations Conference on Trade and Development will be held on 18 and 19 April 2016;
- (f) The one-day special meeting of the Council on international cooperation in tax matters will be held on 22 April 2016;
  - (g) The integration segment will be held from 2 to 4 May 2016;
  - (h) The humanitarian affairs segment will be held from 20 to 22 June 2016;
- (i) The high-level political forum on sustainable development, convened under the auspices of the Council, will be held from 11 to 15 July 2016; the three-day ministerial meeting of the forum will be held from 18 to 20 July 2016;
- (j) The high-level segment, including the three-day ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Council, and the biennial Development Cooperation Forum, will be held from 18 to 22 July 2016;
- (k) The organizational session regarding the programme of work of the Council from July 2016 to July 2017 will be held on 28 and 29 July 2016.

The Council, in its decision 2016/207, and recalling its resolution 2016/1, in particular paragraph (h), by which it had decided to hold the humanitarian affairs segment of its 2016 session from 20 to 22 June 2016, decided to change the dates for holding the segment to the period from 27 to 29 June 2016.

The Council, in its decision 2016/208, and recalling General Assembly resolutions 69/313 and 70/1 and its resolution 2016/1, decided that the multi-stakeholder forum on science, technology and innovation for the Sustainable Development Goals will be held on 6 and 7 June 2016.
