## Annotated agenda for the 2017 session of the Economic and Social Council

The Economic and Social Council, in its decision 2017/202, adopted the provisional agenda for its 2017 session (E/2017/1).

Section I of the present document reflects the list of items on the agenda for the 2017 session of the Council. Section II contains the annotations for the items. The annotations are intended to provide a brief history of each item and to indicate, where applicable, the documentation that is to be made available during the course of the session. The present document does not include items that are considered by the Council on a biennial basis.<sup>1</sup>

The Council, in its resolution 2017/1, adopted the working arrangements for its 2017 session, which includes the coordination and management meetings, the operational activities for development segment, the integration segment, the humanitarian affairs segment, the high-level segment, and the high-level political forum on sustainable development, convened under the auspices of the Council.

The Council further updated its working arrangements for the 2017 session by determining that the one-day special meeting of the Council on international cooperation in tax matters would be held on 7 April 2017 (Council decision 2017/209)<sup>2</sup> and that the Economic and Social Council forum on financing for development follow-up, including the special high-level meeting with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development, would be held from 22 to 25 May 2017 (Council decision 2017/206).<sup>3</sup>

The updated working arrangements for the 2017 session are set out in the annex.

## **II.** Annotations

## **1. Election of the Bureau**

Pursuant to General Assembly resolution 68/1, the programme of work of the Economic and Social Council is on a July-to-July cycle. The term of office of the officers of the Council (the Bureau) for the 2017 session will be from the date of their election until the date of election of their successors, in accordance with rule 19 of the rules of procedure of the Council. In accordance with the principle of equitable geographical rotation of the office of the President among the regional groups, the President of the Council at its 2017 session should be from the African States. The four Vice-Presidents of the Council will be elected from the other regional groups.

In its decision 2017/200 A, the Council elected by acclamation Frederick Musiiwa Makamure Shava of Zimbabwe as President of the Council, and Marie Chatardová of Czechia, Cristián Barros Melet of Chile and Heiko Thoms of Germany as Vice-Presidents of the Council for its 2017 session.

In its decision 2017/200 B, the Council elected by acclamation Nabeel Munir of Pakistan as Vice-President of the Council for its 2017 session.

In its decision 2017/200 C, the Council elected by acclamation Jürgen Schulz of Germany as Vice-President of the Council to complete the term of office of Heiko Thoms (Germany).

On the recommendation of the President, the Council, in its decision 2017/203, decided on the following special responsibilities of the Bureau for the 2017 session: the President, Frederick Musiiwa Makamure Shava (Zimbabwe), would be responsible for the high-level segment and the high-level political forum on sustainable development for 2017, convened under the auspices of the Council, as well as the multi-stakeholder forum on science, technology and innovation for the Sustainable Development Goals and the forum on financing for development forlow-up; the Vice-President, Cristián Barros Melet (Chile), would be responsible for the operational activities for development segment; the Vice-President, Nabeel Munir (Pakistan), would be responsible for the integration segment; the Vice-President, Jürgen Schulz (Germany), would be responsible for the humanitarian affairs segment; and the Vice-President, Marie Chatardová (Czechia), would be

responsible for the coordination and management meetings, including the elections to fill vacancies in the Council's subsidiary bodies.

## 2. Adoption of the agenda and other organizational matters

The Council, at the 1st meeting of its 2017 session, on 28 July 2016, adopted the provisional agenda for the session (E/2017/1; Council decision 2017/202).

Pursuant to General Assembly resolution 68/1 and taking into account General Assembly resolution 70/299, the Council, in its decision 2017/208,<sup>4</sup> decided that the main theme for its 2017 session would be "Eradicating poverty in all its forms and dimensions through promoting sustainable development, expanding opportunities and addressing related challenges".

## 3. Basic programme of work of the Council

Pursuant to Council resolution 1988/77 on the revitalization of the Council, the President, with the cooperation of the other members of the Bureau, arranges consultations with members of the Council on the draft programme of work and makes proposals thereon for consideration by the Council.

Pursuant to Council decision 2006/206 on adapting the work of the Council, the President of the Council convenes consultations of the Council, on an "as available" basis, to adapt its organization of work and current methods of work in pursuance of the provisions set out in General Assembly resolutions 60/1, 61/16 and 68/1.

## 5. High-level segment

The General Assembly, in its resolution 68/1, decided that a high-level segment will be held in July. It will continue to discharge the functions of the high-level segment of the Council as provided for in General Assembly resolutions 45/264, 48/162, 50/227, 61/16 and 70/299.

Pursuant to Council resolution 2017/1, the high-level segment, including the threeday ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Council, will be held from 17 to 20 July 2017.

## (a) Ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Economic and Social Council

Pursuant to paragraph 11 (c) of the annex to General Assembly resolution 68/1 and paragraph 18 of General Assembly resolution 70/299, the three-day ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Council, will be held during the high-level segment of the Council in order to avoid duplication, enhance efficiency and strengthen complementarity and synergy.

## (b) High-level policy dialogue with international financial and trade institutions

In accordance with General Assembly resolutions 48/162 and 61/16, the Council will hold a high-level policy dialogue with the executive heads of international financial and trade institutions on current developments in the world economy during its high-level segment.

Pursuant to General Assembly resolutions 60/1, 61/16 and 68/1, the Council continues to promote global dialogue, inter alia, by strengthening existing arrangements, including a thematic discussion on a theme from the economic, social and related fields to be decided by the Council and informed by a report of the Secretary-General.

## 6. High-level political forum on sustainable development, convened under the auspices of the Economic and Social Council

The General Assembly, in its resolution 67/290, decided that the high-level political forum on sustainable development under the auspices of the Council would be convened annually by the President of the Council and would have a thematic focus reflecting the integration of the three dimensions of sustainable development, in line with the thematic focus of the activities of the Council and consistent with the 2030 development agenda. The theme of the high-level political forum on sustainable development to be convened under the auspices of the Council during its 2017 session is "Eradicating poverty and promoting prosperity in a changing world" (General Assembly resolution 70/299).

Pursuant to General Assembly resolutions 67/290 and 70/1, the high-level political forum, under the auspices of the Council, would carry out regular thematic reviews on the follow-up and implementation of sustainable development commitments and objectives, including those related to the means of implementation, within the context of the 2030 Agenda for Sustainable Development. In its resolution 70/299, the General Assembly further decided that the high-level political forum under the auspices of the Council, without prejudice to the integrated, indivisible and interlinked nature of the Sustainable Development Goals, should discuss a set of Goals and their interlinkages, with a view to facilitating an in-depth review of progress made on all Goals over the course of a four-year cycle, with means of implementation, including with respect to Goal 17, reviewed annually.

For the high-level political forum on sustainable development to be convened under the auspices of the Council during its 2017 session, the General Assembly decided, in its resolution 70/299, that Sustainable Development Goals 1, 2, 3, 5, 9 and 14 should be reviewed in depth, in addition to the annual review of Goal 17.

In accordance with General Assembly resolutions 70/1 and 70/299, the follow-up and review at the high-level political forum will be informed by an annual progress report on the Sustainable Development Goals to be prepared by the Secretary-General in cooperation with the United Nations system. Every four years, a more scientific and analytical *Global Sustainable Development Report* will be prepared to complement the Secretary-General's annual progress report. In response to the invitation by the General Assembly in its resolution 70/1, the President of the Council conducted a process of consultations on the scope, methodology and frequency of the *Global Sustainable Development Report*, the outcome of which was reflected in the annex to the ministerial declaration of the session of the highlevel political forum in 2016.

Pursuant to General Assembly resolutions 67/290, 70/1 and 70/299, the high-level political forum, under the auspices of the Council, should hold voluntary national reviews by all countries, including countries in special situations, with the aim of facilitating the sharing of experiences, including successes, challenges and lessons learned. The Assembly, in its resolution 70/299, requested the Secretary-General to update, as appropriate and taking into account feedback from countries participating in the high-level political forum under the auspices of the Council during its 2016 session, the voluntary common reporting guidelines as provided for in the annex to the report of the Secretary-General, and to make them available to Member States as a suggested tool in the preparations for voluntary national reviews.

The General Assembly, in its resolution 67/290, invited the regional commissions to contribute to the work of the high-level political forum on sustainable development convened under the auspices of the Economic and Social Council, including through annual regional meetings.

## 7. Operational activities of the United Nations for international development cooperation

Pursuant to Council resolution 2017/1, the operational activities for development segment will be held from 28 February to 2 March 2017.

#### (a) Follow-up to policy recommendations of the General Assembly and the Council

The General Assembly, in its resolution 67/226, and the Council, in its resolution 2015/15, requested the Secretary-General to submit a report on the quadrennial comprehensive policy review of operational activities for development of the United Nations system.

## 8. Integration segment

Pursuant to General Assembly resolution 68/1, an integration segment is held annually, the timing and modalities of which are decided by the Council. The main functions of the segment are to consolidate all the inputs of Member States, the subsidiary bodies of the Council, the United Nations system and other relevant stakeholders and to promote the balanced integration of the three dimensions of sustainable development. The integration segment brings together the key messages from the Council system on the main theme and develops action-oriented recommendations for follow-up.

Pursuant to Council resolution 2017/1, the integration segment will be held from 8 to 10 May 2017. The Council, in its decision 2017/210,<sup>6</sup> decided that the theme of the integration segment of its 2017 session would be "Making eradication of poverty an integral objective of all policies: what will it take?"

## 9. Special economic, humanitarian and disaster relief assistance

In accordance with General Assembly resolution 52/12 B, by which the Assembly established a humanitarian affairs segment of the Economic and Social Council, and pursuant to paragraph 11 (b) of the annex to General Assembly resolution 68/1, a humanitarian affairs segment will be held in June, through which the Council should continue to contribute to strengthening the coordination and effectiveness of United Nations humanitarian assistance and support and complement international efforts aimed at addressing humanitarian emergencies, including natural disasters, in order to promote an improved, coordinated response by the United Nations. The Council should also continue to hold a special event to discuss the transition from relief to development, to be convened immediately preceding the humanitarian affairs

segment and following the annual session of the executive boards of the funds and programmes of the United Nations system.

Pursuant to Council resolution 2017/1, the humanitarian affairs segment will be held in Geneva from 21 to 23 June 2017.

# 10. The role of the United Nations system in implementing the ministerial declaration of the high-level segment of the substantive session of the Economic and Social Council

In its resolution 45/264, the General Assembly requested the Secretary-General to implement the recommendations addressed to him in the annex to the resolution, which included the recommendation that the substantive session of the Council be organized under segments, including a coordination segment, and that the coordination segment focus on the coordination of the activities of the specialized agencies, organs, organizations and bodies of the United Nations system in the economic, social and related fields, in accordance with Articles 63 and 64 of the Charter of the United Nations. In its resolution 68/1, the Assembly decided that dedicated coordination and management meetings would be held regularly to perform the functions of the coordination and general segments.

## 11. Implementation of and follow-up to major United Nations conferences and summits

At the United Nations Conference on Sustainable Development, the United Nations system was requested to mainstream the economic, social and environmental dimensions of sustainable development throughout its work. The General Assembly, in its resolution 71/223, invited the Secretary-General to continue to report to the General Assembly, through the Council, on progress made in further mainstreaming the three dimensions of sustainable development throughout the United Nations system.

In its decision 2011/217, the Council invited the Chair of the Committee on World Food Security to transmit to the Council annually, starting in 2012, a report on the main decisions and policy recommendations made as well as the results achieved by the Committee in the area of food security and nutrition, in accordance with its new roles and vision.

## (a) Follow-up to the International Conference on Financing for Development

Pursuant to General Assembly resolution 69/313, the Economic and Social Council will hold an annual forum on financing for development follow-up, consisting of up to five days, one of which will be the special high-level meeting with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development and up to four days of which will be dedicated to discussing the follow-up and review of the financing for development outcomes and the means of implementation of the 2030 Agenda for Sustainable Development. The forum's intergovernmentally agreed conclusions and recommendations will be fed into the overall follow-up and review of the implementation of the 2030 Agenda for Sustainable Development in the high-level political forum on sustainable development.

The General Assembly, in its resolution 70/192, decided that the annual sessions of the forum would be held at United Nations Headquarters in New York in the spring. It also decided that the forum would be chaired by the President of the Council, who would take the steps necessary to prepare the work of the forum according to paragraph 132 of the Addis Ababa Action Agenda. Also in resolution 70/192, it encouraged the President of the Council, in collaboration with the Secretary-General, to produce an information note regarding arrangements for the meeting of the annual forum in 2016.

The Council, in its decision 2017/206,<sup>3</sup> decided that the Economic and Social Council forum on financing for development follow-up, including the special highlevel meeting with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development would be held from 22 to 25 May 2017, on an exceptional basis, without prejudice to General Assembly resolution 68/1 and without setting a precedent for future discussions.

The General Assembly, in its resolution 71/217, invited the President of the Council to begin early planning of the 2017 Economic and Social Council forum on financing for development follow-up and to consider using in 2017 the modalities that had applied to the 2016 forum.

The General Assembly also made the following requests related to the programme of the 2017 forum: (i) it looked forward to the inclusion, in the 2017 report of the Inter-Agency Task Force on Financing for Development, of an analysis of the promotion of international cooperation to combat illicit financial flows in order to foster sustainable development, and also looked forward to the deliberations of the Economic Social Council forum on financing for development follow-up (71/213);

(ii) it encouraged the Council to consider, at its annual forum on financing for development follow-up, a discussion and analysis of systemic issues and challenges (71/215); (iii) it encouraged the annual Economic and Social Council forum on financing for development follow-up to continue discussions on ways to improve external debt sustainability (71/216); and (iv) it invited the Council, at its next annual forum on financing for development follow-up, to discuss adopting and implementing investment promotion regimes for the least developed countries, pursuant to the relevant resolutions on the matter and invited the President of the Council to include the outcome of that discussion in his summary of the forum on financing for development follow-up (71/238).

In its resolution 2016/28, the Council decided to extend the mandate of the Ad Hoc Advisory Group on Haiti until the conclusion of the 2017 session, with the purpose of following closely and providing advice on the long-term development strategy of Haiti to promote socioeconomic recovery, reconstruction and stability, with particular attention to the need to ensure coherence and sustainability in international support for Haiti, based on the long-term national development priorities, building on the Strategic Plan for the Development of Haiti and stressing the need to avoid overlap and duplication with respect to existing mechanisms.

The Council, in the same resolution, requested the Advisory Group to submit a report on its work, with recommendations, as appropriate, to the Council for consideration at its 2017 session.

In the same resolution, the Council requested the Secretary-General, in close collaboration with the Director General of WHO and in full consultation with Member States through WHO, to develop the terms of reference for the United Nations Inter-Agency Task Force on the Prevention and Control of Non-communicable Diseases, incorporating, but not limited to, the work of the Ad Hoc Inter-Agency Task Force on Tobacco Control and the current work of the secretariat of WHO to develop a division of tasks and responsibilities, as exemplified in appendix 4 to the WHO Global Action Plan for the Prevention and Control of Non-communicable Diseases 2013-2020 (see also Council resolutions 2014/10 and 2015/8).

In its resolution 2016/5, the Council requested the Secretary-General to report at the 2017 session on the implementation of resolution 2013/12 in preparation for a comprehensive review by the General Assembly, in 2018, of the progress achieved in the prevention and control of non-communicable diseases.

In its resolution 66/233 on the pattern of conferences, the General Assembly requested the Secretary-General to propose, at its sixty-seventh session, a comprehensive review of conference servicing highlighting any duplications and redundancies. The Secretary-General, in paragraph 13 of his report on the pattern of conferences (A/67/127 and Corr.1), indicated that the Secretariat had reviewed the process of preparing the biennial calendar of conferences and meetings, which incorporated the provisional biennial calendar of meetings in the economic, social and related fields. He further indicated that the biennial calendar contained almost two thirds of the meetings listed in the provisional biennial calendar and that the

time and effort to prepare, translate and issue two almost identical calendars so close to each other might be considered a duplication and redundant.

In paragraph 15 of his report, the Secretary-General therefore recommended that the General Assembly might wish to invite the Council to reconsider the necessity of reviewing its provisional biennial calendar of conferences and meetings in the economic, social and related fields.

Subsequently, upon the recommendation of the Committee on Conferences, the General Assembly, in its resolution 67/237, concurred with the observations in paragraph 13 of the report of the Secretary-General on the pattern of conferences regarding the biennial calendar of meetings of the Council.

In addition, as indicated in paragraph 23 of the report of the Committee on Conferences (A/67/32), most delegations expressed the view that the issue should initially be brought to the attention of the Bureau of the Council, through its secretariat, and then to the Council as a whole. Therefore, it was suggested that the Council might then wish to review paragraph (b) of its decision 281 (LXIII), on the need for a biennial calendar of conferences and meetings in the economic, social and related fields, in the context of the mandate set out by the Assembly in section II, paragraph 16, of its resolution 66/233.

The General Assembly, in its resolution 71/262, reaffirmed the need to address the issue of duplications and redundancies in conference servicing, and noted in that regard that the Council had decided, in its resolution 2013/13, to consider at a later date the necessity of reviewing its provisional biennial calendar of conferences and meetings in the economic, social and related fields in the light of the ongoing intergovernmental consultations on the further strengthening of the Council.

The General Assembly in its resolution 70/96 and the Council in its resolution 2016/20 also requested the Chair of the Special Committee on the Situation with regard to the Implementation of the Declaration on the Granting of Independence to Colonial Countries and Peoples and the President of the Council to continue to maintain close contact on those matters and to report thereon to the Council. The Council also requested the Secretary-General to follow up on the implementation of the resolution, paying particular attention to cooperation and integration arrangements for maximizing the efficiency of the assistance activities undertaken by various organizations of the United Nations system and to report thereon to the Council at its 2017 session.

## Working arrangements for the 2017 session of the Economic and Social Council

- (d) The partnership forum will be held on 5 April 2017;
- (e) The integration segment will be held from 8 to 10 May 2017;

(f) The multi-stakeholder forum on science, technology and innovation for the Sustainable Development Goals will be held on 15 and 16 May 2017;

(g) The humanitarian affairs segment will be held in Geneva, from 21 to 23 June 2017;

(h) The high-level political forum on sustainable development, convened under the auspices of the Council, will be held from 10 to 14 July 2017, and the three-day ministerial meeting of the forum will be held from 17 to 19 July 2017;

(i) The high-level segment, including the three-day ministerial meeting of the high-level political forum on sustainable development, convened under the auspices of the Council, will be held from 17 to 20 July 2017;

(j) The organizational session regarding the programme of work of the Council from July 2017 to July 2018 will be held on 27 July 2017.

As set out in Council decision 2017/205,<sup>b</sup> the one-day special meeting of the Council on international cooperation in tax matters in 2016 will be held on 9 December 2016. As set out in Council decision 2017/209,<sup>c</sup> the one-day special meeting of the Council on international cooperation in tax matters in 2017 will be held on 7 April 2017.

As set out in Council decision 2017/206,<sup>d</sup> the Economic and Social Council forum on financing for development follow-up, including the special high-level meeting with the Bretton Woods institutions, the World Trade Organization and the United Nations Conference on Trade and Development, will be held from 22 to 25 May 2017, on an exceptional basis, without prejudice to General Assembly resolution 68/1 and without setting a precedent for future discussions.
