1. Centre de formation et de recherche pour le développement (CFRD)

Special, 2014

Introduction

In the context of ECOSOC resolution [1996/31](#), the Centre de formation et de recherche pour le développement (CFRD International), having obtained special consultative status in May 2014, designed and structured its Action Programme in Support of United Nations Objectives for 2014–2017, to be implemented in sub-Saharan Africa and Europe.

Aims and purposes of the organization

There have been no significant changes.

Significant changes in the organization

There have been no significant changes.

Contribution of the organization to the work of the United Nations

The actions of the Centre de formation et de recherche pour le développement are directed toward the implementation of its Action Plan in Support of United Nations Objectives for 2014–2017. The Programme has two main thrusts: (i) governance and peacebuilding, (ii) growth and sustainable development.

- Governance and peacebuilding
- Strengthening of democracy and the rule of law
- Peacebuilding
- Growth and sustainable development
- Strategic development policy and planning
- Initiative to promote inclusive growth and employment
- Sustainable environmental management.

Initiatives taken by the organization in support of the Sustainable Development Goals

In the context of the Millennium Development Goals, the Centre has since 2017 been constructing a 150-bed hospital in the village of Ekomakoko, in the territory of Lomela, Province of Sankuru, in the Democratic Republic of the Congo.

2. Club des jeunes aveugles réhabilités du Cameroun

Special, 2014

Introduction

The Club des jeunes aveugles réhabilités du Cameroun is a proven organization, one that has for nearly thirty years been helping persons with disabilities in general and visually impaired persons in particular. Its vision is to make every visually impaired Cameroonian a fully integrated citizen who is active in society. By order No. 0000045/A/MINATD/DAP/SDLP/SONG, dated 19 February 2013, it changed status from an association to a non-governmental organization. It has five field offices across the country, in the central, southern, eastern, north-western and south-western regions.

Aims and purposes of the organization

The goal of the organization is to work toward visually impaired persons' rehabilitation and personal fulfilment. Accordingly, education and training are its primary focus.

Its objectives are: to promote inclusive education; to take blindness prevention actions; to raise awareness of the problems of visually impaired persons in society in general and, in particular, among policymakers and families; to make both groups' experience of service to everyone, in particular through vocational training and education for persons with disabilities; to develop income-generating activities and promote the well-being of visually impaired women and children; and to promote values, sports and excellence for the whole community of visually impaired persons. All of these objectives have four strategic foci:

- Prevention of the disability and its consequences
- Education, vocational training and employment
- Organizational reinforcement
- Advocacy, networking and resource mobilization

The activities undertaken are:

- The promotion of inclusive education: nearly 250 students, including some fifty pupils with special needs, are enrolled each year in the Louis Braille kindergarten and primary school
- Educational support and monitoring for visually impaired pupils and students through a transcription service and a team of volunteer teachers
- Psychosocial assistance and support for children with disabilities
- Training in Braille, orientation and mobility and training in income-generating activities
- Training and coaching of blind women and girls
- Accommodation and support for thirty visually impaired young persons being taught at the home
- Hosting of national and international volunteers
- Advocacy and awareness-raising.

Significant changes in the organization

In 2017 the organization was granted the status of a private service project by the Ministry of Social Affairs. In 2016 it changed its organizational structure and created new positions to better meet the needs of its target population.

Contribution of the organization to the work of the United Nations

The organization works to promote respect for human rights, and in particular those of persons with disabilities.

Participation in meetings of the United Nations

The Director General attended the forty-ninth meeting of the Commission on Population and Development and the fifteenth meeting of the Committee of Experts on Public Administration, which were held at United Nations headquarters in New York from 11 to 15 April and 18 to 22 April respectively.

Cooperation with United Nations system entities

The organization cooperated with the Representation Office in Cameroon of the Office of the United Nations High Commissioner for Refugees (UNHCR), in 2016, on the recruitment to its school of a teacher who had come from the Central African Republic as a refugee.

In 2017 it hosted World Bank personnel who provided support for its activities under a project known as “e-give”. The organization also takes part in World Bank meetings involving civil society. In 2017 the Director General attended an advisory meeting on inclusive education as a resource person.

Initiatives taken by the organization in support of the Millennium Development Goals

In 2004 the organization opened an inclusive bilingual kindergarten that accepts children regardless of their social status or physical condition, in order to promote education for all. Since 2016 it has been providing support and assistance for another ten primary schools and kindergartens under an inclusive education promotion programme financed by the Christopher Blind Mission, a German non-governmental organization. It also belongs to the Cameroonian anti-hunger network.

3. Collectif sénégalais des Africaines pour la promotion de l'éducation relative à l'environnement

Special, 1998

Introduction

The Collectif sénégalais des Africaines pour la promotion de l'éducation relative à l'environnement is a not-for-profit Senegalese national organization whose membership consists primarily of women and youth concerned with environmental education and training for sustainable development.

Aims and purposes of the organization

- To broadly disseminate information on environmental education, mobilizing Africans in general and teachers in particular to promote environmental education
- To involve students as vectors in the adoption and transmission of healthy environmental protection habits by equipping them, and the general public, with the knowledge and skills necessary to identify and solve environmental problems
- To ensure that the gender dimension is taken into account in all development projects and programmes.

Significant changes in the organization

The organization also plays an active role in the Senegalese peaceful elections monitoring platform. Because of its structural role in promoting the gender perspective, it acts as a gender observer under the United Nations Framework Convention on Climate Change.

Contribution of the organization to the work of the United Nations

From 2014 through 2017 the organization took part in popularizing various initiatives to combat violence against women and girls: the Journée orange campaign against such violence, on the 25th of each month; participation in the various “violence against women days”; and celebrations surrounding the International Day of Peace (21 September), in Dakar in 2016 and in Ziguinchor in 2017.

Participation in meetings of the United Nations

During the 2014–2017 period the organization attended various sessions of the Commission on the Status of Women in New York City: the fifty-eighth session, from 10 to 21 March 2014, on the priority theme of “Challenges and achievements in the implementation of the Millennium Development Goals for women and girls”; the fifty-ninth session, or Beijing+20, from 9 to 20 March 2015; the sixtieth session, from 14 to 24 March 2016, on the priority theme of “Women’s empowerment and its link to sustainable development”; And the sixty-first session, from 13 to 24 March 2017, on “Women’s economic empowerment in the changing world of work”. It also regularly took part in the various gatherings of African non-governmental organizations, and in addition attended the sixty-fifth annual DPI/NGO conference in New York City, 27–29 August 2014; in that connection, it organized a parallel event with a French non-governmental organization, involving exchanges on children’s inclusion in civil status registries as a factor in sustainable development, as well as another on climate change.

Participation in the 22nd Conference of the Parties to the United Nations Framework Convention on Climate Change in Marrakech, in 2016, where it conducted a workshop on the green economy and women’s place therein.

Participation in the Fifteenth Francophonie Summit on the theme of “women and youth in the Francophonie”, in November 2014 in Dakar.

The non-governmental organization attended the fiftieth session of the Commission on Population and Development, in New York City from 3 to 7 April 2017, which dealt with the theme of “Changing population age structures and sustainable development”.

Cooperation with United Nations system entities

United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women), through programmes on gender and women’s participation in politics.

The United Nations Office for West Africa and the Sahel, through the working group on “Women, Peace and Security in West Africa and the Sahel”.

The Dakar office of UNHCR, through human rights programmes regarding, in particular, the rights of persons with disabilities, the fight against torture, and universal periodic review.

Initiatives taken by the organization in support of the Millennium Development Goals

The organization has been active in pursuing the Millennium Development Goals, especially Goals 2, 3 and 7, in terms of outreach, education and advocacy with grassroots organizations.

4. Comité international pour le respect et l'application de la charte africaine des droits de l'homme et des peuples (CIRAC)

Special, 2002

Introduction

Through conferences, symposiums and seminars, the Committee is continuing its mission of education, training and awareness-raising in the area of human rights. It remains committed, as well, to achieving the goals set in the 2030 Agenda for Sustainable Development, in spite of the challenging social and political situation in Africa.

Aims and purposes of the organization

The objectives of the organization are unchanged.

Significant changes in the organization

There have been no significant changes.

Contribution of the organization to the work of the United Nations

2014 and 2016: The Chair of the Committee made two statements on the occasion of the annual International Day of Remembrance of the Victims of Slavery and the Transatlantic Slave Trade at the Palais des Nations in Geneva.

2014–2017: The Committee took an active role in the Working Group of Experts on People of African Descent and the Working Group for the implementation of the Durban Declaration and Programme of Action.

2014: The Committee participated actively in the World Forum on Human Rights in Marrakech, Morocco.

2014–2017: Attended the annual meetings of the World Intellectual Property Organization, with which the Committee is in partnership through the Coordination des ONG africaines des droits de l'homme et du développement.

Participation in meetings of the United Nations

Participation in United Nations meetings

2014–2017: Attendance at all regular and special sessions of the Human Rights Council, with oral statements in plenary. Organization of parallel events to Human Rights Council sessions, involving independent experts, on African human rights issues of concern to the United Nations.

Participation by the Committee in the annual meetings of the United Nations Committee on the Elimination of Racial Discrimination and the Committee on the Elimination of All Forms of Discrimination against Women.

2015: Participation, in partnership with the non-governmental organization Action internationale pour la paix et le développement dans la région des Grands Lacs, in the World Climate Change Conference held in Paris from 30 November to 12 December 2015.

2016: Participation in COP22 on climate change in Marrakech, Morocco, in partnership with the non-governmental organization Action internationale pour la paix et le développement dans la région des Grands Lacs.

December 2016: Participation in the International Observation Mission on the parliamentary elections in Morocco together with several international non-governmental organizations.

April 2018: Participation in the international conference organized by UNHCR, the Office for the Coordination of Humanitarian Affairs and the Netherlands for the benefit of victims of human rights violations in the Kasai region of the Democratic Republic of the Congo.

Cooperation with United Nations system entities

2014–2016: the Committee collaborated with the United Nations Working Group on Arbitrary Detention to defend the rights of a political prisoner in Africa.

2014–2017: The Committee also worked closely with the Office of the United Nations High Commissioner for Human Rights (OHCHR), producing detailed reports on the humanitarian disaster facing member States in the Great Lakes region.

2016: Application to the regional office of UNHCR in Bujumbura, Burundi, on behalf of a Congolese family whose father, the president of the appeals court in Bukavu, Democratic Republic of the Congo, had been murdered.

2014–2017: The International Telecommunications Union and the United Nations Office at Geneva supplied the Committee with more than 100 computers for students and teachers living in less favoured areas of Côte d'Ivoire, Angola and Togo.

2017: The Committee sent the High Commissioner for Refugees a memorandum on the illegal expulsion of sub-Saharan refugees in Algeria.

Initiatives taken by the organization in support of the Millennium Development Goals

Initiatives taken by the organization to help achieve the Millennium Development Goals

2014–2017: Shipment of medical and information technology equipment to the Gambia and Togo to benefit vocational training schools.

2014–2017: Active partnership with a human rights training school based in Kinshasa and Kananga, Democratic Republic of the Congo.

2014–2017: The Committee worked closely with the non-governmental organization “Action de Développement Suisse-Afrique” to improve community health centres in Angola, Côte d'Ivoire and the Democratic Republic of the Congo.

2017: In Niger, the Committee participated in an international seminar on the African migratory crisis organized by the African Commission on Human and Peoples' Rights, with which CIRAC has had observer status since 1993.

5. Drepanie

Special, 2014

Introduction

The Drepanie association is a non-governmental organization seeking to combat sickle cell anaemia. The geographical areas where it is active are in France and Africa (Cameroon, Côte d'Ivoire and Chad in particular).

Aims and purposes of the organization

The objectives of the organization are as follows:

- To raise awareness and inform the general public about sickle cell anaemia (to make it better known by means of scientific events, information and awareness campaigns, and information, education and communication programmes)
- To fight against the isolation of persons suffering from sickle cell anaemia and their families (to help and support patients in daily life, hold information meetings on sickle cell anaemia, and organize cultural and educational outings for sufferers)
- To establish links and partnerships with counterpart associations
- To provide help, support and access to care for sufferers in the countries of the South
- To train health personnel and professionals in the countries of the South.

Significant changes in the organization

There have been no significant changes since Drepavie obtained consultative status with the Economic and Social Council.

Contribution of the organization to the work of the United Nations

Over the past four years, Drepavie has contributed to the work of the United Nations by making an oral statement at the March 2015 session of the Human Rights Council — more specifically, during the panel discussion held 12 March 2015 on children's right to health. Drepavie presented two written statements during the thirty-first session of the Human Rights Council on the themes of universal periodic review in Rwanda (agenda item 6) and the United Nations statement declaring sickle cell anaemia a public health priority. Drepavie made a written statement at the thirty-second session of the Human Rights Council on the theme of World Sickle Cell Day. At the thirty-fourth session of the Human Rights Council, Drepavie introduced a written statement on the theme of the protection of the rights of children suffering from sickle cell anaemia and the implementation of the sustainable development agenda by 2030; however, Drepavie was unable to make an oral statement at that session given the large number of speakers (Drepavie was on the waiting list). On Friday, 16 June 2016, Drepavie organized a side event at the thirty-fifth session of the Human Rights Council to mark World Sickle Cell Day. Representatives of the Embassies of France and Côte d'Ivoire were present. The event was moderated by doctors specializing in sickle cell anaemia and by the French national blood service (Établissement français du sang).

Drepavie also participated in the work of the universal periodic review by sending its written contributions to the OHCHR offices in Togo, Niger and Cameroon. Finally, Drepavie contributed to the work of OHCHR by sending a report on the right to health and the implementation and effective realization of the health-related Sustainable Development Goals (October 2017).

Participation in meetings of the United Nations

Drepavie attended the thirty-first to thirty-sixth sessions of the Human Rights Council and took part in universal periodic review for Niger, Togo, Cameroon, Rwanda, Ghana and Gabon as well as the 2018 Social Forum on health.

Cooperation with United Nations system entities

Drepavie cooperated with OHCHR by sending its report on the Sustainable Development Goals and health on 16 October 2017.

Initiatives taken by the organization in support of the Millennium Development Goals

Drepavie has helped to achieve the Millennium Development Goals by setting up a health-themed humanitarian project in Cameroon. The goals of the project are as follows:

- Access to primary care to improve quality of life for patients with sickle cell anaemia
- Strengthening and support of peer associations (Cameroon, Côte d’Ivoire).

The strategy includes:

- Sickle cell anaemia information and awareness campaigns in Kribi, Cameroon (distribution of brochures, educational CD-ROMs to doctors) with the cooperation of local authorities (district health chief) and local associations
- A screening campaign for the local population
- Advocacy with local health authorities, in concert with peer associations
- Communications in collaboration with local media (TV, radio)
- Access to quality care and periodic monitoring for patients with sickle cell anaemia (medical and biological monitoring of patients and access to basic care).

6. Fondation d’Auteuil

Special, 2014

Aims and purposes of the organization

There have been no significant changes

Significant changes in the organization

2017: creation in Switzerland of the Fondation Apprentis d’Auteuil International

Contribution of the organization to the work of the United Nations

Contribution to the Sustainable Development Goals and implementation of the Convention on the Rights of the Child:

2016:

- Emphasis put on the participation of children and young people: publication of the white paper “Prendre le parti des Jeunes”, awareness-raising for French policymakers respecting the difficulties faced by vulnerable young people and families
- 2,100 contributions collected from youth and families
- 20 proposals submitted to policymakers
- 27,500 copies published
- Interviews with 200 elected officials, including 10 ministers.

Initiatives taken by the organization in support of the Millennium Development Goals

Contribution to Sustainable Development Goal No. 4, on improving conditions and quality of education:

- Since 2014, the Fondation d’Auteuil, in conjunction with four European and Moroccan partners, has enrolled 16,000 young people in the international solidarity operation “Solidarity Study Olympics”, sponsored by the French Commission of the United Nations Educational, Scientific and Cultural Organization (UNESCO).
- Participation by 1,225 young people in 26 countries in international solidarity study actions.

Activities of Fondation d’Auteuil institutions in support of the 17 Sustainable Development Goals:

- Annual Sustainable Development Goal project awards presentation to schools, with two schools being granted UNESCO accreditation in 2016.

Advocacy with policymakers on awareness of the Sustainable Development Goals

- 2015: During the 5+5 Dialogue of foreign ministers from Southern Europe and North Africa, formulation of proposals with the Anna Lindt Foundation for youth mobility between Europe and North Africa and for multicultural cities (Sustainable Development Goals 4 and 11).
- 2017: The Fondation d’Auteuil joined the Groupe Enfance collective, mounted an exhibit on the rights of the child and, in November, held an international panel discussion in Paris on more effective investment in the rights of the child.

7. Génération recherche action et formation pour l’environnement

Special, 2006

Introduction

Génération recherche action et formation pour l’environnement is a not-for-profit non-governmental organization founded in 1995, with headquarters in Rolle, Switzerland. Since its inception, and its accreditation to ECOSOC, it has undertaken initiatives to benefit the people of Senegal, Burkina Faso and Côte d’Ivoire.

Aims and purposes of the organization

As a non-governmental organization specializing in microcredit, the association supports projects in various sectors of the informal economy, in rural and urban areas alike. Its goals are to fight poverty and prevent rural depopulation.

Significant changes in the organization

Since 2014, there has been no significant improvement in security conditions, either in Burkina Faso or in Côte d'Ivoire; moreover, some local employees have ceased to show any real interest in controlling how the funds are used — something that is of vital importance to us.

The association's efforts are chiefly focused on Senegal: from 2014 to 2017, it funded 367 new microloans totalling CHF 76,000, essentially in the area of small rural businesses, livestock feedlots and crop years.

Goal 1.1: through microloans, to keep rural people on the land in the Great Lakes region of Senegal by providing them with income generated from available resources (crop years, small local businesses and the like).

Introduction

This four-year period has seen a great deal of work and success. Our permanent headquarters, the office of La Brique, remained unchanged throughout the four years, under the leadership of Mr. Aoutene Akissita Alouatchou. During the 2014–2017 period many changes took place in the life of our organization. The following report will shed light on our various activities during that time. We wish to take this opportunity to say thank you to all the United Nations staff who work constantly for the development of our communities and who have made our missions so successful, even though some difficulties do subsist here and there.

Aims and purposes of the organization

The organization works in the field of human rights, including disadvantaged children, the emancipation of women, education and the social reintegration of young people in difficulties. It contributes to people's socioeconomic and cultural well-being at the grass-roots level, to achieve sustainable, harmonious, participatory and holistic human development. The objectives of the organization are:

- * To strive to protect human rights and promote social integration of individuals at every level;
- * To strive to curb the proliferation of small arms, drugs and their derivatives, smuggling, terrorism, and mercenary activities, in order to further cultivate the spirit of peace for a world free of war and violence;
- * To take care of destitute and deprived children and orphans;
- * To fight against STI/HIV/AIDS, Ebola, tuberculosis and other diseases;
- * To promote good governance within our States and the rational management of public assets;
- * To promote environmental protection through protection of the soil, flora, fauna and forests so as to prevent natural disasters and combat climate change, which hamper the development of agriculture, our communities' main source of income;
- * To work toward social integration of street children and at-risk youth through training in income-generating activities, entrepreneurship, animal husbandry and agriculture;
- * To combat ill-treatment, prostitution, slavery and violence against children and women;
- * To promote the rights of children and women; * To alleviate poverty at the grass-roots level;
- * To provide people with access to primary health care at the grass-roots level;
- * To provide rural communities with drinking water and sociocultural infrastructure;
- * To collect computer hardware and other recyclable goods, to refurbish these and make them available to target populations who need and can make good use of them.

- * To ensure that local, legislative and presidential elections are nationally and internationally monitored.

To achieve its objectives, the organization intends, inter alia:

- * To attend conferences at the national and international levels;
- * To provide awareness and training sessions at the grass-roots level;
- * To inform, educate and communicate;
- * To organize seminars, workshops, symposiums, forums, conferences, round tables and other meetings;
- * To collaborate with governments, local communities, non-governmental organizations, associations and institutions, both national and international;
- * To build an orphanage and a youth listening centre
- * To establish health huts in the most remote hamlets;
- * To establish schools and vocational training centres;
- * To establish study halls and computer rooms;
- * To drill water wells in rural areas;
- * To identify, develop, implement and evaluate projects and programmes for the benefit of local people;
- * To undertake community works;
- * To take study trips;
- * To produce a newsletter or memorandums;
- * To write reports and briefs;
- * To participate in broadcasts.

Significant changes in the organization

Since the organization received special consultative status, our statutes have been slightly amended to enable us to work worldwide with greater openness and establish representative offices in other countries. These changes were made to Titles II and IV of the statutes; they afford us greater flexibility in our work, as offices have been established in Geneva, New York, and Benin, while preparatory work is under way in other countries.

Contribution of the organization to the work of the United Nations

La Brique has contributed to the work of the United Nations in various ways. Thus, our delegates have participated in several human rights conferences in Geneva; a conference in Vienna; and several conferences in New York City. In addition, alongside our sister organizations in Togolese civil society, we conduct peacebuilding activities to enhance social cohesion and alleviate the tensions of the sociopolitical crisis in Togo, and to strengthen democracy and the rule of law.

Immediately following its accreditation to the Economic and Social Council, La Brique acquired nearly international scope despite its limited financial means and the difficulties it faced in obtaining visas for its important missions.

- We developed a youth dialogue to combat climate change, so that everyone is aware of its harmful effects. Building from there, awareness-raising was done with farmers and a number of communities, to enable everyone to take care of their immediate environment, to avoid diseases and natural disasters such as may occur at any time. Participants were also shown how to adapt their crops to the adverse effects of climate change.
- Seeking open government, we took part in conferences here in Lomé, on Big Data, and the IT Forum Togo 2017 on the theme “The Internet of Things will bring new challenges”. This is also an opportunity to create new jobs in information technology. An Elephant Walk was organized, together with a number of other activities, to help protect biodiversity.

The Organisation des Hommes démunis et enfants orphelins pour le développement (OHDEOD) works to improve and develop the quality of life and environment of indigent men and orphan children.

Aims and purposes of the organization

The organization seeks to provide social structure for men, women and children who have become indigent as a result of war, theft or other hostile acts, and to improve their health status, diet and life expectancy.

To achieve that goal, it works in the field, at the national, regional and international level, alongside orphaned and half-orphaned children.

Significant changes in the organization

There have been no significant changes

Contribution of the organization to the work of the United Nations

The organization makes an active contribution to the United Nations vision for the Millennium Development Goals to be achieved for the development of the world's men, women and children, in terms of:

- Reducing infant mortality;
- Promoting gender equality and the empowerment of women;
- Environmental preservation;
- Eradicating extreme poverty and hunger;
- Combating HIV/AIDS, malaria and other diseases; and
- Promoting primary education for all.

The organization is active in the field, undertaking extensive information gathering related to the Millennium Development Goals. Its findings will very soon be submitted to the United Nations for the purpose of future discussion.

Initiatives taken by the organization in support of the Millennium Development Goals

For some months now the organization has been gathering large amounts of information in the field to respond to the Millennium Development Goals. Up to now our main focus has been on information related to extreme poverty among men, women and orphaned children. We also gather information in the field relating to environmental preservation, with the aim, of course, of putting in place strategies to remediate the problems caused by extreme poverty and facilitate environmental preservation.

11. Presse emblème campagne

Special, 2010

Introduction

The organization, based in Geneva, was founded in June 2004 under Swiss law and is recognized as a non-governmental organization by the authorities of the Canton of Geneva. It is active in the areas of human rights, humanitarian law and conflict resolution. It is a non-governmental organization with a worldwide scope of activity.

Aims and purposes of the organization

The goal of Presse emblème campagne is to defend freedom of the press and to enhance the protection of journalists in areas affected by conflict and internal violence. It regularly documents violations of international treaties on human rights and humanitarian law (Geneva Conventions) as regards the work of the media, and intervenes at the diplomatic level with governments and international organizations to have these enforced.

Significant changes in the organization

None.

Contribution of the organization to the work of the United Nations

The organization has made contributions to a number of United Nations activities since 2014. It has attended all regular sessions of the Human Rights Council in Geneva, contributed to the follow-up to the plan of action developed by the United Nations Educational, Scientific and Cultural Organization (UNESCO) on the safety of journalists and the issue of impunity, and to the work of OHCHR on the safety of journalists.

Participation in meetings of the United Nations

The organization was an active participant in the twenty-fifth to thirty-sixth regular sessions, inclusive, of the Human Rights Council in Geneva. It presented several oral statements at each session. It also took part in the June 2017 UNESCO meeting in Geneva entitled: “Multi-Stakeholder Consultation on Strengthening the Implementation of the UN Plan of Action on the Safety of Journalists and the Issue of Impunity”.

Presse emblème campagne cooperated with OHCHR on the report of the Secretary-General to the General Assembly ([A/72/290](#)) on “The safety of journalists

Panorama: This informational web page, in Spanish, was put up in 2014. It deals with United Nations human rights endeavours with particular reference to Latin America. It publishes 300 articles a year.

Geneva Human Rights Agenda: This is an app for mobile phones, created in 2015, for the use of diplomatic missions and non-governmental organizations. It is a free service providing all information and documents relating to human rights conferences, discussions and meetings taking place in Geneva. The app currently has more than 8,000 users.

Rolf Traeger, an economist with the United Nations Conference on Trade and Development, and Sarah Cook, director of the UNICEF Innocenti Research Centre, wrote an analysis for *Convergence* (22/09/2015), the newsletter of *Secours populaire français*, on why the incidence of poverty in the 48 poorest countries had not fallen.

A feature of the organization's twenty-fourth people's seminar, "Vivre la pauvreté dans son enfance" (25/09/2015), was the contribution of Nathalie Serruques, who heads up Mission Enfance–UNICEF in France.

The organization subscribes to all international days and years decreed by United Nations. It communicates on these subjects through its communications media and enriches the programmes it carries out in that regard.

Participation in meetings of the United Nations

No activities were specified.

Cooperation with United Nations system entities

The organization uses and disseminates United Nations agencies' data and follows their recommendations, with particular emphasis on benefits to women and children. In the context of emergency actions, our teams monitor all information issued on humanitarian crises by the Office for the Coordination of Humanitarian Affairs. On 18 May 2017, together with *Le Monde Diplomatique*, the organization moderated a panel discussion on the refugee crisis that was also attended by Ralf Gruenert, representing UNHCR.

The programme on family farming, organic products, short supply chains and environmental protection coordinated by the organization in El Salvador (Comasagua) was granted accreditation by France for the twenty-first session of the Conference of Parties to the United Nations Framework Convention on Climate Change.

On 8 December 2015, UNESCO House in Paris hosted a reception for "Green Santa Claus" to kick off celebrations for the seventieth anniversary of *Secours populaire français*. Events related to the anniversary were held under UNESCO patronage.

Initiatives taken by the organization in support of the Millennium Development Goals

Sustainable Development Goal 1: In Greece, in conjunction with the non-governmental organization Solidarity Association of People in Greece, the organization takes action (in the areas of food, health, education and vacations/culture/leisure) to support families who are victims of the economic crisis and refugees.

and earthquake-proofed a school for 207 pupils, employing environmentally friendly technologies; the building is accessible to persons with disabilities and fitted out with a potable water supply and sanitation system.

Sustainable Development Goal 5: In East Jerusalem, with the non-governmental organization Palestinian Medical Relief Society, the non-governmental organization has conducted a programme to enhance the resilience of Palestinian youth and mobilize them through solidarity-based citizens' initiatives to promote gender equality.

Sustainable Development Goal 6: In Haiti, in collaboration with the non-governmental organization Canadian Assistance for Humanitarian Development, the organization has conducted a programme to supply 1,000 families in Rivière Froide with drinking water.

Sustainable Development Goal 8: In Lebanon, with the non-governmental organization Development for People and Nature Association, the organization led a humanitarian operation for 185 Syrian, Palestinian and Lebanese young people whereby they were paid to perform work aimed at improving the livelihoods of refugee populations.

Sustainable Development Goal 10: In Mauritania, with the non-governmental organization El Karamat, the organization is conducting a project to support the empowerment of the women in Adwabas (Gaat Teydouma commune, Hodh El Gharbi region). beneficiaries.

Sustainable Development Goals 11 and 1: In El Salvador, with the Canasta Campesina organization, the organization is carrying out a programme to enhance the agroecological production capacity of youth and women, as well as the entrepreneurial management of the Canasta Campesina cooperative in Comasagua on solidarity-based social economy principles. 1,660 beneficiaries.

Sustainable Development Goal 13: 2015 national congress: The organization set up a workshop on targeted actions to mitigate the effects of climate change.

Sustainable Development Goal 17: The children's movement Copain du monde, inspired by the principles of the Convention on the Rights of the Child, creates a space, time and place where children can learn about solidarity together, and can begin to build new solidarities. These children, taking responsibility for their own activities, reach out to the world and learn about other children on all continents where Secours populaire français is active, with the common goal of learning to love rather than hate one another and of learning to cooperate rather than shun one another. They have the opportunity to meet other children at the Villages Copains du monde that have been developed in France and around the world, where children from France and abroad build solidarity. These villages teach solidarity and citizenship, which the children will exemplify once they return home.

Solidarité pour le développement communautaire is a humanitarian non-governmental organization that is active in the Democratic Republic of the Congo (Kinshasa, Central and Eastern Kasai).

Aims and purposes of the organization

The goals of the organization are:

- To contribute to respect for human rights and the strengthening of democracy
- To promote peace and peaceful conflict resolution
- To provide farmers with training and support for their agricultural production
- To help eliminate maternal, infant and neonatal mortality
- To provide young people with training and support in creating their own jobs
- To provide assistance to vulnerable persons
- To combat all forms of violence against women and girls
- To provide supervision and care for orphans and vulnerable children.

Significant changes in the organization

In view of the current situation, the General Assembly has amended the organization's statutes. The amended articles, as adopted by the Assembly, are as follows: Article 6: The mission of Solidarité pour le développement communautaire is to raise people's awareness of their own problems, build their capacity to solve them and support them in finding solutions.

Article 7: The goals of the organization are:

- To contribute to respect for human rights and the strengthening of democracy
- To promote peace and peaceful conflict resolution
- To provide farmers with training and support for their agricultural production
- To help eliminate maternal, infant and neonatal mortality
- To provide young people with training and support in creating their own jobs
- To provide assistance to vulnerable persons
- To combat all forms of violence against women and girls
- To provide supervision and care for orphans and vulnerable children.

Article 8: The organization's areas of activity are: civic education, voter education and information; legal, medical and psychosocial assistance; nutrition and food security; sexual and reproductive health; maternal, child and newborn health; peace and peaceful conflict resolution; agriculture and animal husbandry; vocational training; and food and non-food assistance.

Contribution of the organization to the work of the United Nations

Introduction

Since 1986 the organization has been working to promote the cultural recognition of indigenous peoples and ethnic minorities through its support for projects in the field. The recognition and expression of cultural identity is recognized by the 2007 United Nations Declaration on the Rights of Indigenous Peoples.

Furthermore, Traditions pour demain is working to raise institutional awareness at the multilateral level (Economic and Social Council, United Nations Educational, Scientific and Cultural Organization, World Intellectual Property Organization, European Commission) and at the national level, in the countries where it is active, with respect to issues of cultural rights, cultural diversity, protection of intangible cultural heritage, intellectual property rights as they relate to traditional knowledge, cultural development and the rights of indigenous peoples. Particular emphasis is placed on these issues in situations of armed conflict.

Aims and purposes of the organization

To contribute, through a pragmatic approach, to support for projects for the cultural expression of indigenous peoples and ethnic minorities. As a not-for-profit,

secular and non-political organization, Traditions pour demain seeks, through a humanistic approach, to raise the awareness of institutions and the general public of the various themes mentioned above.
