<u>Recommendations adopted by the Board of Trustees of the United Nations</u>
Voluntary Trust Fund on Contemporary Forms of Slavery at its fifth session

1. At its fifth session, held in Geneva from 7 to 10 February 2000, the Board of Trustees of the United Nations Voluntary Trust Fund on Contemporary Forms of Slavery examined applications for new travel and project grants, the financial situation of the Fund (see annex I) and the implementation of its previous recommendations, approved in 1999. The Board also met with representatives of Governments and with the NGO Terre des Hommes-Switzerland. The recommendations adopted by the Board at its fifth session were approved by the High Commissioner for Human Rights on behalf of the Secretary-General on 17 February 2000.

Organization of the Board's sessions

- 2. In principle and provided that enough money is available, the Board should meet every year. Its sixth session is scheduled at the end of January 2001. Considering the important increase in the Board's workload and in the number of documents examined at its fifth session, the sixth session should last at least four days.
- 3. The Committee on the Rights of the Child will be consulted concerning the possibility of organizing a joint discussion with the Board, at the Committee's first session in 2001, on questions of common interest.
- 4. The Board recommended that the Bureau of the Commission on Human Rights should continue to give an opportunity to the Chairman or a member of the Board to deliver a brief speech to the Commission under the relevant agenda item in order to introduce the report of the Secretary-General on the Fund and to provide updated information to the Commission on the financial situation of the Fund and activities of the Board.

Review of previous grants

5. The Board reviewed the use of project grants paid in 1999 and heard representatives of Terre des Hommes-Switzerland, the established channel of assistance for the Foyer Maurice Sixto in Haiti (see E/CN.4/Sub.2/AC.2/1999/4, annex II). The Board noted with satisfaction that all beneficiaries had implemented the projects in good faith. The reporting was satisfactory and resources made available had been well spent. The Board recommended releasing a second instalment of US\$ 2,500 of the grant approved in 1999 for the Consulting Center for Constitutional Rights and Justice, Nigeria, as the narrative and financial reports on the use of the first instalment had been received and considered satisfactory.

Recommendations for grants

- 6. At its fifth session, the Board examined 43 new applications for travel grants amounting to approximately US\$ 113,059 and 25 new applications for project grants amounting to approximately US\$ 552,236.
- 7. In accordance with General Assembly resolution 46/122, the project and travel grants recommended and approved by the High Commissioner for Human Rights will assist non-governmental organizations in 17 countries in Africa, America, Asia and Europe. In accordance with the mandate of the Fund, the Board's recommendations focused on assisting representatives of non-governmental organizations from different regions, dealing with issues of contemporary forms of slavery, to participate in the deliberations of the Working Group on Contemporary Forms of Slavery*, as well as on extending, through established channels of assistance, humanitarian, legal and financial aid to individuals whose human rights have been severely violated as a result of contemporary forms of slavery.

^{*} The Board took note that the primary focus identified by the Working Group for its twenty-fifth session was bonded labour and debt bondage.

8. The Board recommended that US\$ 30,800 be spent for travel grants (see annex II) and US\$ 83,500 for project grants (see annex III), for a total amount of US\$ 114,300.

New guideline concerning project grants

9. In accordance with a new guideline recommended by the Board, the application forms for project grants for 2001 will indicate that a maximum of US\$ 15,000 only can be requested of the Fund.

Fund-raising

- 10. The Board expressed its appreciation to the Government of Japan for a new pledge announced during the Board's meeting with government representatives on 10 February 2000. The Board also expressed its appreciation to the other Governments which showed interest in the activities of the Fund.
- 11. The Board thanked the High Commissioner for Human Rights, Ms. Mary Robinson, for having sent in 1999 a letter appealing all Governments to contribute to the Fund, as recommended by the Commission on Human Rights in its resolution 1999/46 of 27 April 1999. Upon recommendation by the Board, the High Commissioner agreed to renew this appeal in September 2000, in order to obtain a sufficient amount of money to enable the Fund to fulfil its mandate in the year 2001. Taking into consideration that requests received in 2000 amounted to about US\$ 700,000, in the Board's views, the Fund would need a minimum amount of US\$ 300,000 before January 2001.

Cooperation with the Working Group

- 12. In accordance with paragraph 8 of resolution 1999/18 of the Sub-Commission on the Promotion and Protection of Human Rights, the secretariat of the Working Group will invite the members of the Board in a position to do so to participate at the twenty-fifth session of the Working Group on Contemporary Forms of Slavery, to be held in Geneva from 14 to 23 June 2000.
- 13. In the selection of applications for travel grants at its sixth session in 2001, the Board will take into consideration the primary focus that the Working Group will identify at its session in June 2000.

Other recommendations

14. The Board encouraged the secretariat of the Fund to further develop cooperation with field offices of United Nations funds, programmes and agencies such as UNICEF, UNHCR, UNDP and ILO, as well as the International Organization for Migration.

- 15. The High Commissioner for Human Rights approved the recommendation that members of the Board visit projects, within their geographical region, for a better evaluation of the work carried out and planned.
- 16. The High Commissioner for Human Rights agreed with the Board's recommendation that a brochure on the activities of the Fund be prepared, for information and fund raising purposes, in a sufficient number of copies for wide dissemination to interested NGOs and donors.
