Annotations

1. Election of officers

Rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council stipulates that, at the commencement of the first meeting of a regular session, the Commission shall elect from among the representatives of its members a Chairperson, one or more Vice-Chairpersons and such other officers as may be required. Following the established practice, the Commission shall elect a Chairperson and four Vice-Chairpersons and designate one of the Vice-Chairpersons also as Rapporteur (Vice-Chairperson-and-Rapporteur).

In subparagraph (c) of its decision 2002/210, the Economic and Social Council decided that, immediately following the closure of a regular session, the Commission for Social Development would hold the first meeting of its subsequent regular session for the sole purpose of electing the new Chairperson and other members of the Bureau. Consequently, the Commission held the first meeting of its forty-ninth session on 19 February 2010, immediately following the closure of the forty-eighth session, and elected by acclamation Jorge Valero (Bolivarian Republic of Venezuela) as Chairperson of the Commission and Andi Xhoi (Albania), Katya Wiesbrock-Donovan (Germany), Jimmy Blas (Philippines) and Najla Abdelrahman (Sudan) as Vice-Chairpersons.

Subsequently, the Group of Asian States nominated Eduardo Menez (Philippines) upon the resignation of Mr. Blas, the Group of Eastern European States nominated Olisa Cifligu (Albania) upon the resignation of Mr. Xhoi, and the Group of Western European and other States nominated Susanne Fries-Gaier (Germany) upon the resignation of Ms. Wiesbrock-Donovan to represent their respective regional groups on the Bureau as Vice-Chairpersons.

At the opening meeting of the forty-ninth session of the Commission, on 9 February 2011, the nominees will be elected as Vice-Chairpersons. At the same meeting, the Commission will designate one of its Vice-Chairpersons as having rapporteurial responsibilities.

In accordance with Economic and Social Council resolution 2010/10 of 22 July 2010, the Chairperson and the Vice-Chairpersons of the forty-ninth session will be elected for a second year at the first meeting of the fiftieth session of the Commission, to be held immediately following the closure of the forty-ninth session.

2. Adoption of the agenda and other organizational matters

Rule 7 of the rules of procedure requires that, after the election of its officers at the beginning of each session, the Commission shall adopt the agenda for that session on the basis of the provisional agenda. The provisional agenda and documentation for the forty-ninth session of the Commission were approved by the Economic and Social Council in its decision 2010/242.

The proposed organization of work of the Commission at its forty-ninth session (see annex I) has been prepared pursuant to relevant decisions of the General Assembly and the Economic and Social Council to facilitate the consideration of agenda items within the time frame available and in accordance with the conference services allocated to the Commission. The timetable should be considered tentative and

indicative: if the Commission completes its consideration of an item ahead of schedule, it may wish to proceed immediately to the next item.

The Commission is scheduled to meet from Wednesday, 9 February, to Friday, 18 February 2011. Arrangements have been made to hold morning and afternoon meetings during the session: morning meetings will be held from 10 a.m. to 1 p.m. and afternoon meetings from 3 p.m. to 6 p.m.

3. Follow-up to the World Summit for Social Development and the twenty-fourth special session of the General Assembly

In accordance with General Assembly resolution 55/46 on the implementation of the outcome of the World Summit for Social Development and of the twenty-fourth special session of the General Assembly entitled “World Summit for Social Development and beyond: achieving social development for all in a globalizing world”, the Commission will undertake regular assessment of the implementation of the Copenhagen commitments and the further initiatives adopted at Geneva.

(a) Priority theme: poverty eradication

In its resolution 2010/10 of 22 July 2010, the Economic and Social Council decided that the priority theme for the 2011-2012 review and policy cycle would be poverty eradication, taking into account its interrelationship with social integration and full employment and decent work for all. The Commission will review the theme at its forty-ninth session in 2011. The Commission will have before it the report of the Secretary-General on the priority theme for the policy part of the 2011-2012 cycle.
