Statement

We are the one of the only active student-run organizations with Economic and Social Council consultative status on the global stage today. The International Relations Students' Association of McGill University is an independent group at the University, comprised of a diverse cohort of McGill students.

Volunteerism is the at the heart of the International Relations Students' Association of McGill University, with all of our programming executed by full-time students who devote precious hours and diligent effort to promoting student engagement in global affairs on our campus and in our respective local and international communities.

Of particular importance is the International Relations Students' Association of McGill University's Junior Peacemakers initiative, which offers elementary school students in Montréal globally-minded education on various social and political challenges.
