Annotations

1. Election of officers

Rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council stipulates that, at the commencement of the first meeting of a regular session, the Commission for Social Development shall elect from among the representatives of its members a Chair, one or more Vice-Chairs and such other officers as may be required. In subparagraph (c) of its decision 2002/210, the Council decided that, immediately following the closure of a regular session, the Commission would hold the first meeting of its subsequent regular session for the sole purpose of electing the new Chair and other members of the Bureau. Accordingly, the Commission held the first meeting of its fifty-eighth session on 21 February 2019, immediately following the closure of the fifty-seventh session. In the absence of any nominations for the Chair or other members of the Bureau for its fifty-eighth session, the Commission postponed the election of all of the members of the Bureau on the understanding that, upon nomination by their respective groups, the candidates would be allowed to participate in the meetings of the Bureau held in preparation for the fifty-eighth session.

On 10 February 2020, the Commission will be invited to elect, in accordance with established regional rotation, the Chair from the African States and Vice-Chairs from the Asia-Pacific States, the Eastern European States, the Latin American and Caribbean States and the Western European and other States, and to designate one of its Vice-Chairs as Rapporteur.

2. Adoption of the agenda and other organizational matters

Pursuant to rule 7 of the rules of procedure, after the election of its officers at the beginning of each session, the Commission adopt the agenda for that session on the basis of the provisional agenda. The provisional agenda and documentation for the fifty-eighth session were approved by the Economic and Social Council in its decision 2019/214.

The proposed organization of work (see annex I) has been prepared pursuant to relevant decisions of the General Assembly and the Economic and Social Council to facilitate the consideration of agenda items within the time frame available and in accordance with the conference services allocated to the Commission. The timetable should be considered tentative and indicative: if the Commission completes its consideration of an item ahead of schedule, it may wish to proceed immediately to the next item.

The Commission is scheduled to meet from Monday, 10 February, to Wednesday, 19 February 2020. Arrangements have been made to hold morning meetings, from 10 a.m. to 1 p.m., and afternoon meetings, from 3 to 6 p.m.

3. Follow-up to the World Summit for Social Development and the twenty-fourth special session of the General Assembly

In accordance with General Assembly resolution 55/46 on the implementation of the outcome of the World Summit for Social Development and of the twenty-fourth special session of the Assembly, entitled "World Summit for Social Development and beyond: achieving social development for all in a globalizing world", the Commission regularly assesses the implementation of the Copenhagen commitments and the further initiatives adopted in Geneva, in a manner consistent with the functions and

contributions of the relevant organs, organizations and bodies of the United Nations system, and advises the Economic and Social Council thereon.

The Commission serves as the main United Nations forum for an intensified global dialogue on social development issues and contributes to the follow-up to the 2030 Agenda for Sustainable Development, within its existing mandate, by supporting the thematic reviews of the high-level political forum on sustainable development on progress with regard to the implementation of the Sustainable Development Goals, including cross-cutting issues, which should reflect the integrated nature of the Goals as well as the interlinkages between them.

(a) Priority theme: affordable housing and social protection systems for all to address homelessness

In its resolution 2018/3, the Economic and Social Council decided that the Commission would consider one priority theme at each session on the basis of the follow-up to and review of the World Summit and its linkages to the social dimensions of the 2030 Agenda, proposing an action-oriented resolution with recommendations to the Council in order to contribute to its work. In its resolution 2019/4, the Council decided that the priority theme for the fifty-eighth session would be "Affordable housing and social protection systems for all to address homelessness". The Commission will have before it the report of the Secretary-General on the priority theme.

(c) Emerging issues: twenty-five years of the World Summit for Social Development: addressing emerging societal challenges to the implementation of the 2030 Agenda for Sustainable Development

In its resolution 2006/18, the Economic and Social Council decided to include the agenda item entitled "Emerging issues" in the programme of work of the Commission. The General Assembly invited the Commission to give appropriate consideration to the commemoration of the twenty-fifth anniversary of the World Summit by organizing a half-day meeting during the fifty-eighth session of the Commission (resolution 74/122, para. 66). Accordingly, and in consultation with the regional groups, the Bureau agreed that the theme for discussion under this agenda item during the session would be "Twenty-five years of the World Summit for Social Development: addressing emerging societal challenges to the implementation of the 2030 Agenda for Sustainable Development". A note by the Secretariat will be before the Commission to facilitate the discussion.
