#### **Annotations**

### 1. Election of officers

It is stipulated in rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council that, at the commencement of the first meeting of a regular session, the Commission for Social Development shall elect from among the representatives of its members a Chair, one or more Vice-Chairs and such other officers as may be required. In subparagraph (c) of its decision 2002/210, the Council decided that, immediately following the closure of a regular session, the Commission would hold the first meeting of its subsequent regular session for the sole purpose of electing the new Chair and other members of the Bureau. Accordingly, the Commission held the first meeting of its sixty-second session on 15 February 2023, immediately following the closure of the sixty-first session, and elected by acclamation Ruchira Kamboj (India) as Chair and Jon Ivanovski (North Macedonia), Carla Carlson (Dominican Republic) and Thomas Lammar (Luxembourg) as Vice-Chairs of the Commission for its sixty-second session. At the same meeting, the Commission postponed the election of the remaining officer, on the understanding that, upon nomination by the respective group, the candidate would be allowed to participate in the meetings of the Bureau held in preparation for the sixty-second session.

On 5 February 2024, the Commission will be invited to elect Vice-Chairs from the African States and the Western European and other States to fill the vacancy arising from the completion of the tour of duty of Thomas Lammar (Luxembourg), and to designate one of its Vice-Chairs as Rapporteur. ### 2. Adoption of the agenda and other organizational matters

Pursuant to rule 7 of the rules of procedure, after the election of its officers at the beginning of each session, the Commission shall adopt the agenda of that session on the basis of the provisional agenda. The provisional agenda and documentation for the sixty-second session were approved by the Council in its decision 2023/328.

The proposed organization of work (see annex I) has been prepared pursuant to relevant decisions of the General Assembly and the Council to facilitate the consideration of agenda items within the time frame available, in accordance with the conference services allocated to the Commission. The timetable should be considered tentative and indicative: if the Commission completes its consideration of an item ahead of schedule, it may wish to proceed immediately to the next item.

The Commission is expected to meet from Monday, 5 February, to Wednesday, 14 February 2024. Arrangements have been made to hold morning meetings, from 10 a.m. to 1 p.m., and afternoon meetings, from 3 to 6 p.m., during the session.

# 3. Follow-up to the World Summit for Social Development and the twenty-fourth special session of the General Assembly

In accordance with General Assembly resolution 55/46 on the implementation of the outcome of the World Summit for Social Development and of the twenty-fourth special session of the Assembly, entitled "World Summit for Social Development and beyond: achieving social development for all in a globalizing world", the Commission regularly assesses the implementation of the Copenhagen commitments and the further initiatives adopted in Geneva, in a manner consistent with the functions and contributions of the relevant organs, organizations and bodies of the United Nations system, and advises the Economic and Social Council thereon.

The Commission serves as the main United Nations forum for an intensified global dialogue on social development issues and contributes to the follow-up to the 2030 Agenda for Sustainable Development, within its existing mandate, by supporting the thematic reviews of the high-level political forum on sustainable development on progress with regard to the implementation of the Sustainable Development Goals, including cross-cutting issues, which should reflect the integrated nature of the Goals as well as the interlinkages between them.

In its resolution 2018/3, the Council decided that the Commission would consider one priority theme at each session on the basis of the follow-up to and review of the World Summit and its linkages to the social dimensions of the 2030 Agenda, proposing an action-oriented resolution with recommendations to the Council in order to contribute to its work. In its resolution 2023/12, the Council decided that the priority theme for the sixty-second session would be "Fostering social development and social justice through social policies to accelerate progress on the implementation of the 2030 Agenda for Sustainable Development and to achieve the overarching goal of poverty eradication". The Commission will have before it the report of the Secretary-General on the priority theme.
