Statement

On the wake of the 4th World Women Conference in Beijing in 1995 the International Muslim Women Union came into the international scene. It was established in 1996 and given special consultative status at the Economic and Social council of the United Nation.

Most of our leadership was present with active participation in Beijing. Hence the Beijing declaration and Platform of Action was present, (in its most areas of critical concern), in our strategy. Since the International Muslim Women Union is an international organization for Muslim women all over the globe, it embodies and caters to our vision, aspirations and ambitions. A vision based on the Islamic perspective and on Islamic approach towards all walks of life, without losing sight of the contemporary of issues in the international arena.

The International Muslim Women Union is very much concerned with eradication or rather alleviation of poverty. As such our projects are designed to meet this goal.

As mentioned earlier the International Muslim Women Union is a Platform for Muslim Women worldwide, it envisages a vision for a sounder world order, where conflicts are resolved, justice, equity peace and religious tolerance and co-existence, prevail.

The International Muslim Women Union is hosted by the generous country of Sudan. Out of gratitude and appreciation, we should mention that poverty situation is one of the challenges in this developing country, it is further aggravated by the unfair, unjustified and uncalled for unilateral sanction imposed on its people.

sustainable development. However, despite this steady increase in mortality, there are many opportunities to reduce mortality and provide excellent services for expectant mothers. These opportunities include midwifery training, which is an important strategy in achieving maternal and child health and to graduate significant number of African females in many scientific fields to achieve the objective of sustainable development.

International Muslim Women's Union is a voluntary and non-governmental organization, and its role is to assist women in African countries in general and Muslims in particular and vulnerable in the implementation of training courses in the field of maternal and child health and the project to ensure female students in the health fields in African Countries.

In view of the importance of the female students and their leading role, missionary and leadership in the societies, especially in African countries, which suffer from a shortage of health staff, the International Muslim Women's Union seeks to graduate the largest number of scientific competencies in this field by forming strategic partnerships with a number of Sudanese universities and institutions to provide an excellent educational environment for the incoming students under the terms and policies of the Ministry of Higher Education and Scientific Research.
