Statement

We, the International Students' Association of McGill, are a federally incorporated non-profit organization, established and operating at McGill University in Montréal, Canada. We are one of the few active student-run organisations with ECOSOC special consultative status on the global stage today. International Students' Association of McGill is an independent group at the University, comprised of a diverse cohort of McGill students. Volunteerism lies at the heart of International Students' Association of McGill. All of our programmes are executed by full-time students who devote precious hours and diligent effort to promoting student engagement in global affairs on our campus and in our respective local and international communities. Of particular note is International Students' Association of McGill's Junior Peacemakers initiative which offers elementary school students a globally-minded peace education through activities and discussion with intersectional approaches, in hopes of igniting their passion for change-making.

Through our many years of International Students' Association of McGill's consultative participation at the United Nations, it would be impossible for us to overstate our gratitude to the international community for the countless opportunities extended to us. International Students' Association of McGill acknowledges that social protection programs must undergo a gender-based and intersectional analysis in constructing inclusive approaches that consider the varying lived experiences of those identifying as a woman or girl. The diversity and importance of each woman's experience must be accounted for and must be a priority for the 63rd Session of the Commission on the Status of Women.
