Note by the Secretariat

1. The draft organization of work of the thirty-seventh session of the Commission on Population and Development, which is contained in the annex to the present note, has been prepared in order to facilitate the Commission's consideration of the items in the agenda for the session in accordance with the time and conference services allocated to it. The annotated provisional agenda for the session has been circulated as document E/CN.9/2004/1.

2. At its intersessional meeting, the Bureau of the Commission recommended that interventions by delegations during the debate on national experiences (agenda item 4) address the review and appraisal of the progress made in achieving the goals and objectives of the Programme of Action of the International Conference on Population and Development at the national level, taking into account the cross-cutting themes identified by the Bureau; namely, (a) population imperatives for sustainable development, and (b) building partnerships and capacity, and mobilizing human and financial resources for the implementation of the Programme of Action.

3. Meeting facilities will be available for two formal meetings of the Commission each day. The meeting hours will normally be from 10 a.m. to 1 p.m. and from 3 p.m. to 6 p.m.
