High-level political forum on sustainable development

Convened under the auspices of the Economic and Social Council 9–18 July 2018

Report of the high-level political forum on sustainable development convened under the auspices of the Economic and Social Council at its 2018 session

Summary

The 2030 Agenda for Sustainable Development is presently in its third year of implementation. There has been progress in many areas, such as the widespread adoption of the Sustainable Development Goals into national development plans and strategies and the creation of coordinating structures and mechanisms for implementation. Many countries are working to ensure coherence among actions to implement the 2030 Agenda and the Paris Agreement, the Sendai Framework for Disaster Risk Reduction 2015–2030 and the Addis Ababa Action Agenda of the Third International Conference on Financing for Development, as well as other internationally agreed instruments. Disaggregated data and statistics are gaining ground, supporting better policymaking towards reaching those furthest behind. The momentum around the 2030 Agenda remains strong. It will be critical to further increase the commitments in working towards the seventy-fourth session of the General Assembly, when the forum will meet under its auspices.

Despite positive trends, major disparities in achievements exist, both within and between countries. The least developed countries, landlocked developing countries and small island developing States continue to lag on almost all targets. Middle-income countries, for their part, face their own challenges of large groups of people being excluded from ensuring better lives for their families.

Moreover, lowered projections for sustainable economic growth and persistent patterns of inequality are cause for concern and require coordinated global action to address the root causes of difficult challenges. Wealth continues to be highly unevenly distributed, and decisions by a small group of individuals could do much to effect positive global change. The speed at which transformative actions are adopted will be critical for determining positive future progress towards the Sustainable Development Goals and ensure sufficient deployment of solutions to disrupt unsustainable patterns and practices.





Poverty and hunger, especially in rural areas, persist. There is a global deficit of social protection, especially towards vulnerable groups; access to water and sanitation services is lacking; and forest areas are decreasing while land degradation is threatening the livelihoods of millions. The increased occurrence of climate change-related disasters increases competition for natural resources, and the rising number of violent conflicts is driving food insecurity. Both developed and developing countries state that, with growing migratory flows, the capacity to address the specific needs of migrants are under strain everywhere. Certain populations remain at high risk of being left behind, including women and girls, children and youth, indigenous peoples, and people with disabilities. Extreme poverty is more prevalent among women, the current decline in maternal mortality is too slow, and access to health services is lagging.

Women and girls are also disproportionally affected by disasters and conflict, especially when living in poverty. Many are still deprived of their basic rights; in addition, indigenous peoples disproportionately suffer from a lack of recognition of their rights in some countries. The application of the principle of leaving no one behind could have a positive effect when efforts are made to ensure that those at risk not only receive benefits but also participate in and contribute to the process of sustainable development.

The increased recognition of the important role of disaggregated data in policymaking aiming to reach those furthest behind is a positive trend. However, greater commitment to developing official statistics and data is required. Effective monitoring systems need to be developed to more effectively measure progress, building on the ongoing data revolution. The absence of technology and infrastructure in rural areas presents a challenge, and statistics on inequalities and discrimination are often missing, including between countries. Gender-based violence is difficult to measure. By assessing the capacity of national statistical offices, focusing on methodology and maintaining confidentiality, inequalities within the socioeconomic context of a country and in relation to other forms of inequality can be measured and examined.

Building resilience requires extensive coordination and planning across various sectors. Actions to achieve resilience can be divided into three areas: reducing current and known risks; controlling future risks; and managing disasters or shocks as they occur. Drivers and underlying causes of disaster risk need to be addressed comprehensively and systematically, taking into account not only the impact on one sector but also the cascading impacts on other sectors. Resilience is critical for every aspect of the Sustainable Development Goals and can be considered an indicator of the overall health of societies in times of rising conflict, political instability and climate change.

Measures for temporary or partial debt forgiveness have helped countries to recover from shocks and can help to direct investment to the most fragile sectors in order to prepare for future shocks. Economic trade and social policies should focus on workers and populations rather than on specific jobs or sectors. It is critical to strengthen social protection systems, as they mitigate the effects of shocks, especially for the most vulnerable. A systems-thinking approach and a long-term perspective to build resilience at all levels requires investment in human capacity, understanding current and future population trends, timely and targeted investment in the capacities of the youth, adopting a proactive approach and investing in early warning systems. Other critical elements relate to the role of science and technology in strengthening resilience, the need for partnerships across borders, and regional cooperation to share experiences in resilience building on a continuous basis.

Leaving no one behind should not be rhetoric; it must be accompanied by concrete action plans. Some social groups are left further behind as a result of exclusive policies, and that must be changed. A broad set of integrated policies for social protection, combined with economic and fiscal policies conducive to reducing poverty and inequality, is necessary to leave no one behind. A whole-of-society approach needs to be taken by involving all stakeholders, particularly those who are left behind, not only as beneficiaries but also as agents of change.

The forum included reporting by the Chairs of the regional forums on sustainable development on the outcomes of their respective regional forums, underscoring the importance of the regional dimension, which provides both a critical nexus between the national and global levels and an important opportunity to share best practices and facilitate peer learning. The forums had addressed a variety of topics. Resilience building was considered a prerequisite for the achievement of the Sustainable Development Goals in Asia and the Pacific. In Africa, resilient structural transformation, in line with the 2030 Agenda and Agenda 2063, requires integrated national frameworks that also incorporate inclusion, protection against climate change and disaster risk reduction. The Arab Forum focused on natural resources, future generations and the common good and underscored the need for greater cooperation for sustainable management, highlighting, among other issues, economic diversification; resilient and sustainable cities; financing inclusive and sustainable development; the role of civil society; gender equality and women's empowerment; and engaging young people. In Latin America and the Caribbean, citizens' participation was stressed, putting people as the centre of actions. Challenges to achieving sustainable development in the region included poverty, inequality, high external debt and the reduction of levels of international cooperation.

The 46 voluntary national reviews carried out at the high-level political forum on sustainable development took stock of national actions, achievements and challenges, and identified next steps in implementing the 2030 Agenda. Many countries reported that the Sustainable Development Goals had support at the highest levels of governance and across the national political spectrum. All countries provided detailed accounts of steps taken to integrate the 2030 Agenda into their national policy frameworks. Many stated that arrangements such as interministerial committees on the Goals currently provided coordination and leadership, sometimes drawing on stakeholders from outside government. Domestic implementation is often based on a whole-of-government approach and partnerships, while a whole-of-society approach fosters stakeholder engagement and raises awareness on actions for implementation. Technical bodies support high-level institutions and committees, and national statistical offices are members of the coordinating institutions or provide them with technical support. To promote ownership within government, some countries have appointed focal points for the Sustainable Development Goals in line ministries and established related units to ensure effective coordination across departments and agencies. Institutions established and adapted at the municipal level provide evidence that implementation is also taking place subnationally. At the same time, there are continuing challenges, including the complexity of taking integrated approaches, the need to broadly communicate the Sustainable Development Goals and the means of implementation. Voluntary national reviews were found by reporting countries to be a useful process.

I. Introduction

- 1. The General Assembly, in its resolution 67/290, decided that the meetings of the high-level political forum on sustainable development under the auspices of the Economic and Social Council would be convened annually by the President of the Council for a period of eight days, including a three-day ministerial segment. Pursuant to paragraph 11 (c) of the annex to Assembly resolution 68/1, the three-day ministerial meeting is to be held during the high-level segment of the Council.
- 2. The Council, in its decision 2018/204, decided that the forum would be held from 9 to 13 July 2018 and the high-level segment of its 2018 session from 16 to 19 July, including the three-day ministerial meeting of the forum from 16 to 18 July.
- 3. In its resolution 70/299, the General Assembly decided that the theme of the 2018 session of the forum would be "Transformation towards sustainable and resilient societies" and that the forum, without prejudice to the integrated, indivisible and interlinked nature of the Sustainable Development Goals and with a view to facilitating an in-depth review of progress made on all Goals over the course of a four-year cycle, would review Goals 6, 7, 11, 12 and 15 in depth, in addition to its annual review of Goal 17.
- 4. The present report reflects the proceedings of the forum convened under the auspices of the Economic and Social Council at its 2018 session.

II. Proceedings of and action taken at the forum

- 5. From 9 to 18 July 2018, the forum held 26 meetings, composed of opening, wrap-up and closing segments, discussions on the review of Sustainable Development Goals 6, 7, 11, 12, 15 and 17, and thematic review panel discussions, as well as 46 voluntary national reviews. At its 16th meeting, on 16 July, the forum viewed a film, *Made in Forests*, which was introduced by the United Nations Development Programme Goodwill Ambassador and actress Michelle Yeoh. The forum also held a general debate on its theme within the framework of its three-day ministerial meeting during the high-level segment of the Council (see para. 187 below).
- 6. A total of 240 side events, 15 sustainable development learning courses and 7 special events, as well as other related activities, were held on the margins of the formal meetings of the forum and were sponsored by a diverse group of stakeholders, including Governments; agencies, funds and programmes of the United Nations system; international and intergovernmental organizations; and major groups and other relevant stakeholders. Opening of the forum

7. At the 1st meeting, on 9 July, the President of the Economic and Social Council, Marie Chatardová (Czechia), declared open the high-level political forum on

- sustainable development convened under the auspices of the Council at its 2018 session and made opening remarks.
- 8. At the same meeting, the Under-Secretary-General for Economic and Social Affairs, Liu Zhenmin, made a statement and introduced the report of the Secretary-General on progress towards the Sustainable Development Goals (E/2018/64).
- 9. Also at the same meeting, keynote addresses were made by the Director of the Center for Sustainable Development and professor at Columbia University, Jeffrey D. Sachs; the Special Envoy of the Secretary-General on Disability and Accessibility, María Soledad Cisternas Reyes; and the co-founder of the online magazine Worldchanging, Alex Steffen.

Wrap-up session of the first week and conclusion of the forum

- 10. At the 15th meeting, on 13 July, concluding the first week of the high-level political forum, an interactive discussion on the topic "Leaving no one behind: are we succeeding?" was chaired by the President of the Council and moderated by the Executive Vice-President and Managing Director of the World Resources Institute, Manish Bapna, who both made statements.
- 11. At the same meeting, the Assistant Secretary-General for Human Rights addressed the forum, followed by presentations by the rapporteurs of thematic clusters 1 and 2: the Deputy Director of the Bureau for Policy and Programme Support of the United Nations Development Programme, Douglas Keh; Director at the Ministry of Economy and Finance of Senegal, Mahi Amadou Deme; Deputy Director General at the Ministry of Foreign Affairs of Finland, Riitta Oksanen; and the Executive Secretary of the Economic Commission for Latin America and the Caribbean, Alicia Bárcena; and the following lead discussants: Vice-Chair of the Committee for Development Policy and professor of International Affairs at The New School, Sakiko Fukuda-Parr; the Special Rapporteur on the rights of indigenous peoples, Victoria Tauli Corpuz; the Future Generations Commissioner for Wales, Sophie Howe; and Strategic Adviser at Gray Panthers (representing the other stakeholders group for ageing), Sylvia Beales.
- 12. An interactive discussion ensued, during which the panellists responded to comments made and questions posed by the representatives of Chile, Belgium, Mauritania, Switzerland, Estonia and Sierra Leone, the Special Envoy on Disability and Accessibility, and the representatives of the major groups for business and industry and women and of the other stakeholders groups for Together 2030, education and academia, and persons with disabilities.
- 13. At the same meeting, the President of the Council presented her observations and highlighted trends that had emerged from the meetings during the forum's first week (9–13 July).
- 14. Also at the 15th meeting, the Under-Secretary-General for Economic and Social Affairs made a statement.
- 15. At the 24th meeting, on 18 July, at the conclusion of the forum, a keynote address was made by the Secretary-General of the United Nations.
- 16. At the same meeting, the President of the Council made a statement and declared closed the high-level political forum on sustainable development convened under the auspices of the Council at its 2018 session.

Action on the draft ministerial declaration

17. At its 24th meeting, on 18 July, the forum had before it the draft ministerial declaration of the 2018 high-level political forum on sustainable development,

convened under the auspices of the Economic and Social Council, on the theme "Transformation towards sustainable and resilient societies" (E/2018/L.20-E/HLPF/2018/L.2).

- 18. At the same meeting, the President of the Council informed the forum that the draft ministerial declaration contained no programme budget implications.
- 19. Also at the same meeting, the President of the Council drew the attention of the forum to the proposed amendments to the draft ministerial declaration submitted by the United States (E/HLPF/2018/L.3).
- 20. Also at the 24th meeting, the representative of the United States made a statement on a point of order to which the President responded.

Action on the amendment contained in paragraph 1 of document E/HLPF/2018/L.3

- 21. At the 24th meeting, on 18 July, the representative of the United States made a statement.
- 22. At the same meeting, the forum rejected the amendment by a recorded vote of 107 to 50, with 3 abstentions. The voting was as follows:²

- 3. Adoption of the ministerial declaration.
- 4. Adoption of the report.
