# Candidatures for the appointment of an External Auditor

## Report by the Director General

This document provides updates on the status of candidatures for the appointment of an External Auditor as of 5 November 2019.

- 1. Subsequent to the issuance of document IDB.47/11 and as announced in information note No. 83, a communication was received on 4 November 2019 from the Permanent Mission of Indonesia announcing the withdrawal of their candidate for the post of External Auditor. - 2. On 5 November 2019, as announced in information note No. 84, the Permanent Mission of Bhutan informed the Secretariat of the withdrawal of their candidate for the post of External Auditor. The communication is reproduced in annex II to the present document.


