Australia, Bangladesh, Belarus, Belize, Bhutan, Bosnia and Herzegovina, Burkina Faso, China, Cyprus, Eritrea, Ethiopia, Iceland, Iraq, Israel, Jamaica, Kazakhstan, Kyrgyzstan, Lebanon, Liberia, Liechtenstein, Malta, Montenegro, Tunisia, Turkey and Ukraine also joined in sponsoring the draft resolution.

The Committee adopted draft resolution A/C.3/62/L.23/Rev.1, as orally revised, without a vote.

After the adoption of the draft resolution, statements were made by the representatives of the United States and the Islamic Republic of Iran.

Oral decision

On the proposal of the Chairman, the Committee decided to take note of documents A/62/297 and A/62/259.

A statement was made by the representative of Portugal, on behalf of the European Union, in connection with draft resolution A/C.3/62/L.24/Rev.1, adopted at the 53rd meeting.

Austria, Bangladesh, the Comoros, Costa Rica, El Salvador, Guinea, Lebanon, Lesotho, Mauritania, the Niger, Nigeria, Spain and Sri Lanka also joined in sponsoring the draft resolution.

A statement was made by the representative of the United States.

The Committee adopted draft resolution A/C.3/62/L.44, without a vote.

After the adoption of the draft resolution, statements were made by the representatives of Cuba, Japan and the Cameroon.

Action on draft resolution A/C.3/62/L.49

The Secretary read out an oral statement of programme budget implications in connection with the draft resolution.

The representative of Cuba, on behalf of the Non-Aligned Movement, orally revised the draft resolution.

Grenada joined in sponsoring the draft resolution.

The Committee adopted draft resolution A/C.3/62/L.49, as orally revised, by a recorded vote of 121 to 52, with 1 abstention.

Before the vote, statements were made by the representatives of the United States and Portugal (on behalf of the European Union); after the vote, statements were made by the representatives of Colombia and Japan.

Oral decision

On the proposal of the Chairman, the Committee decided to take note of a number of documents under the item.

The Committee thus concluded its consideration of 70 (a), (b), (c) and (e) and 70 as a whole.

The Chairman made a statement and the Committee concluded its consideration of agenda item 129.

Revitalization of the work of the General Assembly [121]

Following statements by the representatives of Egypt, the Sudan, Benin and Uruguay, and clarifications made by the Secretary, the Committee approved its draft programme of work, as submitted by the Chairman in document A/C.3/62/L.86 and clarified by the Secretary, and decided to transmit it to the plenary of the General Assembly for approval.

The Committee thus concluded its consideration of agenda item 121.
