After the vote, a statement was made by the representative of Portugal (on behalf of the European Union; the candidate countries Turkey, Croatia and The former Yugoslav Republic of Macedonia; the countries of the Stabilization and Association Process and potential candidates Albania, Bosnia and Herzegovina, Montenegro, Serbia, and the EFTA country Iceland and Norway, members of the European Economic Area, as well as Ukraine, Moldova and Georgia).
