High-level Dialogue on Financing for Development
(23-24 October 2007)

The High-level Dialogue of the General Assembly on Financing for Development, under agenda item 53 (b) (High-level dialogue for the implementation of the outcome of the International Conference on Financing for Development), will be held on 23 and 24 October 2007 at the ministerial level. The overall theme of the High-level Dialogue will be “The Monterrey Consensus: status of implementation and tasks ahead”. The High-level Dialogue will consist of a series of formal and informal meetings and six interactive multi-stakeholder round tables. The modalities for the High-level Dialogue are contained in General Assembly resolutions 59/293 of 27 May 2005 and 61/191 of 20 December 2006.

Two plenary meetings will be held on Tuesday, 23 October 2007 (morning and afternoon) in the General Assembly Hall. Six round tables and an interactive dialogue will be held on Wednesday, 24 October 2007. The six round tables are as follows:

Round table 1 (10–11.30 a.m.): “*Mobilizing domestic financial resources for development*”;

Round table 2 (10–11.30 a.m.): “*Mobilizing international resources for development: foreign direct investment and other private flows*”;
