The representative of Panama made a statement, in explanation of vote before the vote.

By 109 votes to 8, with 55 abstentions (recorded vote), the General Assembly adopted draft resolution A/62/L.18 (resolution 62/80).

By 110 votes to 8, with 54 abstentions (recorded vote), the General Assembly adopted draft resolution A/62/L.19 (resolution 62/81).

By 161 votes to 8, with 5 abstentions (recorded vote), the General Assembly adopted draft resolution A/62/L.20/Rev.1 (resolution 62/82).

By 161 votes to 7, with 5 abstentions (recorded vote), the General Assembly adopted draft resolution A/62/L.21/Rev.1 (resolution 62/83).
