Decision: The proposal received 4 votes in favour, 8 against (France, Italy, Japan, Sweden, Ukraine, the United Kingdom of Great Britain and Northern Ireland, the United States and Uruguay) and 3 abstentions (Egypt, Ethiopia and Senegal) and was not adopted, having failed to obtain the required number of votes.

The President drew attention to the text of a draft resolution contained in document S/2017/884, submitted by Albania, Australia, Austria, Belgium, Bulgaria, Canada, Croatia, Cyprus, Czechia, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Israel, Italy, Japan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Montenegro, the Netherlands, Norway, Poland, Portugal, Qatar, the Republic of Korea, Romania, Slovakia, Slovenia, Spain, Turkey, Ukraine, the United Kingdom of Great Britain and Northern Ireland and the United States of America.

Before the vote, a statement was made by the Russian Federation.

The Council proceeded to vote on the draft resolution (S/2017/884) before it.

Decision: The draft resolution (S/2017/884) received 11 votes in favour, 2 against Bolivia (Plurinational State of) and the Russian Federation) and 2 abstentions (China and Kazakhstan) and failed to be adopted owing to the negative vote of a permanent member of the Council.

After the vote, statements were made by the United States, the United Kingdom, the Plurinational State of Bolivia, Japan, Ukraine, Italy, Ethiopia, Kazakhstan, Sweden, Senegal, Uruguay, China, Egypt, the Russian Federation and France.
