The Council proceeded to vote on the draft resolution (\$\frac{\scrt{S}}{2017}/1063}\) before it.

Decision: The draft resolution (S/2017/1063) received 12 votes in favour, none against and 3 abstentions (Plurinational State of Bolivia, China and the Russian Federation), and was adopted as resolution 2393 (2017).
