The Council proceeded to vote on the draft resolution (S/2018/853) before it.

Decision: The draft resolution (S/2018/853) received 15 votes in favour, none against and no abstentions and was adopted unanimously as resolution 2436 (2018).

After the vote, statements were made by the President, speaking in her capacity as the representative of the United States, Ethiopia, the Russian Federation, the Netherlands,

and China.
