The attention of any Member States intending to request an exemption under Article 19 of the Charter of the United Nations is drawn to the provisions of General Assembly resolution 54/237 C, in which the Assembly, inter alia, urges such Member States to provide the fullest possible supporting information.

The Assembly also decided that requests for exemption under Article 19 must be submitted by Member States *at least two weeks* before the session of the Committee on Contributions, so as to ensure a full review of the requests.

Accordingly, any such requests should be received by the President of the General Assembly *no later than Friday, 18 May 2018*.

The Committee on Contributions will also be considering multi-year payment plans submitted pursuant to General Assembly resolution [57/4 B](#), as reaffirmed in resolution [70/245](#).
