# **Commission on the Status of Women** Sixty-third session

	The Chair of the Commission, Her Excellency Geraldine Byrne Nason of Ireland, opened the meeting and reconvened the sixty-third session of the Commission.	

Election of officers - Item 1

The Commission resumed its consideration of the item.

The Chair recalled that, at the first meeting of the sixty-second session, on 24 March 2017, the Commission had elected Mr. Mauricio Carabali Baquero of Colombia as Vice-Chair of its sixty-second and sixty-third sessions.

The Chair also recalled that, at the second meeting of its sixty-second session, held on 12 March 2018, the Commission had elected Ms. Rena Tasuja of Estonia as Vice-Chair, as well as herself as Chair, of its sixty-second and sixty-third sessions.

The Chair further recalled that, at the first meeting of the sixty-third session, held on 23 March 2018, the Commission had elected Her Excellency Koki Muli Grignon of Kenya as Vice-Chair of its sixty-third session, and postponed the election of the Vice-Chair from the Asia-Pacific States.

Election of a Vice-Chair

The Commission elected, by acclamation, Mr. Mohammed Marzooq of Iraq as Vice-Chair of the sixty-third session of the Commission.

Designation of the Rapporteur

The Commission was informed that Ms. Rena Tasuja of Estonia would also serve as Rapporteur for the sixty-third session of the Commission.

Appointment of the remaining members of the Working Group on Communications on the Status of Women

The Chair recalled that, at the first meeting of the sixty-third session, on 23 March 2018, the Commission appointed Belgium and the Russian Federation to serve on the Working Group on Communications at the sixty-third session of the Commission and postponed the appointment of the remaining members of the Working Group.

The Commission appointed the Islamic Republic of Iran and Nigeria to serve on the Working Group on Communications of its sixty-third session and postponed the appointment of the remaining member of the Working Group.

Adoption of the agenda and other organizational matters - Item 2

The Commission began its consideration of the item and adopted its provisional agenda (E/CN.6/2019/1) and approved its organization of work (E/CN.6/2019/1/Add.1), on the understanding that further adjustments may be made as the session progresses.

- (a) Implementation of strategic objectives and action in critical areas of concern and further actions and initiatives
  - Priority theme: social protection systems, access to public services and sustainable infrastructure for gender equality and the empowerment of women and girls
  - (ii) Review theme: women's empowerment and the link to sustainable development (agreed conclusions of the sixtieth session)
- (b) Emerging issues, trends, focus areas and new approaches to questions affecting the situation of women, including equality between women and men

The Commission began its consideration of the item as a whole.

**Opening statements** 

Following a statement by the Chair, the Secretary-General of the United Nations, the President of the Economic and Social Council, the President of the seventy-third session of the General Assembly and the President of the Security Council, addressed the Commission.

Introductory statements

An introductory statement was made by the Executive Director of the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women).

A joint statement was made by two civil society representatives.
