

8325th meeting The situation in Burundi

The agenda was adopted without objection.

The President invited the representative of Burundi to participate in the meeting in accordance with rule 37 of the Council's provisional rules of procedure.

The President invited Mr. Michel Kafando, Special Envoy of the Secretary General for Burundi, to participate in the meeting in accordance with rule 39 of the Council's provisional rules of procedure.

The Council began its consideration of the item and heard a briefing by Mr. Kafando.

Statements were made by the representatives of France, Equatorial Guinea, Kuwait, the Netherlands, Côte d'Ivoire, Ethiopia, Sweden, the United States, Kazakhstan, China, Poland, Peru, the Russian Federation, the Plurinational State of Bolivia, and by the President, speaking in his capacity as the representative of the United Kingdom.

The Council heard a statement by the representative of Burundi.

United Nations Interim Force in Lebanon
