111th plenary meeting     *Approval of the appointment of the United Nations High Commissioner for Human Rights: note by the Secretary-General (A/72/945) - Item 115 (h)*


The General Assembly, on the proposal of the Secretary-General, appointed Ms. Michelle Bachelet (Chile) as United Nations High Commissioner for Human Rights for a term of office of four years beginning on 1 September 2018 and expiring on 31 August 2022 (decision 72/422).

Statements were made by the representatives of Madagascar (on behalf of the African States), Solomon Islands (on behalf of the Asia-Pacific States), Estonia (on behalf of the Eastern European States), Argentina (on behalf of the Latin American and Caribbean States), the United States (as host country), New Zealand (also on behalf of Australia and Canada), the European Union, the United Kingdom (also on behalf of Andorra, Austria, Belgium, Denmark, Finland, Iceland, Ireland, Italy, Liechtenstein, Luxembourg, Malta, Monaco, the Netherlands, Norway, Portugal, San Marino, Sweden and Switzerland) Switzerland, the Islamic Republic of Iran and Chile.

Statements in the exercise of the right of reply were made by the representatives of Cuba, the Bolivarian Republic of Venezuela and the United States.

The General Assembly thus concluded its consideration of sub-item (h) of agenda item 115 and agenda item 115 as a whole.
