The attention of any Member States intending to request an exemption under Article 19 of the Charter of the United Nations is drawn to the provisions of General Assembly resolution 54/237 C, in which the Assembly, *inter alia*, urges such Member States to provide the fullest possible supporting information.

The Assembly also decided that requests for exemption under Article 19 must be submitted by Member States *at least two weeks* before the session of the Committee on Contributions, so as to ensure a full review of the requests.

Accordingly, any such requests should be received by the President of the General Assembly *no later than Friday, 18 May 2018*. The Committee on Contributions will also be considering multi-year payment plans submitted pursuant to General Assembly resolution 57/4 B, as reaffirmed in resolution 70/245.

2nd meeting

The Acting-Chair of the Commission, Her Excellency Koki Muli Grignon (Kenya), opened the meeting and reconvened the sixty-second session of the Commission.

*Election of officers* [item 1]

*Election of Chair*

The Commission resumed its consideration of the item.

The Chair recalled that the Commission had elected His Excellency David Donoghue (Ireland), by acclamation, as Chair of the sixty-second and sixty-third sessions of the Commission, at the first meeting of the sixty-second session, on 24 March 2017.

Following the departure of His Excellency David Donoghue (Ireland) from his post, the Commission then elected, by acclamation, Her Excellency Geraldine Byrne Nason, as the Chair of the Commission for its sixty-second and sixty-third sessions.

*Election of other members of the Bureau*

The Acting-Chair further recalled that at its first meeting, the Commission had elected Her Excellency Koki Muli Grignon (Kenya) as Vice-Chair of the Commission at its sixty-second session, and Mr. Mauricio Carabali Baquero (Colombia), as Vice-Chair of the Commission at its sixty-second and sixty-third sessions. Subsequently, the Commission elected, by acclamation, Mr. Shah Asif Rahman (Bangladesh) and Ms. Rena Tasuja (Estonia) as Vice-Chairs for the sixty-second session and sixty-second and sixty-third sessions, respectively.

*Election of the Rapporteur*

The Commission was informed that Her Excellency Koki Muli Grignon (Kenya), would also serve as Rapporteur for the sixty-second session.

*Appointment of the remaining members of the Working Group on Communications on the Status of Women*

The Commission elected, by acclamation, Nigeria, Qatar and the Russian Federation, to serve as members of the Working Group on Communications at the sixty-second session of the Commission.

*Adoption of the agenda and other organizational matters [item 2]*

The Commission began its consideration of the item and adopted its provisional agenda (E/CN.6/2018/1) and approved its organization of work (E/CN.6/2018/1/Add.1), on the understanding that further adjustments may be made as the session progresses.

*Follow-up to the Fourth World Conference on Women and to the twenty-third special session of the General Assembly, entitled "Women 2000: gender equality, development and peace for the twenty-first century"* [item 3]

- (a) *Implementation of strategic objectives and action in critical areas of concern and further actions and initiatives*
  - (i) *Priority theme: challenges and opportunities in achieving gender equality and the empowerment of rural women and girls*
  - (ii) *Review theme: challenges and achievements in the implementation of the Millennium Development Goals for women and girls*
- (b) *Emerging issues, trends, focus areas and new approaches to questions affecting the situation of women, including equality between women and men*
- (c) *Gender mainstreaming, situations and programmatic matters*

The Commission began its consideration of the item as a whole.

*Opening statements*

Following a statement by the Chair, the Secretary-General of the United Nations, the President of the Economic and Social Council (Czech Republic) and the President of the seventy-second session of the General Assembly, addressed the Commission.

*Introductory statements*

Introductory statements were made by the Executive Director of the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women) and the Vice-President of the International Fund for Agricultural Development (also on behalf of the Food and Agriculture Organization and the World Food Programme).

A joint statement was made by two civil society representatives on behalf of rural women and girls.

Statements were also made by the Chair of the Convention on the Elimination of all Forms of Discrimination Against Women; and the Special Rapporteur on violence against women, its causes and consequences Committee.

*General discussion*

The Commission began its general discussion of agenda item 3 as a whole.

Statements were made by the representatives of Egypt (on behalf of the Group of 77 and China), Tunisia (on behalf of the Arab Group), Guyana (on behalf of the Caribbean Community) and Brazil (also on behalf of Angola, Cabo Verde, Equatorial Guinea, Guinea-Bissau, Mozambique, Portugal, São Tomé and Príncipe and Timor Leste, comprising the community of Portuguese language countries).

Statements were also made by the observers of the Gambia (on behalf of the Group of African States), Bulgaria (on behalf of the European Union), Slovenia (on behalf of Argentina, the Plurinational State of Bolivia, Brazil, Chile, Colombia, Costa Rica, the Dominican Republic, Ecuador, El Salvador, Guatemala, Honduras, Indonesia, Kenya, Malaysia, Mexico, Panama, Peru, Qatar, Slovenia, South Africa, Trinidad and Tobago, Turkey and Uruguay, comprising the Group of Friends of Older Persons), Marshall Islands (on behalf of the Pacific Islands Forum), Thailand (on behalf of the Association of Southeast Asian Nations) and the Dominican Republic (on behalf of Belize, Costa Rica, the Dominican Republic, El Salvador, Guatemala, Honduras, Nicaragua, Panama, members of the Central American Integration System).
