After the vote, statements were made by the representatives of Sweden, Ethiopia, Kazakhstan, Equatorial Guinea, France, the Netherlands, Kuwait, China, the Russian Federation and the United Kingdom; and by the President, speaking in his capacity as the representative of Peru.

The representative of the Syrian Arab Republic made a further statement.
