
Financial report

I. Introduction

- 1. During the 13th plenary meeting of the tenth Review Conference of the Parties to the Treaty on the Non-Proliferation of Nuclear weapons, on 26 August 2022, States parties to the Treaty adopted a decision to establish a working group on further strengthening the review process of the Treaty, to discuss and make recommendations to the Preparatory Committee that would improve the effectiveness, efficiency, transparency, accountability, coordination and continuity of the review process of the Treaty (NPT/CONF.2020/DEC.2).
- 2. States parties to the Treaty agreed that the costs associated with the preparation and holding of the working group on further strengthening the review process of the Treaty would be borne by the States parties through a one-time assessed contribution.
