# Peacebuilding Commission Organizational Committee

# Provisional rules of procedure of the Peacebuilding Commission

Rule 1 Chair

(a) The Peacebuilding Commission consists of various configurations: the Organizational Committee and country-specific meetings.

(b) The membership of the Organizational Committee shall select the Chair and Vice-Chairs of the Peacebuilding Commission from among its members for a term of one year. Due consideration shall be given to criteria included in General Assembly resolution 60/180 and Security Council resolution 1645 (2005), including representation from all regional groups (see annex).<sup>1</sup>

(c) The Chair or the Vice-Chairs of the Commission shall preside over both the Organizational Committee and the country-specific meetings, unless the Organizational Committee decides otherwise.

### Rule 2

#### Sessions and meetings

(a) The Organizational Committee shall meet, as required, on invitation of the Chair acting in consultation with the members of the Organizational Committee, to fulfil the responsibilities, in accordance with General Assembly resolution 60/180 and Security Council resolution 1645 (2005), including, inter alia, the setting of the agenda, issuing of invitations for country-specific meetings and review of the annual report.

(b) Country-specific meetings shall be convened as necessary.

(c) Meetings of the Peacebuilding Commission shall be held in public or private, as appropriate. Decisions on whether a meeting shall be held in public or private shall be taken by the Chair in consultation with the members of the respective configuration.

(d) For each meeting of the Peacebuilding Commission, the respective Chair, assisted, as required, by the Peacebuilding Support Office, will prepare a draft agenda.

(e) Arabic, Chinese, English, French, Russian and Spanish shall be both the official and the working languages of the Peacebuilding Commission.

#### Rule 3 Agenda

The agenda of the Peacebuilding Commission shall be established by the Organizational Committee, in accordance with paragraph 12 of General Assembly resolution 60/180 and Security Council resolution 1645 (2005). The Chair of the Peacebuilding Commission will, as appropriate, consult with those requesting advice, in accordance with paragraph 12 of General Assembly resolution 60/180 and Security Council resolution 1645 (2005).

# Rule 4

#### **Participation**

(a) Mindful of the intergovernmental character of the Peacebuilding Commission, members of the Commission and participants, in accordance with paragraphs 7, 8 and 9 of General Assembly resolution 60/180 and Security Council resolution 1645 (2005), shall be given the opportunity to participate fully and equally in the discussions of the Commission in a flexible and interactive manner.

(b) The Chair of the Peacebuilding Commission shall, in consultation with its members, provide on a regular basis for consultation with representatives of civil society, non-governmental organizations, including women's organizations, and the private sector engaged in peacebuilding activities, as appropriate. To ensure this, the Peacebuilding Commission shall develop further details and modalities.

#### Rule 5

#### Conclusions

For meetings of the Peacebuilding Commission, the Chair shall, where appropriate, present conclusions and recommendations agreed by consensus among the Member States of the respective configuration.

# Rule 6

#### Review

These provisional rules of procedure shall be further developed and reviewed in the light of the practical work of the Commission, as necessary.

# Annex

# Selection of the Chair and Vice-Chairs of the Peacebuilding Commission

The provision below was adopted by the Organizational Committee of the Peacebuilding Commission on 29 November 2012. It constitutes an integral part of the provisional rules of procedure of the Peacebuilding Commission and should be read as an addition to rule 1, paragraph (b), of the provisional rules of procedure.

The Chair shall be selected from the Group of African States, followed by the Group of Asia-Pacific States, the Group of Eastern European States, the Group of Latin American and Caribbean States and the Group of Western European and other States. The two Vice-Chairs shall be selected from two regional groups other than that of the Chair.
