Algeria, Argentina, Nepal, Senegal, Yugoslavia and Zambia: draft resolution_

The Security Council,

Having considered the Secretary-General's report of 21 January 1988 (\$/19443) pursuant to resolution 605 (1987),

<u>Expressing</u> its grave concern over the increasing suf ferings of the Palest inian people in the occupied Palestinian territories,

Bearing in mind the Inalienable rights of all people recognized by the Charter of the United Nations and proclaimed by the Universal Declaration of Human Rights,

Reaffirming that the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949, is applicable to the Palestinian and other Arab territories occupied by Israel since 1967, including Jerusalem,

<u>Commending also</u> the United Nations Relief **and** Works Agency for Palestine Refugees in the Near East for its invaluable work,

 $\underline{\textit{Conscious}}$ of the urgent need to resolve the underlying problem through a comprehensive, just and lasting settlement, including a solution to the Palestinian problem in all its aspects,

- 1. Expresses its deep appreciation to the Secretary-Ceneral for his report;
- 2. <u>Calls upon</u> Israel, **as** the occupying Power and as a High Contracti ng Party to the Geneva Convention relative to the Protection of Civilian Persons in Time of war, of 12 August 1Y49, **to** accept the <u>de jure</u> applicability of **the Convention** to the Palestinian and other Arab territories occupied since **1967**, including Jerusalem, and **fully** to comply with its obligations under that Convention;

- 3. Recalls the obligation of all the High Contracting Parties, under article 1 of the Convention, to ensure recepet for the Convention in all circumstances:
- 4. <u>Calls again</u> upon Israel to desist forthwith from its policies and practices which violate **the human** rights of the Palestinian people;
- 5. Requests Israel to facilitate the task of the International Committee of the Hed Cross and of the United Nations Relief and Works Agency for Palestine Refugees in the Near East and requests all Members to give them their full support;
- b. Reyuests the Secretary-General to continue to monitor the situation in the occupied territories by all means available to him and to make regular and timely reports to the Council;
- 7. Affirms the urgent need to achieve, under the auspices of the United Nations, a comprehensive, just and lasting settlement of the Arab/Israeli conflict, an integral part of which is the Palestinian problem, and expresses its determination to work towards that end:
- **8.** <u>Requests</u> the Secretary-General to continue his endeavours to prornote such a settlement and to keep the Council regularly Informed;
- 9. <u>Decides</u> to keep the situation in the Palestinian and other **Arab** territories occupied by Israel since 1967, Including Jerusalem, under review.
