**Letter dated 23 July 2004 from the Secretary-General addressed to the President of the Security Council**

I have the honour to refer to article 12 bis, paragraph 2, of the statute of the International Criminal Tribunal for Rwanda, which reads as follows:

“In the event of a vacancy in the Chambers amongst the permanent judges elected or appointed in accordance with this article, after consultation with the Presidents of the Security Council and of the General Assembly, the Secretary-General shall appoint a person meeting the qualifications of article 12 of the present statute, for the remainder of the term of office concerned.”

In this connection, I should like to inform you that Judge Asoka Gunawardena, a national of Sri Lanka, has resigned as a permanent judge of the International Tribunal, effected 30 June 2004.

The Government of Sri Lanka has presented the candidacy of the Judge J. Asoka de Silva, a national of Sri Lanka, to replace Judge Gunawardena. Please find attached his curriculum vitae (see annex).\*

It is my view that Judge de Silva meets the qualifications that are prescribed in article 12 of the statute of the International Tribunal. I also consider that Judge de Silva's appointment would be well calculated to ensure adequate representation in the Tribunal of the principal legal systems of the world, as contemplated in paragraph 1 (c) of article 12 bis of the Tribunal's statute.

I should, therefore, like to proceed to consult with you on the appointment of Judge de Silva, in accordance with article 12 bis, paragraph 2, of the statute of the International Criminal Tribunal for Rwanda. I look forward to receiving your views on the matter.
