Identical letters dated 14 November 2012 from the Secretary-General addressed to the President of the General Assembly and the President of the Security Council

I have the honour to transmit to you the attached letter dated 29 October 2012 from Judge Theodor Meron, President of the International Tribunal for the Former Yugoslavia.

In his letter, Judge Meron requests the extension of the term of office of 13 permanent judges of the Trial and Appeals Chambers and 8 ad litem judges of the Trial Chamber of the Tribunal until the dates set out therein or until the completion of the cases to which they are or will be assigned, if sooner.

I recall that, pursuant to Security Council resolution 1931 (2010) and General Assembly decision 64/416 C, the current term of office of the judges of the Appeals Chamber is set to expire on 31 December 2012. Similarly, according to Security Council resolution 1993 (2011) and General Assembly decision 65/413 B, the term of office of the judges of the Trial Chamber expires on 31 December 2012. However, it is evident from the updated trial and appeals schedules that the cases to which these judges are or will be assigned will not be completed by the end of this year. Therefore, it is necessary to extend the term of office of the judges beyond 31 December 2012.

It falls to the General Assembly and the Security Council to consider and decide on this request. Accordingly, I should be grateful if you would bring the letter from Judge Meron to the attention of the members of the General Assembly and of the Security Council.

Letter dated 29 October 2012 from the President of the International Tribunal for the Former Yugoslavia addressed to the Secretary-General

I have the honour of referring to Security Council resolution 1931 (2010) of 29 June 2010, in which the Security Council extended the terms of office of the judges of the Appeals Chamber until 31 December 2012 or until the completion of the cases to which they are assigned or until the completion of their term as members of the Appeals Chamber, if sooner. I also have the honour of referring to Security Council resolution 1993 (2011) of 29 June 2011, in which the Security Council (1) extended the terms of office of the permanent judges of the Trial Chambers until 31 December 2012 or until the completion of the cases to which they are assigned, if sooner; and (2) extended the terms of office of the ad litem judges of the Trial Chambers until 31 December 2012 or until the completion of the cases to which they are assigned, if sooner.

By this present letter, I wish to submit updated trial and appeal schedules and to bring to your attention the necessity of extending the terms of office of the Tribunal's permanent judges and of certain ad litem judges.

By reference to the attached trial and appeal schedules, the following extensions are sought:



Trial schedule of the International Tribunal for the Former Yugoslavia


