

Observance of the ceasefire regime

Monitoring groups have continued to monitor observance of the ceasefire regime as part of implementing the memorandum on the creation of de-escalation areas in the Syrian Arab Republic, signed by the Russian Federation, the Republic of Turkey and the Islamic Republic of Iran on 4 May 2017.

The number of violations by illegal armed groups active in the Idlib de-escalation area has decreased.

The Russian representative office of the Russian and Turkish Joint Commission reviewing issues related to violations of the ceasefire regime has reported two incidents of gunfire: one in Idlib Governorate and one in Ladhiqiyah Governorate.

The Turkish representative office has not reported any violations.

Provision of humanitarian aid to the population of the Syrian Arab Republic

The Centre for Reconciliation of Opposing Sides in the Syrian Arab Republic has not carried out any humanitarian operations over the past 24 hours.

In total, 1,978 humanitarian operations have been carried out. The total weight of humanitarian cargo delivered is 3,095 tons.

Reconciliation of opposing sides

No ceasefire agreements have been signed over the past 24 hours.

The number of populated areas that have joined the reconciliation process is 2,518.

The number of armed groups that have announced their commitment to accepting and fulfilling the terms of the ceasefire is unchanged — it is still 234.

The Russian representative office of the Russian and Turkish Joint Commission reviewing issues related to violations of the ceasefire regime has reported seven incidents of gunfire: five in Aleppo Governorate and two in Ladhiqiyah Governorate.

The Turkish representative office has not reported any violations.

Provision of humanitarian aid to the population of the Syrian Arab Republic

Over the past 24 hours, the Centre for Reconciliation of Opposing Sides in the Syrian Arab Republic has carried out one humanitarian operation: in Zamalka, Rif Dimashq Governorate, 300 food parcels with a total weight of 1.29 tons were distributed.

In total, 1,979 humanitarian operations have been carried out. The total weight of humanitarian cargo delivered is 3,096 tons.

Reconciliation of opposing sides

No ceasefire agreements have been signed over the past 24 hours.

The number of populated areas that have joined the reconciliation process is 2,518.

The number of armed groups that have announced their commitment to accepting and fulfilling the terms of the ceasefire is unchanged — it is still 234.

Provision of humanitarian aid to the population of the Syrian Arab Republic

In total, 1,981 humanitarian operations have been carried out. The total weight of humanitarian cargo delivered is 3,100.39 tons.
