

Observance of the ceasefire regime

Monitoring groups have continued to monitor observance of the ceasefire regime as part of implementing the memorandum on the creation of de-escalation areas in the Syrian Arab Republic, signed by the Russian Federation, the Republic of Turkey and the Islamic Republic of Iran on 4 May 2017.

The Russian representative office of the Russian and Turkish Joint Commission reviewing issues related to violations of the ceasefire regime has reported five incidents of gunfire: three in Hama Governorate and two in Aleppo Governorate.

The Turkish representative office has reported eight incidents of gunfire in the following Governorates: four in Hama, three in Aleppo and one in Ladhiqiyah.

Provision of humanitarian aid to the population of the Syrian Arab Republic

Over the past 24 hours the Centre for Reconciliation of Opposing Sides and Refugee Migration Monitoring has carried out one humanitarian operation: in Ghadir al-Bustan, Dayr al-Zawr Governorate, food parcels with a total weight of 2.165 tons were delivered.

In total, 2,054 humanitarian operations have been carried out. The total weight of humanitarian cargo delivered is 3,242.858 tons.

Reconciliation of opposing sides

No ceasefire agreements have been signed over the past 24 hours.

The number of populated areas that have joined the reconciliation process is 2,518.

The number of armed groups that have announced their commitment to accepting and fulfilling the terms of the ceasefire is unchanged – it is still 234.

Observance of the ceasefire regime

Monitoring groups have continued to monitor observance of the ceasefire regime as part of implementing the memorandum on the creation of de-escalation areas in the Syrian Arab Republic, signed by the Russian Federation, the Republic of Turkey and the Islamic Republic of Iran on 4 May 2017.

The Russian representative office of the Russian and Turkish Joint Commission reviewing issues related to violations of the ceasefire regime has reported 12 incidents of gunfire in the following Governorates: 7 in Ladhiqiyah, 2 in Hama, 2 in Aleppo and 1 in Idlib.

The Turkish representative office has reported nine incidents of gunfire: seven in Hama Governorate and two in Ladhiqiyah Governorate.

Provision of humanitarian aid to the population of the Syrian Arab Republic

Over the past 24 hours the Centre for Reconciliation of Opposing Sides and Refugee Migration Monitoring has carried out two humanitarian operations:

- In Mazlum, Dayr al-Zawr Governorate, 500 food parcels with a total weight of 2.165 tons were delivered
- In Hazzah, Damascus Governorate, 500 food parcels with a total weight of 2.165 tons were delivered.

In total, 2,056 humanitarian operations have been carried out. The total weight of humanitarian cargo delivered is 3,247.188 tons.

Reconciliation of opposing sides

No ceasefire agreements have been signed over the past 24 hours.

The number of populated areas that have joined the reconciliation process is 2,518.
