Letter dated 10 July 2019 from the President of the Security Council addressed to the Secretary-General

Annex

Terms of reference of the Security Council mission to Colombia, 11 to 14 July 2019

1. The Security Council will carry out its mission to Colombia within the context of Council resolutions [2366 \(2017\)](#), [2377 \(2017\)](#) and [2435 \(2018\)](#). The mission will be co-led by Peru and the United Kingdom of Great Britain and Northern Ireland.
2. The objectives of the mission are as follows:
 - (a) To demonstrate the Security Council's full commitment to the peace process in Colombia and its support for the implementation of the Final Agreement for Ending the Conflict and Building a Stable and Lasting Peace;
 - (b) To observe and support the efforts of the United Nations Verification Mission in Colombia to implement its mandate, in line with Council resolutions [2366 \(2017\)](#), [2377 \(2017\)](#) and [2435 \(2018\)](#);
 - (c) To acknowledge the importance of the end of the conflict with the former Revolutionary Armed Forces of Colombia-People's Army, to recognize the challenges of building peace after more than 50 years of conflict, to understand the aspirations and concerns of the parties and other actors and to encourage positive cooperation and continued momentum in implementing the Agreement for the benefit of all Colombians.
3. The mission will seek to achieve the objectives through meetings with representatives of:
 - (a) The Government of Colombia;
 - (b) The People's Alternative Revolutionary Force political party;
 - (c) The United Nations Verification Mission in Colombia;
 - (d) The Peace Commissions of Congress;
 - (e) The transitional justice institutions under the Comprehensive System of Truth, Justice, Reparation and Non-Repetition;
 - (f) The United Nations country team in Colombia;
 - (g) Members of civil society, community leaders and non-governmental organizations.
4. The mission will seek to achieve its objectives through a visit to a territorial area for training and reintegration where former combatants of the Revolutionary Armed Forces of Colombia-People's Army are undergoing their reintegration, which will include meetings with residents of the territorial area for training and reintegration, authorities and relevant civil society and community leaders.
5. The mission will also seek to implement lessons learned from previous Security Council missions.
6. The Security Council will be accompanied by representatives of the media.
