### **Security Council Committee established pursuant to resolution 1540 (2004)**

#### **Note verbale dated 19 April 2006 from the Permanent Mission of Chile to the United Nations addressed to the Chairman of the Committee**

The Permanent Mission of Chile to the United Nations presents its compliments to the Security Council Committee established pursuant to resolution 1540 (2004), and has the honour to submit the attached report (see annex), which complements and expands on the Government of Chile's declaration with respect to paragraph 4 of resolution 1540 (2004), which the Republic of Chile also complied with in October of 2004 and in declarations throughout the course of 2005.

**Background information on the implementation by Chile of resolution 1540**

(Where pertinent, the item number on the matrix for Security Council resolution 1540 (2004) is indicated in parentheses.)

**1. National laws or legislative provisions referring to the prohibition to non-State actors to acquire, possess, develop, transport, transfer or use chemical weapons and their means of delivery:**

**1.1 Conventions, agreements and declarations:**

Chile signed the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons and on Their Destruction on 14 January 1993 and ratified it on 12 July 1996.

The Convention was promulgated as a law of the Republic by DS 1,764 of 2 December 1996 and published in the *Diario Oficial* on 11 March 1997.

For the purpose of implementing the Convention, the General Directorate of National Mobilization (DGMN) was designated, by DS 364 of 13 March 1997, as the National Authority (OP 1, No. 5 on the matrix).

The National Authority is required to submit annual reports to the Technical Secretariat of the Organization for the Prohibition of Chemical Weapons (OPCW) on activities that are regulated by the Convention. In its initial declaration, submitted to the Technical Secretariat of OPCW in 1997, Chile stated that it did not possess chemical weapons (OP 1, No. 1 on the matrix).

**1.2 On national legislation**

Act 17,798, on Control of Arms, Explosives and Similar Elements, establishes legal measures for dealing with conventional weapons and also provides, in Article 2 (e), for control of “elements that have physiological effects”.

In addition, article 3 prohibits the possession of devices manufactured on the basis of asphyxiating, paralysing or poisonous gases. It also prohibits the possession of so-called special weapons or weapons of mass destruction, such as chemical, biological, toxic and nuclear weapons (OP 2 and OP 3 (a) and (b), chemical, biological and nuclear weapons, Nos. 1-14 on the matrix).

An amendment to Act 17,798 has been introduced with the aim of including detailed provisions on the control and prohibition of the chemical weapons and chemical substances mentioned in Lists 1, 2 and 3 of the Convention on Chemical Weapons, establishing controls on those substances as well as on the industrial facilities that produce them. The new text has been completed and is currently being considered for approval by DGMN and the Ministry of National Defence (MDN).

## 2. On border controls

Pursuant to decision No. 1,110 of 12 April 2000 and decision No. 02000 of 30 June 2000, the National Customs Service is now involved in controlling the substances listed in the Chemical Weapons Convention, which lists a number of dual-purpose chemical substances, considering the potential risk of their becoming part of the chain of precursors for the manufacture of chemical weapons. This measure makes it possible to monitor transfers, as well as the individuals or entities that request them; accordingly, the authorization of the General Directorate of National Mobilization, in its capacity as National Authority for the Chemical Weapons Convention, is required in order for any of these substances to enter or leave the national territory.

## 3. On penalties for infringement of the legislation

For the Chilean State, the Convention is a law of the Republic, inasmuch as it has been signed, ratified and promulgated in the *Diario Oficial*. Consequently, any individual or entity that infringes article 1 of the Convention, on General Obligations, paragraph 1 of which reads as follows:

“Each State Party to this Convention undertakes never under any circumstances:

(a) To develop, produce, otherwise acquire, stockpile or retain chemical weapons, or transfer, directly or indirectly, chemical weapons to anyone;

(b) To use chemical weapons;

(c) To assist, encourage or induce, in any way, anyone to engage in any activity prohibited to a State Party under this Convention”,

Anyone who engages in such activities is liable to criminal penalties ranging from medium-term rigorous imprisonment in the medium degree to long-term rigorous imprisonment in the minimum degree (541 days to 6 years). There are no administrative penalties.

Articles 13 and 14 of Act 17,798, on Arms Control, deal with criminal aspects of the possession or ownership of arms in general. Accordingly, the amendment to this law specifically refers to the aspects covered by the Chemical Weapons Convention and will include in the supplementary regulations the penalties to be applied.
