The Permanent Mission of the Republic of Croatia to the United Nations presents its compliments to the Chair of the Security Council Committee established pursuant to resolution 1540 (2004) and has the honour to transmit herewith the following:

Annex I to the note verbale dated 3 March 2016 from the Permanent Mission of Croatia to the United Nations addressed to the Chair of the Committee

Report of the Republic of Croatia, submitted in accordance with Security Council resolution 1540 (2004) concerning the prevention of the proliferation of weapons of mass destruction and their delivery systems, February 2016

Croatia is a State party to all global treaties on non-proliferation of weapons of mass destruction and is fulfilling its obligations pertaining to the implementation of the relevant Security Council resolutions. Croatia is a member of key international and regional organizations that deal with issues of peace and security and whose programmes include the issue of non-proliferation of weapons of mass destruction: the United Nations, European Union, North Atlantic Treaty Organization (NATO), Organization for Security and Cooperation in Europe, International Atomic Energy Agency (IAEA), Organization for the Prohibition of Chemical Weapons (OPCW), Regional Cooperation Council, and the Regional Arms Control Verification and Implementation Assistance Centre (RACVIAC) — Centre for Security Cooperation. It also participates in all relevant international export control regimes: the Wassenaar Arrangement on Export Controls for Conventional Arms and Dual-Use Goods and Technologies, Nuclear Suppliers Group, Zangger Committee, Australia Group, Global Initiative to Combat Nuclear Terrorism and Proliferation Security Initiative.

In accordance with the National Strategy and Action Plan for the Non-Proliferation of Weapons of Mass Destruction (National Strategy and Action Plan), Croatia has conducted many activities since the last report for 2014.

Croatia organized and hosted an informal meeting of European Union directors in charge of disarmament, non-proliferation of weapons of mass destruction and arms control, held in Zagreb on 16 and 17 March 2015. It was the first meeting of European Union political directors held in Croatia since the country became a member of the European Union. The meeting served as a platform for an exchange of views among European Union members on the Review Conference of the Parties to the Treaty on the Non-Proliferation of Nuclear Weapons. In addition to the directors from all European Union member States, the meeting was attended by the representatives of the European External Action Service, the Director for Security Policy and Conflict Prevention, Ms. Joëlle Jenny, the main adviser and special envoy for disarmament and non-proliferation, Mr. Jacek Bylica, and the Chair of the Working Party on non-proliferation of weapons of mass destruction of the Council of the European Union, Ms. Judit Körömi.

The Director General of IAEA, Mr. Yukiya Amano, visited Zagreb on 18 and 19 May 2015. On that occasion he had a number of meetings at the ministries and institutions which technically cooperate with IAEA, where key political issues were discussed. Mr. Amano was received by the President of Croatia, Mrs. Olinda Grabar-Kitarović, the Minister of Health, Mr. Siniša Varga, the Minister of Economy, Mr. Ivan Vrdoljak, the Minister of Agriculture, Mr. Tihomir Jakovina, the Deputy Minister of Foreign and European Affairs, Mr. Joško Klisović, and the Deputy Minister of Science, Education and Sports, Mr. Roko Andričević. Mr. Amano visited

the Clinical Hospital of the Sisters of Mercy and the Ruder Bošković Institute with which IAEA has been successfully cooperating for years.

Between 20 and 22 September 2015, the Director General of OPCW, Mr. Ahmet Üzümcü, paid an official visit to Zagreb. Mr. Üzümcü held a meeting with the First Deputy Prime Minister and Minister of Foreign and European Affairs, Ms. Vesna Pusić, visited the Croatian Academy of Arts and Sciences, the Ruđer Bošković Institute and RACVIAC — Centre for Security Cooperation. At those meetings, the enhancement of cooperation between relevant institutions and OPCW was discussed. Mr. Üzümcü also attended a meeting of the National Commission for the Implementation of the Chemical Weapons Convention, at which members of the Commission gave brief presentations on current projects that contribute to the successful implementation of the Convention. Mr. Üzümcü reported on the process of destruction of the Syrian chemical weapons and the strategic plans of OPCW for the upcoming period. He stated that, so far, 192 States had acceded to the Convention and that universalization had been achieved, but that the existence of non-State actors who possessed knowledge of the development of chemical weapons was a new challenge for both member States and OPCW and it was, therefore, necessary to work on strengthening mutual cooperation. He appealed to the Republic of Croatia to join in the project of mentoring countries that needed help in the implementation of the Convention and the establishment of functioning national commissions.

A meeting of the National Commission for the Non-Proliferation of Weapons of Mass Destruction was held at the Ministry of Foreign and European Affairs on 7 December 2015, chaired by Assistant Minister of Foreign and European Affairs for multilateral affairs and global issues, Ms. Jasna Ognjanovac. The meeting was attended by the appointed representatives of relevant institutions involved in the implementation of the National Strategy and Action Plan. After the introductory address by the Assistant Minister, institutions reported on the activities within their jurisdiction based on the proposed agenda.

It was concluded that there was no immediate threat of exposure of Croatia to weapons of mass destruction, but in the context of unpredictable international events, stricter border controls and the exchange of information and strengthening of cooperation with intelligence agencies in Europe and the rest of the world were being implemented. In order to ensure the security of the Republic of Croatia, the need for closer (institutional) cooperation with the countries of South-East Europe was stressed, for which the platform was set up at RACVIAC — Centre for Security Cooperation through the establishment of the Network of Governmental Experts on combating weapons of mass destruction. It was also stressed that it was necessary to continuously train civil servants dealing with the prevention of the proliferation of weapons of mass destruction in seminars, workshops and conferences at national and international levels.

The Ministry of Foreign and European Affairs, as the competent authority for dual-use items, conducts a number of activities in order to raise awareness among private actors, industry, academia and the research community. In that regard, it organizes industry outreach events at least once a year, updates information on the export control web page, publishes handbooks and other guidance material and promotes events related to internal compliance programmes.

With the objective of promoting internal compliance programmes, in June and November 2014, the Ministry of Foreign and European Affairs held two workshops for companies that manufacture or export dual-use goods or export goods that can be used to produce such goods.

In November 2014, the Ministry of Foreign and European Affairs also organized a seminar for academia and the research community. The aim of the seminar was to inform the academic community and research institutes about all aspects of export control of dual-use items and to raise awareness of the intangible transfer of technology.

In April 2014, as part of international cooperation, the Ministry of Foreign and European Affairs hosted a visit to Zagreb by a delegation from Albania organized by the Export Control and Related Border Security Programme. The aim of the meeting was to convey experiences and practices within the scope of Croatian export control experts that could serve the Albanian delegation to take the next step in the development of their own export control system.

The Ministry of Foreign Affairs, as the competent authority for dual-use items, attaches a high degree of importance to close cooperation with other governmental bodies, especially with the Customs Administration, which has a key role in enforcing dual-use exports.

In 2015, in cooperation with the United States Department of Energy international non-proliferation export control programme, the Ministry of Foreign and European Affairs co-organized a seminar for the Customs Administration with a focus on raising awareness of export controls, identification of dual-use goods and issues related to weapons of mass destruction. The seminar was held in Zagreb from 24 to 27 August.

The Ministry of Foreign and European Affairs and the National Protection and Rescue Directorate organized a meeting of the National Commission for the Non-Proliferation of Weapons of Mass Destruction on 5 March 2015. The purpose of the meeting was to familiarize Commission members with the capacities of the National Directorate in case of a chemical, biological, radiological or nuclear incident and to consider standard operating procedures for the action of operative forces in the event of a nuclear accident, in accordance with the Regulation on Standard Operating Procedures for operative protection and rescue forces in the event of a radiological and/or nuclear emergency. The National Directorate organized a visit to an equipment store and gave a presentation on the equipment and resources for chemical, biological, radiological and nuclear protection.

Taking into account the importance of such activities, the Ministry of Foreign and European Affairs will continue its efforts to promote export control compliance among different stakeholders.

The Customs Administration of the Ministry of Finance conducts effective controls and activities on the basis of its statutory responsibilities and powers in accordance with the objectives of the National Strategy and Action Plan, using both the hard work of customs officers and all available technology to detect and prevent the proliferation of weapons of mass destruction. Pursuant to article 21 of the Law on the Control of Dual-use Goods (Official Gazette of the Republic of Croatia 80/2011 and 68/2013), the Customs Administration controls the export of dual-use goods and evaluates the conformity of the goods with the export licence, and the

transfer of dual-use goods within the customs territory of the European Union, and provides brokering services and technical assistance and transit of dual-use items. The Customs Administration also supervises the import, export and transit of military goods and non-military ordnance, pursuant to the import and export of military and non-military ordnance (Official Gazette of the Republic of Croatia 80/2013) and the Law on the Management of Chemicals contained in the Convention on the Prohibition of Development, Production, Stockpiling and Use of Chemical Weapons and Their Destruction (Official Gazette of the Republic of Croatia 127/2013).

Preventive measures, such as risk analysis systems and the education of customs officers, are an extremely important part of the control policy.

In 2015, the Customs Administration, in an effort to raise awareness and implement more effective control of non-proliferation of weapons of mass destruction, continued to build administrative capacities and hold seminars on the control of dual-use goods for customs officers involved in the procedures of customs clearance of goods at customs warehouses and border crossings, organized by their own Customs Training Centre (Zagreb and other regional centres: Split, Osijek and Rijeka, three workshops with 75 customs officers attending).

In addition to the seminars, customs officers actively participated in workshops, seminars, conferences and operations within the country or abroad at both the regional and international levels, organized within the projects of the European Union and the Government of the United States of America, or other regional or international institutions, such as the World Customs Union, Organization of the Petroleum Exporting Countries, Southeast European Law Enforcement Centre and others.

Representatives of the Customs Administration actively participated in the work of national committees, including the Commission for Issuing Export Licences for Dual-use Goods, the National Commission for the Non-Proliferation of Weapons of Mass Destruction, the Permanent Coordination Group for monitoring the implementation and coordination of the implementation of international restrictive measures, and the National Committee for the Prohibition of Chemical Weapons. All conclusions reached were carried out by the Commissions.

In addition to education, the Customs Administration has also used other implementation measures, such as risk analysis systems, by which, on the basis of various criteria built into the electronic system of risk management, high-risk shipments were selected for documentation checks or physical inspection of goods for export, import and transit. The Customs Administration used the electronic information system of the European Union for a quick exchange of information with other European Union member States and other information technology tools to achieve adequate and effective control of the export, import and transit of goods.

Operational technique is an extremely important tool used by customs officers in detecting goods, components and equipment that could be used as weapons of mass destruction (portal monitors, radioactivity detectors, mobile vehicles for detecting radiation, etc.). An important factor for efficiency and control is the interagency cooperation among national authorities which has been developed and is of exceptional quality. In addition, the Customs Administration has developed administrative cooperation and assistance in customs matters systems with neighbouring countries and other countries in the region as well.

The Ministry for Economic Affairs is the facilitator of the activities related to the Law on the Management of Chemicals Contained in the Convention on the Prohibition of the Development, Production, Stockpiling and Use of Chemical Weapons, and on Their Destruction (Official Gazette of the Republic of Croatia 127/2013) and the related ordinance (Official Gazette of the Republic of Croatia 34/2014) in accordance with articles VI and VII of the Convention.

The Ministry for Economic Affairs maintains the register of users and end users of toxic chemicals and their precursors, which includes a record of the companies, institutes and universities that carry out specific activities. The users and end users submit reports on toxic chemicals and their precursors for the previous year. Reports are processed and the annual declaration on activities in 2014 was made for the relevant chemical and manufacturing facilities. The annual declaration was forwarded to OPCW in electronic form. In accordance with article VII of the legislative and administrative measures in the implementation of the Chemical Weapons Convention, a report was sent to OPCW. Also, further to the request of OPCW and the resulting variations in the transfer of the amounts of listed chemicals that occurred when submitting the annual report to OPCW in 2013, the Ministry for Economic Affairs dealt with the resulting problems of deviations. OPCW requested the list of industrial plants in the Republic of Croatia that are subject to inspection and the Ministry for Economic Affairs submitted the requested data. In cooperation with OPCW, it was made possible for participants in the associates programme to spend three weeks gaining new experiences in two factories in Croatia in 2015. The Republic of Croatia fulfilled its obligation to pay the OPCW membership fee in 2015. The National Commission for the Implementation of the Chemical Weapons Convention nominated, at the proposal of the Ministry for Economic Affairs, Ms. Zrinka Kovarik for the scientific advisory council and the nomination was accepted. The Ministry for Economic Affairs issued permits for a one-time import of listed chemicals.

In 2015, the State Office for Radiological and Nuclear Safety carried out the following activities related to combating the proliferation of weapons of mass destruction.

It is proceeding according to European Union regulations concerning the prevention of the proliferation of weapons of mass destruction. This particularly applies to acting on Commission (Euratom) regulation No. 302/2005 of 8 February 2005 concerning the application of Euratom safeguards (OJ L 54, 28.2.2005).

Consequently, reports on nuclear material and nuclear activities in the Republic of Croatia are regularly (monthly and annually) submitted to the European Commission.

In the Republic of Croatia, an inspection has also been conducted by the inspectors of the European Commission and IAEA to determine the status of nuclear materials registered in the country. The conclusion was that some measures had been implemented and the deficiencies noted during previous inspections removed, but there were still some steps to be taken.

IAEA regularly receives reports (quarterly and annually) on nuclear material and nuclear activities in the Republic of Croatia.

The drafting of the national programme for the implementation of the strategy of disposal of radioactive waste, spent sources and spent nuclear fuel has begun, with a view to ensuring long-term disposal of the same.

Intensive activities are being undertaken for the safe disposal of radioactive waste and spent radioactive sources (that could be used for terrorist purposes). The lasting solution will include a central warehouse for the Republic of Croatia.

Activities are being carried out in accordance with the regulation on the supervision and control of trans-frontier shipments of radioactive waste and spent fuel (Official Gazette of the Republic of Croatia 11/2013).

Employees of the State Office for Radiological and Nuclear Safety participate in the work of international bodies and organizations dealing with the security of radioactive sources and nuclear materials.

In its regular activities, in particular the inspections of radioactive sources and nuclear materials in the Republic of Croatia, the State Office is in charge of keeping a high level of protection of these materials, which may be used in producing weapons of mass destruction.

In collaboration with other governmental bodies (in particular the National Protection and Rescue Directorate, the police and the Customs Administration) and through its system of permanent monitoring, the State Office is included in the rapid response system concerning possible threats of use.

In 2015, the Ministry of the Interior actively participated in the implementation of the measures and actions aimed at preventing and combating the proliferation of weapons of mass destruction.

In accordance with the 2015 Police Education Plan, a course for border police was conducted for 44 trainees, who were educated on combating terrorism and the proliferation of weapons of mass destruction.

In 2015, the legislation and the regulatory framework were regularly monitored, the legal and regulatory frameworks were harmonized with the regulations and good practices of the European Union and NATO, and the best practices were used to combat the proliferation of weapons of mass destruction.

Measures and actions were also undertaken to implement the National Strategy for Integrated Border Management and the corresponding action plan, in cooperation with the competent ministries and various agencies involved in integrated border management, the Schengen Action Plan and the Strategy for the Marine Police and its accompanying action plan, namely, the concept of protecting the land borders of the Republic of Croatia and the concept for implementation of compensation measures in the country.

In the period from 1 to 4 June 2015 in Linares, Spain, Europol and the European Explosive Ordinance Disposal Network organized a conference on chemical, biological, radiological and nuclear threats, which was also attended by representatives of the police.

From 19 to 23 October 2015, at the NBC Battalion barracks the bomb squad police officers were trained in how to proceed on encountering a chemical, biological, radiological or nuclear danger.

As concerns international activities in this regard, in addition to the abovementioned attendance of police officers at the Europol training conference in Spain, Europol workshops concerning radiological threats were conducted in Poland, Sarajevo and Belgrade.

The matrices are not a tool for measuring compliance of States in their non-proliferation obligations but for facilitating the implementation of Security Council Resolutions 1540 (2004), 1673 (2006), 1810 (2008) and 1977 (2011). They do not reflect or prejudice any ongoing discussions outside of the Committee, in the Security Council or any of its organs, of a State's compliance with its non-proliferation or any other obligations. Information on voluntary commitments is for reporting purpose only and does not constitute in any way a legal obligation arising from resolution 1540 or its successive resolutions.
