Security Council Committee established pursuant to resolution 1718 (2006)

Note verbale dated 23 February 2012 from the Permanent Mission of the Republic of Moldova to the United Nations addressed to the Chair of the Committee

The Permanent Mission of the Republic of Moldova to the United Nations presents its compliments to the Chair of the Security Council Committee established pursuant to resolution 1718 (2006) and has the honour to transmit herewith a report on measures taken by the Republic of Moldova to implement Security Council resolutions 1718 (2006) and 1874 (2009) relating to the Democratic People's Republic of Korea (see annex).

Report by the Republic of Moldova on the implementation of Security Council resolutions 1718 (2006) and 1874 (2009) adopting certain measures relating to the Democratic People's Republic of Korea

1. The Ministry of Transport and Road Infrastructure of the Republic of Moldova reports that notification regarding restrictive measures against the Democratic People's Republic of Korea related to direct or indirect supply, sale or transfer of luxury goods has been placed on the official website of the Ministry.
2. In the field of air transport, following the Ministry's instruction, the Civil Aviation Administration issued a circular letter concerning compliance with the requirement of resolutions 1718 (2006) and 1874 (2009) to prohibit air operators from using aircraft registered in the air register of the Republic of Moldova for the transportation, direct or indirect supply, sale or transfer of luxury goods to the Democratic People's Republic of Korea.
3. In the field of road transport, notification of the luxury goods embargo was placed on the official website of the National Agency for Road Transport.
4. In the field of inland waterway transport, the harbour master of the port of Giurgiulesti instructed the owners and operators of vessels operating under the flag of the Republic of Moldova to refrain from carrying out direct or indirect transport of goods stipulated in the resolutions to the Democratic People's Republic of Korea.
5. All subdivisions of the Customs Service were informed of the resolutions by a circular letter. Also, according to the procedure of risk management in Customs, selectivity criteria were created within the Automated System for Customs Data (ASYCUDA), which stipulate that all deliveries that may involve the Democratic People's Republic of Korea are subject to a detailed documentary and physical verification.
6. The Border Guard Service of the Republic of Moldova mentioned that between 2006 and 2011, no attempts to enter or transit through the Republic of Moldova by the persons mentioned in the annexes to the resolutions were registered.
7. The Ministry of Defence of the Republic of Moldova reports that the Moldovan National Army does not have any military cooperation relationship with the Democratic People's Republic of Korea. The Ministry, in the framework of its planned activities, will observe the restrictions approved by the Security Council.
8. The Security and Information Service of the Republic of Moldova reports compliance with the provisions of Security Council resolutions 1718 (2006) and 1874 (2009), in strict accordance with the legislation in force. Also, in the course of monitoring the non-proliferation of weapons of mass destruction, the Service has not registered any cases of infringement of the said resolutions by entities inside or outside the country (including any participation in nuclear tests conducted by the Democratic People's Republic of Korea). In case any information should come to its

attention, the Service will report it in order to comply with the Security Council resolutions.

9. The National Bank of Moldova forwarded the said resolutions to licensed banks in order to be implemented.
