Report of the United Arab Emirates on the implementation of Security Council resolution 2270 (2016)

The present report describes the steps taken by the United Arab Emirates to implement Security Council resolution 2270 (2016) regarding the Democratic People's Republic of Korea.

The pertinent authorities in the United Arab Emirates circulated, upon its adoption, resolution 2270 (2016) to all relevant governmental entities and associated departments in the United Arab Emirates and requested that they fully implement its measures and that they inform the authorities of any violations of the provisions of the resolution.

Pursuant to paragraphs 10, 12 and 32 to 35 of resolution 2270 (2016), the Central Bank of the United Arab Emirates issued a notice to all national banks, local branches of international banks, money exchange facilities, finance and financial investment companies operating in the country requesting that they identify and freeze all accounts, assets and investments owned by or on behalf of individuals and entities designated in resolution 2270 (2016) and previous Security Council resolutions.

The Federal Customs Authority of the United Arab Emirates circulated resolution 2270 (2016) to all local federal customs authorities, requested them to implement all sanctions imposed on the Democratic People's Republic of Korea, including those in paragraphs 29 to 31 and 37 of the resolution, and stressed that inspection of cargo destined to and originating from the Democratic People's Republic of Korea was mandatory pursuant to paragraph 18. The Federal Customs Authority also requested that the national port authorities abide by paragraphs 19, 20 and 22 of the resolution.

The General Civil Aviation Authority of the United Arab Emirates has taken all necessary measures with respect to paragraphs 19, 21 and 31 of resolution 2270 (2016).

The Federal Authority for Nuclear Regulation of the United Arab Emirates implements resolution 2270 (2016) through its regulation on the export and import control of nuclear material, nuclear-related items and nuclear-related dual-use items (FANR-REG-09) for transfer (export, import, re-export, transit and trans-shipment) of any regulated items (items controlled by the international nuclear export-import control). Article 4.4 of FANR-REG-09 prohibits the transfer of any regulated items associated with the proliferation of any weapon of mass destruction in violation of international agreements ratified by the United Arab Emirates and the relevant Security Council resolutions. The requirements of the law and of regulation FANR-REG-09 are implemented through licensing the transfers of nuclear material, nuclear-related items and the import, export or re-export of nuclear-related dual-use items, and through the authorizations of transit or trans-shipment of nuclear-related dual-use items. Implementation of the law, of regulation FANR-REG-09 and of the

obligations of the licensees are verified through inspections and enforcement by the Safeguards Department of the Federal Authority for Nuclear Regulation. The Federal Authority for Nuclear Regulation fully cooperates with the Federal Customs Authority and local customs authorities.

The Ministry of Economy of the United Arab Emirates circulated resolution [2270 \(2016\)](#) to all relevant departments for them to take all necessary measures to implement it.

Pursuant to paragraphs 6, 8, 9 and 17 of resolution [2270 \(2016\)](#), the Ministry of Defence of the United Arab Emirates reported that there were no activities related to, or cooperation with, the Democratic People's Republic of Korea.

The United Arab Emirates has been working, and will continue to work, closely with the Security Council Committee established pursuant to resolution [1718 \(2006\)](#) and the Panel of Experts on the Democratic People's Republic of Korea on the implementation of resolution [2270 \(2016\)](#).
