## Security Council Committee established pursuant to resolution [1718 \(2006\)](#)

### **Note verbale dated 21 December 2017 from the Permanent Mission of Senegal to the United Nations addressed to the Chair of the Committee**

The Permanent Mission of the Republic of Senegal to the United Nations presents its compliments to the Chair of the Security Council Committee established pursuant to resolution [1718 \(2006\)](#) and has the honour to transmit herewith the report of Senegal on the implementation of the measures contained in resolutions [2371 \(2017\)](#) and [2375 \(2017\)](#) (see annex).

**Report of Senegal on the implementation of resolutions [2371 \(2017\)](#) and [2375 \(2017\)](#)**

Concerning the measures contained in Security Council resolutions [2371 \(2017\)](#) and [2375 \(2016\)](#), the Republic of Senegal, which has ratified most international instruments on non-proliferation and disarmament, strives to fulfil the obligations contained in the relevant United Nations resolutions concerning the Democratic People's Republic of Korea, including these resolutions.

Accordingly, it should be noted from the outset that Senegal does not cooperate in the military or technical field, nor does it have agreements related to fisheries or other maritime economic activities, with the Democratic People's Republic of Korea.

As concerns the freezing of the assets of the individuals and entities targeted by resolutions [2371 \(2017\)](#) and [2375 \(2017\)](#), financial institutions have been instructed to take the necessary measures. With reference to paragraph 12 of resolution [2371 \(2017\)](#) and paragraph 18 of resolution [2375 \(2017\)](#), in which the Council decides that States shall prohibit, by their nationals or in their territories, the opening of new joint ventures or cooperative entities with entities or individuals of the Democratic People's Republic of Korea, or the expansion of existing joint ventures through additional investments, whether or not acting for or on behalf of the Government of the Democratic People's Republic of Korea, unless such joint ventures or cooperative entities have been approved by the Committee in advance on a case-by-case basis, it should be noted that the competent Senegalese authorities have taken measures against the North Korean company Mansudae Overseas Project Architectural Group, which is on the sanctions list.

The company was registered as a legal entity under number SN-DKAR-B6903 on 23 April 2008 and operates primarily in the construction sector. The Government of Senegal has systematically refused to issue entry and short-stay visas to or renew previous visas for the company's North Korean workers. Owing to these measures, the company cannot continue to carry out its activities.
