# Security Council Committee established pursuant to resolution 1718 (2006)

### Note verbale dated 28 October 2020 from the Permanent Mission of Colombia to the United Nations addressed to the Chair of the Committee

The Permanent Mission of the Republic of Colombia to the United Nations presents its compliments to the Security Council Committee established pursuant to resolution 1718 (2006) and, with reference to Security Council resolution 2397 (2017), adopted on 22 December 2017, has the honour to transmit herewith the final report of Colombia pursuant to paragraph 8 of that resolution (see annex).

The Mission takes this opportunity to reiterate the importance that Colombia attaches to the implementation of Security Council resolutions, in line with its unwavering commitment to disarmament and the non-proliferation of weapons of mass destruction, and to international peace and security.

# Report of Colombia on the implementation of Security Council resolution 2397 (2017)

#### Background

In paragraph 8 of its resolution 2397 (2017), adopted on 22 December 2017, concerning the application of sanctions against the Democratic People's Republic of Korea, the Security Council states:

(...) that all Member States shall provide a midterm report by 15 months from the date of adoption of this resolution of all DPRK nationals earning income in that Member State's jurisdiction that were repatriated over the 12 month period starting from the date of adoption of this resolution, including an explanation of why less than half of such DPRK nationals were repatriated by the end of that 12 month period if applicable, and all Member States shall provide final reports by 27 months from the date of adoption of this resolution.

## Information on nationals of the Democratic People's Republic of Korea in Colombia

The information presented below was provided on 15 October 2020 by the Migration Control Subdirectorate of the Special Administrative Unit of Migración Colombia, the national migration authority.

## Number of nationals of the Democratic People's Republic of Korea currently in Colombia

No registered nationals of the Democratic People's Republic of Korea are currently in Colombia. The entry and exit data for those nationals show that, from 2012 to date, those who entered Colombia legally through authorized checkpoints have left the country.
